Who Should Sign-up!

Boy Scout Participant Qualifications:

- Must have a current BSA membership with a Boy Scout troop.
- Must be at least at least First Class Scout by the first day of the jamboree.
- Must be at least 12 years of age by the first day of the jamboree or an 11 year old that has graduated the 6th grade, but has not reached their 18th birthday by the last day of the jamboree.
- Webelos Scouts who meet the age minimum above are encouraged to sign up.
- Be approved by the unit leader and Marin Council.
- Must understand and sign the Code of Conduct agreement.
- Must meet the physical fitness requirements.
- Must participate in Marin Council's pre-jamboree training experience.
- Must have filed a Jamboree Personal Health and Medical record with the council jamboree committee before the pre-jamboree training.
- Submit all registration fees per the Marin Council payment schedule.

Venturing Participant Qualifications:

- Must have a current BSA membership with a Venturing Crew.
- Must have graduated the 8th grade or be at least 14 years of age by the first day of the jamboree, but have not reached their 21st birthday by the last day of the jamboree.
- Be approved by the unit leader and Marin Council.
- Must understand and sign the Code of Conduct agreement.
- Must meet the physical fitness requirements.
- Must participate in Marin Council's pre-jamboree training experience.
- Must have filed a Jamboree Personal Health and Medical record with the council jamboree committee before the pre-jamboree training.
- Submit all registration fees per the Marin Council payment schedule.
