# MyRecord Enrollment Form

**What is MyRecord™?**

MyRecord™ is a credit card sized CD containing an electronic copy of your pertinent cardiology medical information. The purpose of MyRecord™ is to enable you to have control and possession over your medical information so that a health care provider, unfamiliar with your medical history, would have the necessary information to provide the accurate emergency treatment to you. MyRecord™ also contains educational content for you, specific to your condition and medication history.

**Where Can MyRecord™ be obtained?**

MyRecord™ is available at Northeast Ohio Cardiovascular Specialists (NEOCS).

**How can I get a copy of MyRecord?**

Simply fill out the form below. You may leave it or send this application form to Northeast Ohio Cardiovascular Specialists. Allow 4-6 weeks for shipment of your CD.

**How is MyRecord™ Made?**

The information contained on My Record™ comes directly from Northeast Ohio Cardiovascular Specialists' medical record system. Northeast Ohio Cardiovascular Specialists has contracted with GEMMS to provide this service for you.

**Are hospitals in all countries equipped to read MyRecord™?**

MyRecord™ is a standard CD-ROM. Most medical facilities around the world have basic computers with CD-ROM readers, and can access the information on a MyRecord™ quickly. It takes no additional hardware, software, or knowledge to use, as it starts by itself, once loaded into the CD-ROM reader.

**If an individual was unconscious, how would the administering health care provider find the individual's MyRecord™?**

All medical practitioners, and especially personnel trained in emergency situations, are trained to first look for an individual's identification. That is why we recommend that individuals carry their MyRecord™ in their wallet or purse.

**Is MyRecord™ going to be used primarily in emergency rooms or when I am sent to another health care provider's office?**

Both. There's nothing more important than instant and accurate medical information in the case of an emergency, as well as when you are seen by another healthcare provider.
