1	<ol> <li>I understand that Section 4 ASSIGNMENT, of the Lease Agreement states, "Occupant shall not assign this Lease Agreement or assign the Premises, or any part thereof, without the Landlord's prior consent. Occupant shall pay Landlord a non- refundable processing fee of \$200.00 for each application to Landlord for Landlord's consent to an assignment."</li> </ol>									

- 2. I understand I must submit a one-time, non-refundable fee of \$200.00 to be charged to my account to release my unit. University Student Housing will place my name on the "USH Early Lease Termination," if such a list is being utilized at this time.
- 3. I understand it is my responsibility to find a new occupant to assume the remaining portion of my Lease Agreement. While University Student Housing, LLC attempts to aid me in this process, the landlord or designated agent assumes no responsibility in filling any vacancy resulting from the release process.
- I understand I am responsible for all rental and appropriate fee payments until such time as a new Lease Agreement has been signed for my bed space. I understand that my account balance must also reflect no outstanding debt or payments in process.
- 5. I understand that I must remove all my belongings at least three (3) business days prior to the scheduled move-in date of the person re-leasing my unit.
- 6. I understand that none of the required procedures outlined in this document or my Lease Agreement may be waived as a result of any of the circumstances of my early termination. I understand University Student Housing, LLC, as landlord, reserves the right to review these procedures at any time and amend them as deemed appropriate.
- 7. I understand that no release is complete until the new resident has paid all fees, submitted all paperwork, and taken occupancy of the unit. If, at any time, the new resident fails to complete any portion of the release process, the release is considered void. I will remain responsible for the unit until such time as the release process is successfully completed and a

new resident is living in the unit.									
I have read and understand the guidelines above. I will adhere to these regulations and understand that failure to comply these rules may jeopardize my ability to complete an early termination of my Lease Agreement in a timely manner, or at a may result in additional fees during the release process.
