## Policies For Family Camp Use

The Michigan Crossroads Council's Harold and Gladys Elliott Family Camp is located within D-bar-A Scout Ranch. This campground is dedicated to family RV, camper, and tent camping. All sites have access to the central shower house, and a playground for the youngsters. All sites have a fire ring and a picnic table.

The central shower house includes showers and restrooms, a laundry room with washer and dryer and a community room for gatherings.

Guests of Elliott Family Camp may visit the main scout camp program areas when they are not in use. D-bar-A also has a trading post located in the Martin Building. D-bar-A offers the following, when available, horseback riding, hay rides, and nature programs. Guest may always take part in the miles of hiking trails or fish in one of the three beautiful lakes in camp.

- There is a zero-tolerance policy regarding usage of the following. This includes the renter of record, family members or guests. There shall be no alcohol use, gambling, illegal drugs, fireworks, firearms or Bow and Arrow while at camp.
- 10-MPH Speed Limit it is your responsibility to observe the speed limit and to inform any visitors you may have.
- Visitors All renters and guests must sign in and out at the Martin Building or at the Rangers shop.
- Dogs / Pets are allowed but must be on a leash. You must pick up and dispose of your pet waste (NO EXCEPTIONS). Dogs are allowed only in the Elliott Family camp. They are not allowed in any other part of camp. If there is excessive howling, or barking by your pet, you may be asked to leave. Do not leave your pet tied up and unattended.
- D-bar-A embraces the principles of Leave No Trace; No Cutting of live trees (firewood is available {for a fee} at the Martin building or see the camp rangers). Fires shall be in approved / existing fire rings only (no unattended fires).
- Quiet Time (11pm to 7am)
- The community room may be used as a gathering spot, but kitchen facilities are not available. All food preparation, cooking and dish washing shall be done in your trailer. The room must be cleaned thoroughly before you leave the room.
- The laundry facility is for use only for clothing that is used while at camp. Laundry from home should be done at home.
- No off-road vehicles are allowed in camp.
- No outside storage when not at camp
- The awning on your trailer must be retracted and all items are to be stored inside your trailer storage compartments or in the trailer itself when you are not in camp
- All keys for access to the restrooms and showers will be issued by camp management. Duplicating keys is inappropriate.
- A Hold-Harmless Agreement must be signed with the Michigan Crossroads Council, for those that are not registered as Scouts.
