## STATE OF NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION GREEN ACRES RESOLUTION AUTHORIZING AMENDMENT TO PROJECT AGREEMENT

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres ("State"), provides loans and/or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Borough of Ringwood has previously obtained a grant of \$2,250,000 from the State to fund the following project (s): Open Space Acquisition; and

WHEREAS, the State and the Borough intends to increase Green Acres funding; and

WHEREAS, the applicant is willing to use the State's funds in accordance with its rules, regulations and applicable statutes, and is willing to enter into an Amendment of the Agreement with the State for the above-names projects.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the Borough of Ringwood

- That the Scott Heck or the successor to the office of the Borough Manager is hereby authorized to execute an Amendment to the Agreement increasing funding to \$2,700,000; and
- 2. That the applicant has its matching share of the project, if a match is required, in the amount of \$2,700,000; and
- 3. That, in the event the State's funds are less than the total project cost specified above, the applicant has the balance of funding necessary to complete the project; and
- 4. The applicant agrees to comply with all applicable federal, state and local laws, rules and regulations in its performance of the project.
- 5. That this resolution shall take effect immediately.
