## TERMS AND CONDITIONS OF REQUEST FOR BALANCE CONFIRMATION CERTIFICATE

BY SUBMITTING THIS REQUEST ("Request") for a balance confirmation certificate ("Statement") to DBS Bank Ltd. ("Bank"), which term shall include successors and assigns, you ("Customer"), agree to be bound to the following terms and conditions:
