Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate Stanislaus County's proposed Las Palmas Avenue and Elm Avenue intersection improvement project, the county has requested PG&E to relocate one pole at the southwest corner of the intersection approximately 174 feet to the south east and interset a new pole between that pole and the pole on the northwest corner of the intersection (minor relocation, intersetting structure) along the Manteca #1 60 kilovolt (kV) Power Line located in the City of Patterson (existing public utility easement). The existing wood pole is approximately 55 feet tall and the two new light-duty steel poles, which will weather to resemble the wood poles, will be approximately 10 feet taller (65 feet) to comply with California Public Utilities Commission ("CPUC") General Order 95 minimum ground-to-conductor clearance requirements. Construction is scheduled to begin in May 2011 or as soon thereafter as possible, with completion in June 2011 or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- “The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersecting of additional support structures between existing support structures.”
- “Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **April 18, 2011**, which is 21 days after the date of this filing.* Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: MANTECA #1 60 KV POWER LINE RELOCATION PROJECT (CITY OF PATTERSON AND COUNTY OF STANISLAUS)

ADVICE LETTER NUMBER: 3817-E

Proposed Project: In order to accommodate Stanislaus County's proposed Las Palmas Avenue and Elm Avenue intersection improvement project, the county has requested Pacific Gas and Electric Company (PG&E) to relocate one pole at the southwest corner of the intersection approximately 174 feet to the south east and interset a new pole between that pole and the pole on the northwest corner of the intersection (minor relocation, intersetting structure) along the Manteca #1 60 kilovolt (kV) Power Line located in the City of Patterson (existing public utility easement). The existing wood pole is approximately 55 feet tall and the two new light-duty steel poles, which will weather to resemble the wood poles, will be approximately 10 feet taller (65 feet) to comply with California Public Utilities Commission (CPUC) General Order 95 minimum ground-to-conductor clearance requirements. Construction is scheduled to begin in May 2011 or as soon thereafter as possible, with completion in June 2011 or as soon as possible after construction begins.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III.B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
