## TRACI GOBLE, MAYOR

Traci Goble, the Mayor of Georgetown, Minnesota recently had to take drastic steps to save her town. Georgetown is about 15 miles north of Moorhead and the flood waters were heading towards town from the Red River Valley.

The Army Corps of Engineers told the city it had to increase its permanent levee against the Buffalo River. But some property owners in town were refusing to let the city use the clay from their own property. So the Mayor was forced to make the decision to use the old baseball field in town instead. She called it the "Hole of Hope" as the soil was used to quickly raise the existing levees. Although the people have temporarily traded the baseball field for the safety of the town, the field will return after the flood waters recede.

## GOBLE PIONEER



**Alice Leona Goble Dodson  
early pioneer Oregon  
Territory** – by Carol Porter

*Alice Goble Dodson's story appeared in the Union-Bulletin Walla Walla, Wa. February 1950. A similar story was printed eleven years earlier on her 79th birthday. It is nice to note that the facts remain the same so facts and memory are consistent. The following is a combination of the two stories, often with the journalistic wording of the two interviewers. (1938-1950)*

**Alice Goble Dodson tells events of the long trek across the plains.** The "still spry" woman first came to this territory when she was just under five years old, leaving Marshall County, Ks in the early spring of 1864. Mrs. Dodson covered the immigrant trails in a covered wagon drawn by milk cows.

They started out as a family unit that joined up with other groups to form a train of a 100 wagons before striking out across the dangerous plains for the Oregon country. "We couldn't leave Kansas unless there were 100 wagons of us together," stated Mrs. Dodson. "People said it wasn't safe to have a smaller wagon train because of the Indians. The wagons stretched out in a long line, single file.

The immediate family consisted of Mr. & Mrs. Abiel Goble, Sarah Edyth (Tate), Anne (Hadley), Alice (Dodson) & Amanda (Hadley), of whom Mrs. Dodson was one of the youngest. Others in the party were Mr. and Mrs. Luther Pearsall, parents of Mrs. Laura Pearsall Goble, who rode in a covered buggy drawn by a mare the full distance. That animal, by the way, lived to be 25 years old, and contributed much to the family's subsequent comfort in frequent travels in the Northwest.

Another member of the original group was the 80-year-old mother of Abiel Goble, Sarah Lyons Goble who, ailing from the start, attempted the trip because she refused to be left behind. She held up wonderfully well, but when

the train reached Burnt River in Baker County, she joined that innumerable host which met death along the Oregon Trail. She was buried where she died --- reverently, in primitive fashion.<sup>1</sup>

The captain was elected by the pioneers and guided the group in the lead wagon. The captain sanctioned whatever action the travelers were to take. At night the wagons formed a circle each maintaining a certain position.

All along the way the wagon train just escaped Indian trouble. One evening in the badlands the group happened upon the remnants of a massacred immigrant camp. All were dead except one man. He had been scalped but was treated and recovered.

Another story, quite unpleasant, was remembered by our pioneer. Apparently it had been agreed that white men would not harm Indian women. A group of Indian women took advantage of that agreement and stole some stock. The men took after them and a woman was shot. The Indians were very upset and would have massacred the wagon train, but the young man, a cousin, who had shot the woman, offered himself up to save the others. The Indians took him and flayed him. When the Goble wagon train arrived on the scene, they found the young man dying. His last words were "Oh, my God."

The train reached Meacham in the fall. Alice's father, Abiel Goble went to Walla Walla alone to find a homestead. Homes were scarce. With the promise that Mrs. Laura Goble would board the home owner and his partner Moffett, the gambler named Babcock agreed to let the Gobles rent his house. Laura cooked for them for the winter and Abiel took care of the stock when in the Meacham area. Mrs. Dodson recalled Babcock a "strict, upright man". She recollected that the city was then no more than a couple of saloons, a gambling house and a hotel. The pioneer said the gambler's house was located right on the outskirts of the town by a stream.

The next spring the Gobles left for the Umpqua Valley in southern Oregon where they stayed three years. The family shuttled back and forth from the Umpqua Valley and Walla Walla several times. In 1877 they moved to Asotin creek.

On January 16, 1881 Alice Goble married John Dodson of Asotin area. The Dodson's set up housekeeping in the region of Asotin Creek. Their six children were born there. From there the Dodson's moved to Touchet

To help Mrs. Dodson celebrate her 90 years of pioneering 40 plus friends and relatives flocked to the home of her son Henry Dodson in Walla Walla for an open house. With the majority of her 14 great grand children, 16 grandchildren and 6 children around her she claims to be working towards her 100th birthday. Mrs. Dodson moved to her son's home in the city just 4 years ago. Prior to that time the pioneer had a homestead in Touchet, WA for 35 years. Mr. John Dodson, husband of Alice Goble Dodson died in 1936 after 56 years of married life.

## RICHARD F. PALMER

**Richard F. Palmer** has taken an avid interest in the maritime history of Oswego and Lake Ontario for many years. He has written more than 30 articles on a wide variety of topics in this field for "Inland Seas," quarterly publication of the Great Lakes Historical Society, of which he is a Senior Editor. He has spent much time in libraries and historical societies in communities along Lake Ontario as well as at the National Archives and Library of Congress in Washington, D.C. He also is a member of an Internet network of Great Lakes maritime historians.

A native of Canandaigua, N.Y. he spent the first years of his youth in Palmyra, and later lived on a farm near Fulton. He attended Phoenix Central School, graduated from Nottingham High School in Syracuse and attended Onondaga and then-Auburn Community College. For 28 years he was a reporter for the Syracuse Herald-Journal and subsequently the Cortland Standard and Eagle Newspapers. For a time he was editor of the Camillus Advocate, Baldwinsville Messenger and North Syracuse Star-News. He has a total of 45 years experience as a journalist. For nearly 30 years he was also public affairs specialist for the 174th Fighter Wing, New York Air National Guard, stationed at Hancock Field in Syracuse.

Mr. Palmer also has an avid interest in railroad history. He has authored and co-authored several books on local railroads in upstate New York. His primary hobby is model railroading. He is also a member of the Central New York Chapter, National Railway Historical Society. As such, he is the group's archivist and librarian, and program chairman. He and his wife, Jean, reside in Syracuse.

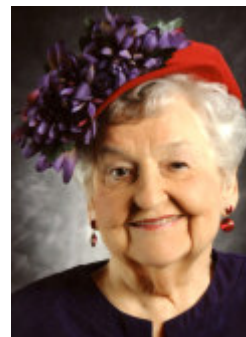
In addition to her parents, she was preceded in death by a brother, Charlie Ray Payne, Jr., and a sister, Carolyn Wolfe.
