Note 1: At an NSCRO Playoff match, each player shall present a school photo ID as final verification. Refer to NSCRO "Regulations for Playoff Matches" for full details.
 At Conference/Union league and playoff matches, the club and players are subject to Conference/Union Game Day Eligibility Verification Procedure.

Note 2: If player is past 5 years from date first enrolled in college, refer to Regulation No. 2 for additional documentations required.

Note 3: For Policy compliant players based on an "Exception", additional documentation must be provided by the institution to verify the following:
 Regulation No. 3a: If a part-time undergraduate student, compliance with NSCRO Regulation 3, Exception a.
 Regulation No. 3b: If a full-time post-graduate student, compliance with NSCRO Regulation 3, Exception b.
 Regulation No. 3c: If student has graduated, compliance with NSCRO Regulation 3, Exception c.
 Regulation No. 4a: If the student is not enrolled in this institution, compliance with NSCRO Regulation 4, Exception a.

Note 4: If student-athlete who does not comply with the current Player Eligibility Policy has been granted a waiver by NSCRO, the associated written document from NSCRO must be provided with this form.
