## VERIFICATION OF 2014 STUDENT/SPOUSE INCOME INFORMATION

If an individual has been granted a filing extension by the IRS, provide the following documents: A copy of the IRS Form 4868 "Application for automatic Extension of Time to file US Individual Tax Return" and copy of IRS Form W-2 for each source of employment received for tax year 2014 and if self-employed, a signed statement certifying the amount of the individuals AGI and US Income tax paid for tax year 2014.
