Zayed University is a new institution established in 1998.

The university is named after the revered founder of this relatively new nation, Sheik Zayed bin Sultan Al Nahyan, and has campuses, one in both Dubai and the other in Abu Dhabi. The cities are approximately 90 miles apart.

All this has happened fairly quickly. I was approached in June and after two "airport" meetings in Detroit, several long telephone calls and a week-long trip to the UAE, we accepted their invitation. Elaine and I will be moving to Dubai in October.

Although we will be in Dubai, we are keeping our home in Toledo and plan to return following my tenure at ZU. Frankly, we were “dazzled” by the two cities, the quality of the faculty and staff, the new university campus in Dubai, and the plans for a new campus in Abu Dhabi on which they are breaking ground shortly after we arrive. The government wants ZU to “become the premier university and prepare leaders for the United Arab Emirates.”

As is the case with all universities, there are major challenges but they are far overshadowed by the great opportunities to establish and grow American-style academic programs at both the undergraduate and graduate levels.

The position is Provost, Chief Operating Officer and Chief Academic Officer.

I first learned about SNA from a presentation Valdis made at a workshop on complexity. (In fact there's another, small-world network connection, since my daughter Olivia met Valdis

when he spoke to her class in the UCLA school of public health.) We subsequently hired Valdis to work with us on our first SNA project, a study of the Maumee Valley Growers, and we purchased his software, Inflow. As a part of that contract, he began to train us in SNA. Later, Neil and I and Bruce Smith from BGSU attended the annual conference of the International Network of Social Network Analysts (INSNA), where I did a one-day course on Ucinet, probably the most popular SNA program for academics (includes more statistical tools, etc). That program is the work of Steve Borgatti, who is at the LINKS center (<http://www.linkscenter.org/>) at the University of Kentucky. Last summer I did a one-week course there.

In the future, we hope to market SNA as one of our services. As I mentioned, I continue to read and learn about SNA. Neil and some colleagues continue to submit and present on the topic at academic conferences. We are happy to work with the commissioners on the project we discussed as a way of gaining experience, while helping you to better understand and perhaps strategically strengthen the network studied.

Jobs or Windows?

Fiscal Priorities. We all set them. Whether it's a family deciding to spend money on their daughter's college education instead of a buying a new car, or a small businessman opting to invest his profits into growing his business instead of taking a trip to Florida, setting spending priorities is a reality of life for all of us. It's no different for county government. With shrinking revenues and ever greater service needs, county government has to set priorities in these challenging economic times.

That's why I was so vocal in opposing a taxpayer funded \$450,000 purchase of new windows for a county building. Instead, I proposed to use about half of that money to fund two job creation programs that would have created about 40 jobs at area non-profits and high tech start ups. A small portion of the money, under my plan, would have gone to help uninsured and underinsured citizens in Lucas County get, on average, a 20% discount on prescription drug costs through joining a purchasing plan sponsored by the National Association of Counties. And the rest of the window money, \$200,000, would have gone into the county's rainy day fund, a conservative investment in case our fiscal situation gets worse. It's just like a family tucking some money into the piggy bank in case of unforeseen challenges. Nobody like to do it, but it's the prudent thing to do.

Unfortunately, my colleagues on the Board of Commissioners voted 2-1 against my proposal. So you, the taxpayer, is the lucky recipient of \$450,000 windows for an aging, non descript county building. Sadly, dozens of Lucas County residents will miss out on getting back on their feet and into the workforce due to this decision. And non-profits, many of which are affiliated with the United Way, will be hurt because they are short staffed and could have used the help the jobs would create to offer services to the neediest among us. Small business in areas like alternative

energy will be hurt because we didn't devote the resources to giving them the manpower to grow and create more jobs. And the tens of thousands of Lucas County residents who are uninsured or underinsured lose out as well, because we didn't invest in a program that could have saved them hundreds of dollars on out of control prescription drug costs.

Ten years ago, I probably would have voted with my colleagues and supported the \$450,000 windows. Back then, our economy was creating jobs at a decent pace, we had a national budget surplus instead of a huge deficit, and we weren't fighting two wars that cost us 10 billion dollars a month. In short, we could address less pressing needs in the community like windows on a county building, because less people in our community were hurting.

In 2008, we face a starkly different reality. Our unemployment rate is rising and is likely to get worse. Foreclosures are decimating families and neighborhoods. And healthcare costs continue to skyrocket out of control while incomes shrink. That's why I could not support the windows this time around.

Congress and the Bush administration bailed out their cronies on Wall Street to the tune of 700 billion taxpayer dollars. In my opinion this was unwise and unfair to places like Toledo, where job killing trade deals and globalization have undermined our manufacturing base. While we don't have the power or resources to totally overcome the unfair hand we have been dealt, we do have some control over our destiny. And that's what my jobs plan was really about. The fat cats in Washington have ignored us for too long, and our local economy is paying the price. Sometimes it seems like people making decisions in D.C. have no real understanding of what we are going through here in Lucas County. By investing what we could in the people of our community through a jobs program and healthcare relief, instead of buying windows, I was hoping to help bail out Main Street for once.

Emergency \$250,000 Investment Proposed to Aid Workers Effected by Jeep Layoffs

Allocation of County funds could help hundreds displaced due to ripple effect of Chrysler cuts

(Toledo, OH)- Seeking to address the growing unemployment problem in Lucas County, worsened by the ripple effect of the Jeep layoffs, Commissioner Konop will today propose an emergency measure devoting *at least* \$250,000 to On the Job Training programs (OJT's) for displaced workers. Konop's proposal will help some of the thousands of workers who will be downsized in the wake of the Jeep layoffs get retrained and placed in other jobs.

"Those who are losing their jobs as a result of the Jeep layoffs are getting laid off through no fault of their own," stated Konop. "We have the hardest working, best trained workforce in the land, but because of forces beyond their control, thousands in our community will lose their jobs in the next several months. We have a duty in county government to do all we can to get these and other hard working citizens back on their feet," stated Konop

Konop's emergency resolution would allocate \$250,000 from a \$450,000 window replacement project to the OJT fund. OJT contracts can be developed between an employer and Lucas County to provide occupational skill training for the dislocated worker in exchange for a reimbursement of up to fifty percent of the wage rate. Currently the OJT fund, which operates on a July to July fiscal year, is projected to run out of cash in two months.

"We urgently need to get people to work in our community, and the funds to do so from state and federal sources are diminishing rapidly because of the growing need," stated Konop. "We must have priorities in county government, and right now jobs for the workers displaced by the Jeep layoffs and other downsizings must come before non-essential new windows for a county building," concluded Konop.

Konop's resolution will be voted on at Tuesday's Commissioner's hearing.

Yes there is a chance for false positives but only if monitor is cleaned with rubbing alcohol or if the monitor is placed near hand sanitizers. The amount of alcohol in these two cases is very concentrated and the vapors emitted from these would affect the monitor's internal sensor.

Yes there is a chance for false positives but only if monitor is cleaned with rubbing alcohol or if the monitor is placed near hand sanitizers. The amount of alcohol in these two cases is very concentrated and the vapors emitted from these would affect the monitor's internal sensor.

I have also attached 2 articles discussing the monitors and smokers.

Corridor changes name, expands economic mission

The UT Science and Technology Corridor is changing its name — becoming Science, Technology and Innovation (STI) Enterprises — and expanding the reach of its economic development efforts, according to University officials.

“The corridor created a strong economic development foundation for UT and for the region,” said Mary Jo Waldock, special assistant to UT President Lloyd Jacobs for economic development.

“STI Enterprises will fold in University research, technology transfer and patent efforts, work-force development, and small and spin-off business incubation,” she said. “UT contributes so much to the regional economy already, and this reorganization will make future and current partnerships that much more focused.”

Dr. Frank Calzonetti, vice president for research development, highlighted the added focus on innovation.

“The National Science Foundation recently conducted a review that showed UT is among the top 10 universities in the nation when it comes to licensing ideas or products for commercialization and launching startup businesses per dollar of research,” Calzonetti said. “Our faculty are and will continue to play a fundamental

role as northwest Ohio becomes a knowledge-based economy.”

The concept of the corridor was developed during the tenure of Dr. Dan Johnson’s UT presidency; Jacobs said STI Enterprises would further build on Johnson’s vision.

“The overarching vision initially set by Dan will not change,” Jacobs said. “STI Enterprises will have as its mission the prosperity of this community, with recognition that an entrepreneurial arm of an engaged university is an important tool for implementation.”

Is this a nightmare, or are my two colleagues on the County Commission about to raise taxes on home sales in the worst economy since the Great Depression. I hope this is a just dream--and a very bad one at that for working families in Lucas County--but after sitting through two hearings on the issue, I'm pretty sure this is reality.

Led by Commissioner Gerken, a proposal is on the table to raise the conveyance tax for all Lucas County residents. This is a tax that we all must pay when selling our home or business. If this tax hike passes, the average home seller in Lucas County will have to write an extra check for \$120 at the time of sale in addition to any other closing costs. Yes, that's a substantial tax hike in this economy. You can see how I could mistake this for a bad dream.

I imagine you are reading this and thinking, I don't have an extra \$120 laying around when I sell my home, especially since it's likely that my home has lost significant value over the last couple years. If you are a parent, I'm sure you could think of a number of ways to spend that \$120, like paying for groceries or clothes for the kids. And my bet is if you are senior, living on a fixed income, you probably could spend that money on prescription drugs or health insurance. But alas, under this nightmare scenario, your tax dollars (around \$1,000,000 per year!) will go directly to the LCIC.

Remember the LCIC? It's the "economic development" agency whose director resigned two hours before he was fired for funneling a no bid contract to a political crony of Commissioner Gerken. It's the economic development agency with no accountability standards, and little results in terms of jobs--as our rising local unemployment numbers continue to well document. And it's the organization that still has a board of 20 politicians in control. See how I could believe this is all a bad dream for Lucas County?

Listen, we all want jobs and economic development. We all want to see the public sector play a role in turning our economy around. But before we raise taxes on working families and seniors

trying to sell their homes or businesses in the worst economy since the Depression, let's take a step back. Wouldn't it make a tad more sense to see some results out of the LCIC first and maybe wait a while for the economy to improve before we consider writing them a blank check for a million dollars of taxpayer money?

I doubt there is an economist on either side of the aisle who could support this on intellectual grounds in our current economic state. And I doubt there are many regular folks out there who could support this based on plain common sense.

However, there are some big wigs out there who support this and don't mind throwing your money around in their boardrooms and backrooms. In fact, this "good 'ole boys network" may well write an article blasting me in response to speaking out about what I believe and standing up for the Average Joe. But I won't back down on this one. I'm sick and tired of reliving these bad dreams in Government Center, while our community continues to lose jobs, investment, and population. Enough is enough...let's wake up Toledo!

Final lease rates are determined by the type of space needed and the infrastructure investment needed. Based upon the opportunity, we lease typically for 2-3 years, but in certain situations are willing to consider shorter leases.

Don't lose control of conveyance fee

The recommendation of former University of Toledo President Dan Johnson to earmark approximately \$800,000 annually of public money for the Lucas County Improvement Corporation seems an odd response to an organization that many people, including Lucas County Commissioner Ben Konop, regard as performing poorly. Not surprisingly, the proposal is popular among most members of the LCIC board.

A \$1 increase in the county's conveyance fee, currently at \$3 for each \$1,000 of property sold, would produce the estimated \$800,000, according to proponents of the proposal.

Under the proposal, the county commissioners would have no role in allocating this \$800,000 at budget time each year. The money would automatically go to LCIC regardless of its performance. Even if commissioners thought other agencies with exemplary records of

performance could provide services more needed by the residents of the county, LCIC would get the money.

This proposal is not good governmental policy. We elect county commissioners to make important budget decisions. This way, the voters can hold the commissioners accountable when things go badly. But how can we hold the commissioners or anybody accountable, when a private, nonprofit organization automatically gets \$800,000 of the public's money and spends it poorly?

If commissioners intend to increase the conveyance fee, they also should maintain control over it.

Ben,

Sorry that it has taken me so long to get this information to you. Attached are two documents that outline the two scholarships (Blue-Gold, and Ohio Can! Go to College) that the University of Toledo is supporting.

The Blue Gold (or Toledo Guarantee) scholarship was recently expanded to include the 21 largest school districts in Ohio. For Lucas county this includes Toledo Public and Washington local. Each high school senior in those school districts who have a 3.0 GPA or higher and qualify for a Pell grant will be able to attend the University of Toledo Tuition free.

You had asked me about the qualifications of Pell grants and this is how it was explained to me. Each student's circumstance is different and

the decision to grant a Pell grant is based on each individual circumstance and the overall need. For example: a family that has a house hold income of \$60,000 and has five high school level kids may qualify for a Pell grant because the financial need for education is high. However, a family who has a household income of \$30,000 but runs a business that is worth \$250,000 probably would not qualify. So each circumstance is different and the qualifiers vary. The University does not get involved in who qualifies or not. In order to qualify for a Blue Gold scholarship you must first show approval of a Pell grant. A Pell grant is required. The average Pell grant is around \$3,000 to \$4,000 annually.

Now, let's say that a Freshman enters UT in Fall of 2009 and is on a Blue Gold scholarship. In order to maintain that scholarship all four years they must maintain a 3.0 gpa and must continue to apply annually for a Pell grant. If this students family situation improves and no longer qualifies for a Pell grant, then the University will still honor its commitment to that student by continuing the scholarship until they graduate.

The University of Toledo has a vested interest in graduating more students, particularly those who live in Ohio. That is why we are investing so much into the Blue Gold and Ohio Can! Go to College scholarships. The Blue Gold scholarship will begin with its first students under this scholarship in Fall 2009. The First Ohio Can! Go to College scholarships will be made available in Fall 2010. The University Admissions Dept. is forecasting 338 entering freshman will come into UT next fall under the new Blue Gold Scholarship. The average cost per student that the University expects to honor in scholarships is \$4,000 per student. Next fall the University is anticipating committing over \$1,300,000 in new Scholarships under this Blue Gold program. The cost of tuition for one year at UT is currently at around \$8,000.

As you and I spoke we both agree that Ohio's economy is directly related to the education of its residents. With 80% of new job growth requiring some sort of advanced education degree these two scholarship programs are designed to turn things around in Ohio and will give the best and brightest students a reason to remain in Ohio and be a part of the economic turnaround.

I would like the opportunity to speak to you further about this on how the county could support these programs, and particularly the Ohio Can! Go to College scholarships in an effort to expand scholarships to all Lucas Co. residents.

My proposal to provide a living wage to every worker whose employer receives a contract, loan, or tax incentive from Lucas County has gotten a lot of people talking this week. And, unfortunately, there has been some fear mongering about my proposal, especially from my critics on the far right wing of the local Republican Party establishment.

So, let's talk first about what this proposal won't do: this resolution won't affect those who chose not to do business with Lucas County; it won't apply to small, family businesses; and, it won't apply to seasonal employees, temporary employees, or interns.

What my living wage proposal will do, however, is ensure that those larger companies who come to the taxpayers for a contract or tax break pay their workers a reasonable wage -- about \$8.50/hour-- or a little over one dollar more than the current federal minimum wage. It's not an outrageous demand. In fact, I wish today's economic climate allowed us to set the wage at an even higher rate. However, in the midst of the deep Bush recession, I felt the \$8.50/hour was a prudent baseline to help lift people out of poverty.

My proposal will also mandate that an employer offer health insurance coverage to its workers at no more than 15% of the workers monthly wage. That's the right thing to do from a moral and fiscal perspective.

The economics of the living wage proposal are simple. If Lucas County awards a contract and the employer pays poverty-level wages without health care, that worker will simply turn to other public assistance, like food stamps, Medicaid, and other benefits just to survive. Taxpayers will get cheap labor on the front-end, but will pay for an expensive and time-consuming bureaucracy on the back-end just to keep this employee and their family at a minimum standard of living.

On the other hand, if Lucas County requires that same employer to pay a

living wage to its workers and provide a health care option, taxpayers will get the same amount of labor without having to subsidize all the additional welfare costs for the worker and their family. Even better, because this worker will be able to support their family on this wage, they'll be able to go out and spend a little more, contributing to an economy that desperately needs spending activity right now.

But even more so than the solid economic arguments, there's a powerful moral argument to be made for a living wage. More than a century ago, the Catholic Church issued a papal encyclical calling for a living wage. People of all faiths recognize the value of work and preach a message of economic justice for all.

Over 40 years ago, Dr. Martin Luther King, Jr. said that, "a true revolution of values will soon look uneasily on the glaring contrast of poverty and wealth." Since Dr. King spoke those words, the gap between the rich and poor has grown. In fact, of all the Bush administration failures, perhaps the greatest is that the wage gap between the rich and the poor grew to record levels in the last eight years. Today, our country and, in particular, our region face a deepening economic recession that threatens to further drive apart those with plenty and those without.

Unfortunately, in many ways, the economic crisis we are in right now is the product of a national attitude that's valued easy wealth over hard work. But those times are quickly coming to an end. The residents of Toledo and Lucas County are not afraid to roll up their sleeves and get to work, but it's up to all of us to ensure that their work is truly valued. If government, on behalf of working families, does not step up and guarantee that taxpayer dollars aren't spent on poverty-level wages, who will?
