- (e) The prothonotary or a deputy prothonotary of the Supreme Court, the registrar or a deputy of the County Court, the principal registrar of the Magistrates' Court;
- (f) The registrar of probates or an assistant registrar of probates;
- (g) The associate to a judge of the Supreme Court or the County Court;
- (h) The secretary of a master of the Supreme Court or the County Court;
- (i) A person registered as a patent attorney under Part XV of the Patents Act 1952 of the Commonwealth;
- (j) A member of the police force;
- (k) The sheriff or a deputy sheriff;
- (I) A member or former member of either House of the State Parliament;
- (m) A member or former member of either House of the Parliament of the Commonwealth;
