### CONDITIONS:

#### **STUD OWNER AGREES TO:**

1. Provide bitch owner with a complete 4 generation pedigree of the dog.

2. Take normal adequate care of the bitch while in our charge.

3. Have the stud dog in good physical condition including current vaccinations.

4. Sign litter registration promptly and return to bitch owner once fees have been paid & litter is born. 5. Provide a return stud service of the same dog to the same bitch if no pregnancy results from the mating, at no charge. To receive the return service, the bitch owner must notify the stud dog owner of failure to conceive, in writing, not more than 70 days following the mating. If the stud is no longer available for whatever reason, for the return service, the stud owner reserves the right to offer a different stud to the bitch owner or a return of fees paid for Stud Service at the Stud owners prerogative.

6. Provide the bitch owner with a written receipt for the stud service and a record of the breeding dates.

# BITCH OWNER AGREES TO:

- 1. The Bitch must be at least two years of age.
- 2. Pay the agreed stud (monetary) service fee before the bitch is serviced. (\$500.00)
- 3. The Bitch must have no disqualifying faults as defined in the Standard for Labrador Retrievers.
- 4. Provide a 4 generation pedigree before servicing and a copy of AKC Registration Certificate.
- 5. Provide veterinary certificate of current clear Brucellosis test and vaccinations including Rabies.
- 6. Send bitch in good health and in season.
- 7. The Bitch must be of sound, stable temperament. It is recommended that the bitch pass a Breed Suitability Test, Temperament Test, or have an equivalent AKC Obedience title, a basic obedience, or companion dog title.
- 8. The Bitch should be groomed, bathed, and dipped before she is delivered to us to be bred.
- 9. A copy of her pedigree, AKC or Foreign Registration Certificate, and photographs showing front, rear, and side structure should be provided.
- 10. Notify stud dog owner, in writing no later than 70 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service being provided.
- 11. Owner will keep the bitch properly confined prior to and following the breeding to ensure no other dog could mate her accidentally.
- 12. Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any person or firm connected with the business of resale or wholesale of dogs.

## STUD SERVICE POLICY:

- 1. The stud fee for Harley Fatboy Boling is \$500.00. The \$500.00 fee is due upon the Bitches arrival.
  - a. NOTE: The <u>American Kennel Club</u> takes the position that the <u>owner of the sire is</u> <u>required to sign</u> an application to register a litter certifying only to the fact that a particular dam was bred to the sire identified on the Litter Registration Application from on a specified date of mating, <u>unless there is an agreement</u> signed by all parties concerned in which it is specifically set forth that the owner of the sire is not obligated to sign an American Kennel Club litter registration application form until such time as the stud fee has been paid.
- 2. One puppy born alive or dead constitutes a litter. However, if <u>less</u> than three (3) puppies result from this mating; a return service will be provided at no charge to this same bitch at her next heat, or within one year, provided all conditions of this contract have been met.
