**Purpose:** This position is responsible for overall management and administration of the Health Resources and Services Administration (HRSA) Epilepsy project. The project is funded through a HRSA State Implementation Grant for Integrated Community Systems for Children and Youth with Special Health Care Needs. The goal of the project is to develop a network of providers who collaborate and participate in patient care through a viable telehealth system. Responsibilities of the position include, but are not limited to, the following: grant coordination; grant evaluation; financial and project reporting; communication among partners; and training and technical assistance.

## **Duties and Responsibilities:**

- 1. Develop and revise project objectives and activities in cooperation with grant partners.

- 11. Complete required travel for site development or other meetings
- 12. Include identified Federally Qualified Health Centers, Rural Health Clinics, and Critical Access Hospitals in the expansion of telehealth locations in Michigan
- 13. Develop social networking methods specifically for the expansion of telehealth understanding and usage
- 14. Work collaboratively with web consultant and create a telehealth website that includes physician resources and locations of facilities
