League Goes Live on Local Talk Show!

This October Amy Christensen and Julie Saugstad represented the League of Women Voters of Stanislaus County on Andy Mendlin's Show "On the Docket", a local talk show that airs on Local Radio Station KFIV.

Our League was asked to be on the show and we jumped at the chance. Not only was October the perfect time to be able to promote our League's Local Candidate Forums and registration dates, but also we were talking on a radio station that is known to have a conservative audience- predominately 45+ age, male listener, and conservative. We were able to reach an audience that has often perceived the League as having a liberal agenda.

Amy and Julie were also able to inform the public of our name change, the reasons why we did this and how it will help our County. Andy Mendlin asked some good questions to create interest and excitement, and Julie and Amy handled them beautifully. In fact, our League members took the bull by the horns. Andy was promoting good, old fashioned debates that would be livelier than forums. We, however, promote venues that give candidates equal time to answer questions from their constituents. We explained that the League used to do national forums, but they have been taken over by the two major parties!

Two phone-in callers wanted to know why we have not changed our name to include men. We have had male members since the early seventies; we have a solid reputation with our current name and want to keep our history.

One caller had the belief that the League was all liberals or Democrats. We are non-partisan and have membership from all political parties. We promote being informed voters, whatever your party affiliation. Julie and Amy were able to inform the listening audience that the League studies issues and only takes positions on areas that we have studied thoroughly. We were able to discuss Measure K and how our Local Action committee studied the measure. POLLING PLACE INNOVATIONS

League of Women Voters Points to Election Modernization

WASHINGTON, **DC** — The League of Women Voters today issued a report on innovative polling place practices. The League's report, entitled <u>Thinking Outside the Ballot Box: Innovations at the Polling Place</u>, highlights some of the ways that elections officials are making it easier for voters to cast their ballots this year.

Across the country, elections officials are changing the way Americans vote. Some of the changes — such as early voting and the use of vote centers — are dramatic and obvious. Others are more subtle, involving new technologies and changes in the procedures used to get voters in and out of the polling place.

"Innovations in polling place management are among the most critical reforms," according to Mary G. Wilson, national League president. "We hope that these stories about polling place innovations will spur all elections officials to think creatively about how to make voting easier for the American voter," Wilson said.

"We are still voting the same way we did 150 years ago, and we don't live that way any more," said Scott Doyle, who manages elections in Larimer County, Colorado. After analyzing voting patterns and the needs of voters in his county, Doyle developed "**vote centers**" for his county. Larimer County replaced its 143 polling places with 31 full-service vote centers where anyone in the county can vote.

"Modernization is essential," according to Wilson. "We need these new approaches to bring more convenience to the voting process and to help boost voter participation," she said. "Long lines and confusion at the polls must become relics of the past," she said.

Additional examples in the League report include 1) "**early voting**" in Clark County, Nevada, where more than 40,000 residents cast their ballots before Election Day at a popular shopping center; 2) "**electronic poll books**" in Seminole County, Florida, which eliminated the use of paper poll books and connected polling places to the voter registration database; and 3) "**uniformity and statewide standards**" in Georgia, which looked to Kennesaw State University for assistance in technology testing and elections official certification.

"Elections officials are taking a fresh look at how they do their work," said Wilson, "and that should pay off for voters and poll workers alike." NEW DISTRICT ATTORNEY SEES CHALLENGES TO BE MET

When Birgit Fladager was elected this year she had already faced the challenge of the Scott Peterson case. From that, she says, she learned the value of bringing a team together. She has been in the Stanislaus County D.A.'s Office for many years, working with the 50 attorneys allocated to them. Currently both the District Attorney's office and

the courts are understaffed and constantly recruiting staff. We are authorized for three more courts, but there is no place to put them. There have been numerous changes in laws during these years. It is a far cry from her first days, pre-computer. Now everything is computerized.

This department is the only governmental prosecution authority in the county; city attorneys do not do criminal prosecution. She emphasized

that the D.A.'s office does not file every case that comes to them, only those that they believe they can win. Many of the cases are gang-related. There is a victim service unit that deals with victims of violent crime that offers services including safety escorts for victims. There are special services for domestic violence victims. The child abuse unit has medical facilities on site.

The greatest challenges are the growing crime rate in Stanislaus County and the need to hire and retain attorneys to meet the needs.

The weekend after our meeting, the entire District Attorney's office moved to new quarters in the new building at12th and I Street, replacing the inadequate present location. We wish them well.




