**Dear Pierce County Voter:** 

#### Civic Knowledge and Engagement

We've launched an initiative to help citizens better understand the basic principles and practices of government. It's the best way to improve community engagement (voting, volunteerism, and awareness of current events).

Voter registration drives alone don't cut it. Only 67% of Pierce County's eligible population is registered to vote. And, 14% of those registered voters <u>never</u> voted. Not once.

Knowledge is proven to increase regard for America's ideals and governmental principles. And that does lead to more voting, volunteerism, and awareness!

#### Pierce Voters Get MORE

When we heard that the state chose not to publish a Statewide Primary Voters' Pamphlet, we were very concerned.

The Voters' Pamphlet is a critical resource. How can you make the best decisions if you don't have information on all of the candidates and issues?

We stepped up to fill the void. Our Pierce County Voters' Pamphlet has it all. If it's on your ballot, you'll find it in this pamphlet. If we had not done this, you would have missed information for 90 federal and state candidates.

And, we restored candidate statements to their full length and asked candidates for more detailed biographies.

#### Please Vote

The Primary Election has a very low turnout. Last year, less than 20% of Pierce County voters cast a ballot. Participation is important. And, this is particularly important for a Top 2 Primary that will determine which candidates advance to the November General Election.



- At least 18 years old by election day.
- Not under the authority of the Department of Corrections.

- In person deadline (New Washington voters only) October 25, 2010.



#### Ballot Title

The City of Milton Resolution No. 10-1784 places before the voters funding of Fire, Paramedic and Emergency Medical Services. This proposition funds Fire and Emergency Medical Services, including addition of Paramedics to serve the Milton community. It authorizes an increase in the regular property tax rate of up to \$1.21 per \$1,000 of assessed value over limitations, for a total rate not to exceed \$3.00 per \$1,000 of assessed value for collection in 2011. The 2011 levy amount becomes the starting base for computing subsequent levy increases for the succeeding four years only. Should this proposition be approved?

#### Explanatory Statement

The Milton City Council determined that it is essential to provide enhanced fire and emergency medical services, including paramedics. The City Council also determined that career and volunteer firefighters, paramedics and emergency medical technicians should be available 24 hours per day to serve the Milton community. To do so, additional funding from a stable and reliable source is necessary. After considering several funding options, the City Council is placing before the voters Proposition No. 1 for a levy lid lift on regular property tax. Proceeds will be used entirely and as the primary source of funding for fire, paramedic and emergency medical services.

If approved, this proposition authorizes the city to levy for collection in 2011, regular property tax in excess of limitations established in Chapter 84.55 RCW. The increase above limitations would be up to \$1.21 per \$1,000 of assessed valuation, *provided* that the maximum rate at which regular property tax is levied does not exceed \$3.00 per \$1,000 of assessed valuation. The 2011 levy amount becomes the base from which subsequent levy limitations are calculated for the following four years; after which, the base amount reverts back to what it would have been without approval of this proposition.

Authorizing Replacement of Property Tax Levy for Maintenance and Operation Expenses

#### BallotTitle

The Board of Fire Commissioners of Pierce County Fire Protection District No. 2 (Lakewood Fire Department) adopted Resolution No. 051710-004 concerning a proposition to finance maintenance and operation expenses. If passed, Proposition No. 1 would allow the District to levy the following excess property tax on all taxable property within the District without regard to the levy rate and percentage limitations in Chapter 84.52 RCW:

and used for maintenance and operations to maintain the current level of fire and emergency medical services, all as provided in Resolution No. 051710-004. Should Proposition No. 1 be approved?

#### Explanatory Statement

Lakewood Fire Department is requesting renewal of the maintenance and operation levy for a period of one year at the same rate and dollars as 2010. The department and the voters have found it necessary to supplement the regular levy since 1974. In 1939, the legislature established fire districts to serve rural areas, rather than urban areas like Lakewood. The regular levy is inadequate to provide fire, emergency medical and rescue services to a city of more than 67,000 people, a hospital, two colleges, a major state mental institution, and a regional shopping mall.

This levy funds about 25% of the department's budget. It will cost approximately \$1.00 per thousand dollars of assessed value in 2011. (The 2010 rate is \$1.00 per thousand.) The law prohibits any further tax levies for maintenance and operational support of the district for this two-year period, if the voters approve this special levy.

Lakewood Fire Department is a fully paid department providing advanced fire suppression, fire prevention and code enforcement, emergency medical and rescue services throughout Lakewood.

#### Statement For

This is not a new tax, but a replacement of the current levy. ## Fire Protection District No. 16

#### **Proposition No. 1 - Property Tax Levies for Emergency Medical Services**

Ballot Title Shall Pierce County Fire Protection District No. 16 be authorized to impose regular property tax levies of \$.50 or less per \$1,000 of assessed valuation for each of ten consecutive years, beginning in 2011, to fund emergency medical services, including advanced life support (paramedic) services?

Explanatory Statement Since 1985, the Key Peninsula Fire Department has returned to the voters repeatedly to renew its emergency medical services levy. Under current state law, the Fire Department can now ask the voters to extend this levy to a 10-year period.

The Board of Commissioners of Fire Protection District 16 has passed a resolution requesting an election to authorize a levy of a property tax in an amount not to exceed fifty cents per \$1,000.00 of assessed valuation, each year for ten (10) successive years. This levy would replace the current levy of 50 cents and will provide sufficient EMS revenue to fund the Key Peninsula Medic One program, including the salaries, equipment and medical supplies of firefighter paramedics, and the cost to deliver critical advanced life support care and emergency ambulance transport service.

Approximately 75% of the calls for service by the District are EMS calls. Growth and call volume have increased during the last several years, since the voters first approved an EMS levy. The regular property tax levy does not provide funds for an adequate level of emergency medical services. Without this levy approval the district projects layoffs of at least 12 personnel.

#### **Ballot Title**

Shall Pierce County Fire Protection District No. 17 be authorized to impose regular property tax levies of \$.50 or less per \$1,000 of assessed valuation for each of six consecutive years, beginning in 2011, to continue providing basic and advanced (paramedic) emergency medical services?

#### **Explanatory Statement**

Since 1979, voters in South Pierce have supported Pierce County Fire Protection Fire District 17 (PCFD 17) by authorizing a property tax levy for Emergency Medical Services (EMS). In 2004, voters again re-authorized this levy and it expires at the end of this year. Over the past 31 years, calls for emergency medical service have increased substantially and today they represent nearly 80% of all emergency calls.
