1. ELIGIBILITY: SFC / E7 - CURRENTLY ON BOARD AGR SOLDIERS

2. REQUIREMENTS:

- a. **MUST BE MOSQ.** Soldiers with the required SMOS and AMOS can apply.
- b. Soldier selected will be militarily assigned to the unit and placed in the required duty position.
- c. Soldier must possess a state driver's license and be qualified to operate military vehicles, which are organic to the unit.
- d. Soldier currently under Suspension of Favorable Personnel Actions (FLAGGED) may not apply.
- e. This position is open to **ALL CURRENTLY ON BOARD MA ARNG AGR MEMBERS (see AGR Gram CY12-05, para 4 for availability criteria).**
- f. Applicant must possess or be able to obtain a SECRET security clearance.

3. APPLICATION PROCEDURES:

Soldiers must submit the following documents to AGR Branch:

- a. A copy of this announcement with contact information filled-in below.
- b. Photocopy a DA Form 705 (APFT Score Card) within the last 12 months.
- c. Statement from the Commander/supervisor within the last 12 months stating Soldier meets height/weight/body fat requirements and not currently enrolled in the weight control program.
- d. Copy of last 3 NCOERS.
- e. Copy of an ERB within the last 12 months.
- f. Full-time Commander/AO memo stating concur/non-concur with request for lateral reassignment.
- g. A filled out Standard Form 181 Race and National Origin Identification (dated August 2005).
