#### **OFFICIAL RULES**

# NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

## 1. PROMOTION DATES

a. These rules (the "Official Rules") govern the Tamarack Diamond Hunt ("Promotion") will begin on February 16th, 2015 at 6a MT and end on February 28th, 2015 at 5p MT.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all legal residents of the United States and the District of Columbia who are 21 years of age or older at the time of entry and who live in Idaho. Employees of Journal Broadcast Group, Inc., d/b/a KRVB, KQXR, KTHI, & KJOT, 5257 Fairview Ave., Ste. 240, Boise, ID 83706 (the "Promoter" or "Station"), its corporate parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcasting stations in the Boise metropolitan area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. Listeners of KQXR will call (208) 287-1003 and be caller #20 when the special cue-to-call sounder airs. Each station will select ten (10) qualifiers to join the station at Tamarack Resort (311 Village Drive, Tamarack, Idaho 83615) for the Tamarack Diamond Hunt on February 28<sup>th</sup>, 2015. See more details in section 5(b). At the time of their call entrants must provide all requested information, including, their first name and last name, complete address, city, state, zip code, email address, telephone number, and date of birth. Use

of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Promoter. The contest administrator's telephone system is the official time keeping device for the Promotion. For purpose of this Promotion, a "Day" shall begin at 12:00:00 a.m. MT and shall end at 11:59:59 p.m. MT.

## WINNER SELECTION AND NOTIFICATION

- a. All decisions of Promoter management with respect to the Promotion are final.
- b. Each qualifier will receive one pair of lift tickets to Tamarack Resort, valid for February 28<sup>th</sup>, 2015 only. The lift tickets must be picked up at 5257 Fairview Ave., Ste. 240, Boise, ID 83706 and a liability waiver must be signed prior to February 27<sup>th</sup> at 5:30p MT. Further instructions will be provided from the station once qualifiers are selected. Upon on-site arrival at Tamarack on February 28th, 2015, contestants will meet on the Canoe Grill Patio at 10 MT for check-in. Photo identification is required at the time of check-in. Contestants will then be given five (5) specific locations to visit throughout the resort. Each contestant will take a "selfie" photograph at each of the five (5) location and then return to

a specified location with their entries. Once representative from Tamarack Resort and the radio station deems all five locations to be complete and accurate, the contestant will place one entry into the official entry box prior to 3:30p MT. The official drawing will take place at 4:15p MT.

- c. Odds of winning are based on the number of callers during each cue-to-call sounder. Twenty (20) total qualifiers will be selected for a chance to win the grand prize. One grand prize winner will be selected at random from the pool of up to twenty (20) qualifiers.
- d. Contestants must listen to 94.9 The River and 100.3 The X for a chance to qualify. To win the grand prize, qualifiers must be present at Tamarack Resort (311 Village Drive, Tamarack, Idaho 83615) on February 28<sup>th</sup>, 2015 at 10a MT and 4:15p MT.
- e. Winners (or their parents or legal guardians if under the age of majority) must execute and return any required affidavit of eligibility and/or liability/publicity release within three (3) days of notification attempt or winner will be disqualified and the prize will be forfeited and an alternate winner may be chosen by KRVB and KQXR.
