The Invitation for Bid (IFB) for Forestry Consulting Services issued August 7, 2013 has been amended/clarified as follows:

#### SECTION 5.0 CONTRACTORS QUALIFICATIONS – (Page 3 of 23)

Delete the first paragraph under Section 5.0 CONTRACTORS QUALIFICATIONS.

Insert the following paragraph in its place:

"The Consultant is **NOT** required to be a Certified Forester (CF) accredited by the Society of American Foresters. The Consultant, however, must have a minimum ten (10) years experience as required to use the "Forester" title under the Code of Virginia; OR the Consultant must be a North Carolina Registered Forester; OR the Consultant must be similarly registered in their respective State with ten (1) years experience."

The Bidder will be required to acknowledge his/her receipt and acceptance of Addendum #1 by submitting the addendum with the BID FORM. If the addendum is not returned with the BID FORM, the successful vendor will be required to acknowledge his acceptance prior to award of the bid; the bidder will not be allowed to make any price changes on his BID FORM.

The date for bid opening will remain at 3:00 p.m. August 28, 2013.
