Question#3: Is the dealer to provide one extra set of mower blades (3 blades) or an extra set for each unit (15 blades)?

Answer #3: Yes, the dealer is to provide an extra set of blades for each of the five units (five extra sets).

You are directed to make the following changes to the Bid Document:

- 1) Remove any reference to the QDS System. The City will not purchase the QDS System.
- 2) Replace the original bid proposal pages with the following bid proposal pages.
