Summer Enrichment (K-8th grade)

Swim Policy

This summer we will be attending Six Flags Water Park for many of our swimming field trips and on days that it rains we will have an alternate field trip. We will not be allowing students into the Wave Pool. Each child must have a Six Flags season pass. **Season Passes may be purchased from us at the time of Registration only. If you have already purchased a season pass, \$55.00 will be deducted from your registration and your child can use the season pass you provide, on those swim days.**

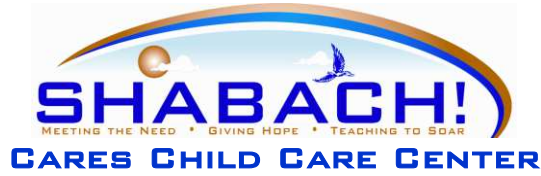
If you choose not to purchase a season pass at the time of Registration you will not be able to purchase one at a later date from SHABACH! You will need to purchase it directly from Six Flags.

The student's season pass must be surrendered to our summer program on the Wednesday of each week that the student is registered to attend. We will receive the pass at morning drop off or at afternoon pickup on that Wednesday. The parent will sign that the pass has been surrendered and the staff person will sign that they have received the pass. **If the pass has not been received by that Wednesday, the day before the swim field trip, then the parent will have to find other care for their student on that Thursday. We will not have staff here at the building to attend to students that are not able to attend the swim field trip. We need all staff to go on the field trip.**

Included in your registration fee is the purchase of swim attire for your student and it is very important that each student wear the swim attire that was purchased for them by our program. The students must wear their swim attire to school under their camp t-shirt and appropriate bottom. In addition each student must have swim shoes, a towel and a change of clothes. Please do not wear the swim shoes to school. We will have the students to change into the swim shoes when the time is appropriate. Please label all items brought on swim days. Children will be supervised by staff at all times. Only wading and swimming facilities meeting applicable local standards will be used.

Any child not picked up by 6:30pm will be charged a late fee of \$1.00 per minute.

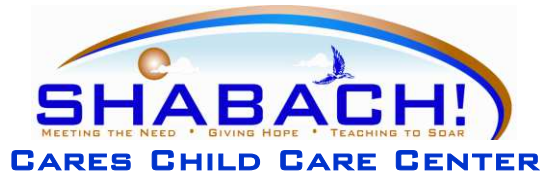

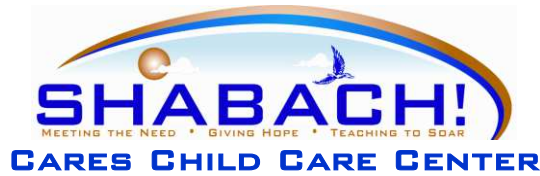

Initial

1. Any balances due within SHABACH! Christian Academy must be paid and all fines/late fees that may be assessed before the child is permitted to attend the Summer Enrichment Program. This includes past due balances from the previous year. The business office maintains one account for your family even though you may have multiple children in multiple programs.
2. There is a \$110.00 non-refundable & non-transferable registration fee is due at the time of registration. This includes your \$55.00 season pass.
3. A prepayment plan schedule is has been provided for you. Should you subscribe to the prepayment plan and do not pay the balance by the due date, you will be assessed an additional \$20.00 late fee. The payment plan is not mandatory.
4. A 10% discount per week, per sibling is taken off total weekly cost.
5. Should you choose not to purchase a season pass at the time of registration you will not be able to purchase one at a later date from SHABACH! You will need to purchase directly from Six Flags.
6. All applicants must have up to date medical forms on file in order to attend this program.
7. You must register for a least one week at the time of registration. **WEEKS ARE NON-REFUNDABLE AND NON-TRANSFERABLE FOR ANY REASON.**
8. **If you register after June 09, 2011 the weekly amount goes up to \$196.00**

Instructions on Adding Additional Weeks

Weeks are to ONLY be added in the Summer Enrichment office with Mrs. Yolanda Stancil or Mrs. Sheree Richardson.

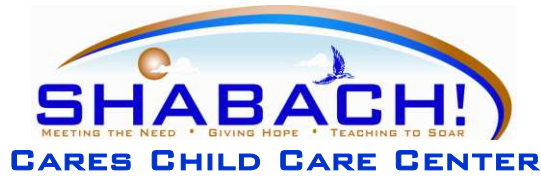
How to add a week within the Prepayment Schedule (prior to June 09, 2011)...

- You will add the week in the Summer Enrichment office.
- You may do a \$30.00 deposit at the time you add the week, and pay the balance by the due date as long as the due date has not past.
- Or you may pay for the week in full (\$176.00) at the time you add the week.

How to add a week after (June 09, 2011)...

- You will add the week in the Summer Enrichment office. The full amount of \$196.00 is due at the time you add the week.
- **All payments must be in no later than 6:30 on the Thursday prior to week of service. If your payment is received after the Thursday prior to service, your child will be subject to a 1 day waiting period before he/she can begin that week.**

Example: If you register or add a week on Friday your child will not start until Tuesday.
