## The Employee Free Choice Act

## Enlist in BAC's Letter Writing Campaign

Good news!

First, on March 10, 2009, the <u>Employee Free Choice Act</u> was introduced in both the House of Representatives and the Senate. With Congress expected to take up the bill in late spring or early summer, mobilizing support for this legislation takes on even greater urgency.

Second, according to a new <u>Gallup Poll</u>, Americans firmly support both the <u>Employee Free Choice Act</u> and workers' rights in general. Here's what the year's first independent survey on these critical issues tells us:

- 53% support "a new law that would make it easier for labor unions to organize workers."
- \* 55% say it's "important" for Congress to pass "a new law that would make it easier for labor unions to organize workers."

These results are especially heartening given the multi-million dollar campaign by corporate interests to lie about the bill and demean working people. Fair-minded Americans want the Employee Free Choice Act to be signed into law.

Unfortunately, those interests won't rest until the last vote is tallied, so it's up to us to continue to press Congress in every way possible to pass this legislation.

Many of you have already responded to earlier Legislative Alerts by signing the online petition supporting the Act and emailing your members of Congress, and for that the BAC wants to thank each and every one of you. [Click here to email your members of Congress or see the link below.]

A third and even more potent way to express your support is by **hand-writing** letters to your members of Congress. Handwritten letters attract more attention since they reflect an even greater degree of time and energy on the part of constituents.

Because of earlier security concerns involving Congressional mail, however, rather than sending your letters directly, BAC Local Unions and Administrative District Councils will be collecting members' letters to deliver to Capitol Hill.

Don't hesitate to involve members of your family in this important endeavor. Below are sample letters, or feel free to use your own words - the important thing is to make sure that we, as BAC members, are heard.

As your constituent, I am counting on you to help restore our economy through passage of the Employee Free Choice Act.
