<u>TIME COMMITMENT</u>: Grand Jurors are expected to spend an average of 10-20 hours per week, depending on the duties demanded by the committee they are assigned to during their year of service. Temporary absence for vacations is permissible, but excessively prolonged or repeated absences would interfere with the functioning of the Grand Jury.
