Councilman Henry stated "I'm fine with everything except for our Level I and Level II customers. I would like to take those rates and split it, instead of .002 to .001 on both of those. As we went up on our contract water, that increase in utility revenue is not showing up anywhere in this 10%. I think that what we've done, especially Bar-S, going up on their water two consecutive years quite a bit, that they are not going to swallow this rate increase. David Tucker is out of town, is anyone here representing Bar-S? With what we've done to them with their water, to add this kick in the teeth with an electric rate also puts quite a burden on them. I do know that Altus shows up on the corporate we're on now because of the difference in rates when their budget year started and now.

And with the Cotton Gin, I think there are some people here representing them, the same. My concern is each of these levels just have one customer, so it's no secret who we're talking about. When we talked about Level- 1 and Level 2. The Cotton Gin is very important for Altus. Even if we lost money on them a little bit, because they turn their gin on in the winter time when we need flow. Just what they do with our winter load makes everybody's cost go down because they make the difference between the summertime peak and the wintertime low. At this rate, I don't believe we lose money on the cotton gin, and I would hate to see us lose either one of these two companies.

I do know that Bar-S is planning on an expansion. I do know that they were bought by the Sigma Group. As they expand, I want Altus to at least have a shot at getting one of those expansions. And I'm afraid that going up to much to fast on their utility rates is a good way to not get you in the door to even talk about an expansion.

I would also recommend that we get both of those entities back on a contract. I know for a lot of councilmen that's a bitter word, but it's because I know the Bar-S contract was a terrible contract. It doesn't have to be a bad contract for the City. They kind of expect us to make a little money off of them so we can sustain things, make sure that we're here tomorrow and make sure the electricity is on when they flip the switch. I don't think they begrudge us having a profit, but I also think that for them to be able to do some long term planning, a five year contract with a roll over or whatever, to sit down every year and compare and then if you have to adjust that, adjust it. I would like to start the ball rolling on getting them on contract for next year.

To recap what I'm saying, take some of the increase in the utility revenues that we made off of the contract water, use that to take care of splitting Level 1 and Level 2 customers into two, so we don't have a two hundred thousand dollar utility increase in one year on those people."

Councilman Smiley questioned "How much revenue is our contract when we put a dollar figure to that for sure what that is going to bring in and is it not included in this?"

James Wilson "I don't have the total estimate for all the contract water, but we do know it's going to be increasing and we do know that it's fairly significant. What I did, because we have some unknowns as to water actual revenue will end up coming in at. I kind of hedged half way. It's very common to have a contract with especially your key employers so that the municipality and the corporation in your business can do some planning. Your right on point that you can have some very simplistic clear concise contracts and know where you are now and where you are going in the future.

The second item is yes you could reduce these increases to minimize the impact knowing that you are going to have some amount of increase contract water revenue that would offset that loss of revenue."

Councilman Shelton "What is the dollar amount of loss of revenue if we shave those back?"

Mr. Wilson "Depends on how big the shaving is."

Councilman Shelton "Have you figured that Rick?"

Councilman Henry "Cutting them in half."

Councilman Patterson "For the two customers, across the board?"

Councilman Henry "Those two"

Mr. Wilson "Are you talking about the kilowatt rate?"

Councilman Henry "Yes"

Mayor Webb "I think where more concern is, What revenue do we lose by cutting that rate in half that we'd have to make up somewhere else?"

Councilman Shelton "Where do you make it up?"

Discussion continued

Councilman Henry "I believe that Bar-S would be taking their electric increase from 120 to 60 K."

Tom Buchanan, a stockholder of Cotton Growers Gin spoke on behalf of the Cotton Growers gin.

Mike Berry, General Manager of Cotton Growers gin also commented.

Mr. Wilson "I'd like to address specifically the request on reducing those two amounts to a Level 1 and Level 2. Because of the unknown revenue that's coming in, I do believe that if you chose to reduce those in half, there's a reasonable chance the additional water revenue would probably cover that. Even if it didn't we would have several months advanced notice in which you would know that you might need to make some other minor adjustments."

Motion made by SIMCO to approve Dr. Henry's synopsis of the program, (½ of those two).

Mayor Webb ".ool per kilowatt hour increase on each of those"

Elizabeth Gray - Absent (OMPA meeting)

15. CITY COUNCIL MEMBER'S COMMENTS AND REPORTS.

Perry Shelton - I had an opportunity to attend a meeting at DEQ with Elizabeth Gray and we had gone to talk to Steve Caesar and David Hardgrave. They were giving a briefing to the DEQ folks on the way ahead for the Altus Water Waste and Chloride problems. There were five of the DEQ engineers there, lot of questions, lot of comments. All in all at the end of the meeting they were very happy that Altus came up and talked about a way ahead. They liked the plan that we have. The head engineer there is going to make minutes to the meeting and I suppose we 'll be seeing those shortly. I haven't received anything yet. It was a good meeting and DEQ folks are happy that we are handling some of our water waste and chloride problems.

Mayor Webb - I'm going to pause right here with Council Comments. We went out of order this evening. We're going to come back and finish up new business with the AMA. We got a little out of order because of this one issue. We'll come back to Council Comments after we get through with the AMA, if that's alright with everybody. (8:40 p.m.)

Mayor Webb - "Now we can reconvene the special meeting of the Altus City Council and continue our Council members comments.(9:00 p.m.)

Jack Smiley - I'm glad this process is -- we've gotten through budget process and the rate increase process. It's been painful but still keeping a positive attitude that we're on the road to recovery.

Scot Simco - Bob, I was going to ask a question. A few months ago I'd ask some questions about the stairs going down to the west waste water plant. I know we've been very busy with all these other projects but I just thought of this and I want to make sure it's still on the drawing plan on in the process of getting worked on.

Bob Stephenson - We're waiting for a quote from one of the local fabrications in town. We're going to compare that against a factory fabrication unit, something that you order and have a truck come in and install. We've got those numbers and now it's just a matter of picking the right one and coming up with the money.

Simco - Great, Thank You and James said he'd come up with the money because it was a safety issue.

Rick Henry - Top of the fold story at the Lawton Constitution today talked about Ft. Sill rationing water. Frederick is doing the same. Their guy said that because Steed is at 50%, I think we should be rationing water. He said the Frederick Lake and Steed is at 50. I don't know if there's another problem there why they are rationing water, but my question to you Bob, this is 2 years now of severe drought, is it prudent for us to go ahead and institute an odd/even watering day or some kind of something where at least be aware of 'yes we have plenty of water right now, but nobody's going to say it will rain this fall or next spring either'.

Bob Stephenson - That's all true enough. And that's another rumor that I did dispel. We got a call that one of the member city's had a mandatory rationing program. That is true they do. Part of that problem had to do more with a broken line that they had feeding the city. And also had to do more with the fact that they had actually contracted to deliver more water than they have in allocation in the District. Frederick, they also has a mandatory rationing that is in place, I think this is the second year. I've talked to Mr. Johnson and they felt it was a prudent thing to do. We have asked people here to volunteerly conserve and I think as we look at the lake and the lake levels and our water

consumption we're probably going to recommend at a later meeting that we step it up and look at some type of 'rationing' conservation program. Our district at the last two meetings we've discussed the level of the lake and we felt that it was time as a Conservancy District we start talking to the members cities about what's their plan to conserve water if that's what they elected to do. The attorney for the District sent out letters last month to each member cities attorney addressing that issue.

Henry - Just as a historical perspective, when's the last time the reservoir has been this low?

Stephenson - I've been on that board 8 or 9 years and I don't remember it that low.

Councilman Smiley - Bob, On our allocation, what percent of our allocation do we use a year normally?

Stephenson - Our annual allocation is 11, 200 acre feet. Last year which was a record water use, we used 7,000 acre feet.

Smiley - Altus is using about 60%. Some of the member cities are using more than 100% because they are selling water to other entities. So have we taken care of that problem?

Stephenson - Yes we're taking care of that problem. It wasn't that pronounced when the lake was full because the people drawing more than their allocated amount, was a small amount but percentage wise it was a bigger number. Our board has talked about it, the fact that we don't feel that the member cities who are staying within their allocation are going to be agreeable to some of the members taking more than their allocation.

Henry - So we have 2 ¹/₂ years at current allocation rates or usage rates?

Stephenson - At current allocation rates. I don't think we're at the need or the time to actually panic and start demanding a very restrictive rationing plan, but I do think it's time that you start thinking about it, our District is thinking about it and we're working with the member cities and Bureau of Reclamation trying to make sure that everybody has a two or three year plan.

Smiley - I was talking to Tom Buchanan about this same thing, if that day ever come, he said they could have water to us within 24 hours. How much water do we have in that lake?

Stephenson - We have a 4800 acre foot allocation (in months?) We used 7,000 acre feet in the 12 months of last year, so the 4800 would be 7-8 months. Our City Reservoir is our immediate emergency supply.

16. MAYOR'S COMMENTS AND REPORTS

I want to comment again my appreciation to this Council and James and Elizabeth on getting this budget passed and ultimately funded today. I'm glad this work is behind us. I anticipate getting right to work with our committees on some of these utilities and other fees and look forward to our other studies that come in and we'll start digesting this and hopefully be ahead of the curve for next year and get some of these lined up along the way. It's been a tough process this year, no doubt. I appreciate the citizens patience with that and understanding knowing that we are doing what we have to do not because it's what we want to do necessarily, but what's needed to get us on the right track. I'm happy that we've completed this part of the process.

Bob Stephenson - If I could make one comment, Council expressed an interest in water study so I did take the liberty of contacting the Prime Group and asked them would they be interested in doing the study. I got that response, James has a copy of that. We'll look that over and should have something within the next meeting or two.
