### **HOT! New Pilot Program Allows Veterans to Directly Schedule Audiology and Optometry Appointments Starting March 30!**

A national performance improvement team has been working with VA medical centers across the country to identify performance improvement opportunities and pilot programs that can positively impact the Veteran and employee experience. One opportunity, identified during sites visits, is the direct scheduling of patients in need of Audiology (hearing) and Optometry (eye) services.

The Bay Pines VA Healthcare System (VAHCS), along with two other sites (White River Junction, VT and Mountain Home, TN), was selected to implement a 120-day pilot program which will give Veterans (including traveling Veterans and those unassigned to a Primary Care provider) the option to directly schedule Optometry and Audiology appointments without the need for a Primary Care referral. This pilot program will be available across the entire Bay Pines VAHCS starting March 30, 2015.

Veterans can schedule Audiology or Optometry appointments directly by calling 727-398-6661 extension 15525 or by speaking with staff at Bay Pines VAHCS facilities where these services are provided. Audiology services are available at the C.W. Bill Young VA Medical Center, Lee County Healthcare Center and VA Community Based Outpatient Clinics located in Bradenton, Palm Harbor, Port Charlotte and Sarasota. Optometry services are available at the C.W. Bill Young VA Medical Center, Lee County Healthcare Center and at VA Community Based Outpatient Clinics located in Bradenton and Port Charlotte. ### **Military Officer Association of America**

#### **Formerly called The Retired Officers Association**

The Military Officers Association of America is a professional association of United States military officers. It is a nonprofit organization that advocates for a strong national defense, but is politically nonpartisan.[citation needed] The association supports government policies that benefit military members and their families. Its membership is made up of active duty, retired, and former commissioned officers and warrant officers from the uniformed services of the United States.

#### **History**

Originally called The Retired Officers Association, the organization that is now the Military Officers Association of America was founded in 1929. The association's first headquarters in Los Angeles, California. The association's goal was to provide advice and assistance to fellow military officers throughout United States. The organization also promoted fraternal relations among America's uniformed services.

The association moved its headquarters to the Washington area in 1944. At that time, the organization had approximately 2,600 members. In 2002, the association changed its name to the Military Officers Association of America. The change took effect on 1 January 2003.

Today, the Military Officers Association of America has over 380,000 members. It is the fourth largest military officers' organization in the United States. In addition to supporting a strong national defense program, the association provides military benefits counseling, career transition assistance, and educational assistance for children of military families (including families of enlisted personnel).

#### **Organization**

Membership in the association is open to active duty, retired, and former commissioned officers and warrant officers from the uniformed services of the United States including the National Guard and Reserve components. The seven uniformed services are the United States Army, the United States Marine Corps, the United States Navy, the United States Air Force, the United States Coast Guard, the United States Public Health Service, and the National Oceanic and Atmospheric Administration. Surviving spouses of deceased officers are eligible for auxiliary membership.

The association is governed by a board of directors. The board is composed of 36 members from all seven uniformed services. Board members also represent six geographic regions. The board elects its chairman and three vice chairmen. It also elects the association's president, chief financial officer, and secretary. The president oversees the association's day-to-day operations. The association's headquarters is located in Alexandria, Virginia.

### SecDef Warns of Pay Cuts

March 20, 2015

On Mar. 18, Secretary of Defense Ash Carter issued a dire warning to Congress if it fails to repeal sequestration: the military may start cutting pay.

The services have already begun to cap pay, providing nominal pay raises that fail to match private sector wage growth, but this is the first time the Department of Defense has talked of actually reducing base pay for servicemembers.

“Everything ... is on the table,” said Carter. “We could be forced to consider pay cuts, not just cuts in the growth of compensation.”

“No portion of our budget can remain inviolate.”

Defense hawks on both sides of the aisle are seeking relief from sequestration budget cuts.

For FY 2016, the administration asked for a \$561 billion base defense budget —\$38 billion over the mandatory sequestration caps. According to Carter, a proposed defense budget that keeps sequester level funding in place will be met with a presidential veto.

That statement drew immediate criticism from republicans, many of whom have pushed for ways to boost military spending in 2016 while leaving budget caps in place for non-defense spending.

On Mar. 19, the House Budget Committee passed its FY 2016 budget. The proposed budget boosts defense spending by adding money to a wartime funding account to make up for caps on the Pentagon’s base budget. The plan would keep defense spending under caps mandated by the 2011 Budget Control Act and provide \$90 billion to the Pentagon’s overseas contingency operations (OCO) account, which is not subject to sequestration caps.

Deficit hawks have complained about using budget gimmicks to exceed sequester caps.

“The defense department shouldn’t have to operate in this kind of uncertain budget environment,” said MOAA’s Deputy Director of Government Relations, Col. Phil Odom, USAF (Ret). “Defense planners need predictability and a repeal of sequestration. Failure to repeal sequestration puts national security at risk.”

### Doc Fix Debate Heats Up

March 20, 2015

For the last few weeks, Congress has been discussing a resolution to prevent a 21% payment cut to doctors who see Medicare and TRICARE patients, known as the “doc fix.”

According to sources, Congress has never been this close to repealing the current Sustainable Growth Rate (SGR) formula,



a legislative mechanism used to pay medical providers who see Medicare and TRICARE patients.

Congress has been trying to fix the flawed formula for the past 13 years, often with short-term patches. Talks of permanent repeal have previously fallen apart at the last minute due to a lack of consensus on how to finance the deal.

Permanently repealing the doc fix will remove a great source of concern from both providers and TRICARE beneficiaries. Because TRICARE reimbursement rates are tied to Medicare’s, the doc fix affects TRICARE beneficiaries of all ages. Additionally a permanent deal is needed to sustain Medicare and TRICARE for Life benefits.

The current payment patch expires March 31, and lawmakers are trying to create a permanent solution instead of passing what would be the 18th temporary fix since 2003.

Congressional leaders from both parties have hammered out a deal that would partially pay for replacing the flawed doc fix formula. For beneficiaries, the deal could involve charging wealthier seniors higher premiums for Medicare Part B and Part D. Providers might see a shift of when payments are made to Medicare Advantage plans.

Details are scarce at this time, but the proposed legislation is rumored to consist of a new pay system for physicians, a consolidation of programs, and paying providers based on performance. Pay will be based partly on how well physicians coordinate care by introducing clinical care guidelines.

### It’s official, DD-214’s are NOW Online.

The National Personnel Records Center (NPRC) has provided the following website for veterans to gain access to their DD-214’s online: <http://vetrecs.archives.gov/>

This may be particularly helpful when a veteran needs a copy of his DD-214 for employment purposes. NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents. Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site. Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time.

### Advocacy

The association promotes military professionals and encourages government policies that support military members and their families. The association staff identifies important national defense issues and provides association members with regular updates on key issues and pending legislation. The association advocates for a strong national defense, but does not get involved in military strategy debates or support specific weapons systems.

### Bottom Line - It's the Same Old Song

March 13, 2015

We all regularly read headlines about the need to reform the military retirement system. Over the past several years, more — than I'd prefer to count — commissions, think tanks, and talking heads crow about how “unsustainable” military compensation is.

One thing I've learned is how repetitive these calls for fundamental changes to military compensation sound. For instance:

“[We] cannot disregard the already heavy costs involved in military retirement of the substantial added costs, which would result if re-computation were to be retained as part of the military retirement system.”

Congress wrote those words in 1963, believing an annual cost-of-living adjustment (COLA) was too expensive for the government and ultimately would threaten national security.

These remarks seem strange now, considering annual COLAs are locked in statute. Military retirees today have the peace of mind of an inflation-protected benefit, something increasingly rare in the private sector. Yet it is one of the incentives that keeps someone in the service for 20 or 30 arduous years.

“During the past two decades, the uniformed services retirement system has come under increasing scrutiny and attack. By recommending the [current] changes ..., [we] are attempting to put the issue of structural reform in the uniformed services retirement system to rest for the foreseeable future. ... As a result of these changes, the criticism of the uniformed services retirement system will subside and the concerns of servicemembers regarding the uncertainty of retirement benefits can be assuaged.”

That sounds like something you would expect from the recent Military Compensation Reform and Modernization Commission (MCRMC) report, right?

Wrong.

That lofty statement came from Congress in 1985, the last time they tried to seriously tinker with military pay and benefits. What was the result of that experiment? REDUX, the system that ended up crippling retention by the late 1990s that the service chiefs begged Congress to abandon it in 1999.

The MCRMC recommends moving retirees into a blended retirement system and lowering the defined benefit by 20 percent while establishing a government match into a contributory retirement plan, similar to a 401(k). The idea is servicemembers put some “skin in the game” and fund part of their own retirement like their civilian counterparts. Servicemembers could take their benefit with them if they leave before 20 years of service. Who could object to that?

“A noncontributory plan of retirement is traditional with the military and particularly suited to a government agency. Private industry, lacking the taxing power and the security of perpetual assistance, wisely accumulates in advance the funds from which to pay retirement benefits, even though the employer’s corporate existence should end. The government has no need to accumulate such a fund as long as the power to tax exists.”

The Hook Commission of 1948 said those words, which highlight the importance of the current system.

While the workforce has changed considerably over the past 70 years, the premise remains the same: The government has the ability to pay for military benefits in ways that private enterprise simply cannot. It is the responsibility of Congress to find a way to pay for national defense.

But that hasn’t stopped studies since then from seeking savings by cutting back on the defined benefit for retirees.

“Some of the proposals offer an opportunity for substantial budget savings, which guarantees them some popularity during this difficult budget season. But changes in military compensation must also be assessed in light of their effects on recruiting and retention, lest we revisit in the next few years the major manning problems of recent years.”

That line sounds remarkably like what MOAA members have been telling Congress when these proposals surface. But those wise words actually were said in 1983 by then-Assistant Director for National Security and International Affairs Robert Hale. They were true then, and they are just as true today.

By looking at the past 13 years of conflict, it is clear the current retirement system works. We’ve been in the longest sustained military engagement in American history, and we’ve only been able to maintain retention levels because of the value of the current system.

Any changes to military retirement would have to provide the same results. In today’s environment, a transportable ca-


reer device only provides a greater incentive to leave when times get tough.

**The bottom line:** Commissions, think tanks, and recommendations on retirement reform tend to sing the same tune. You need an advocate like MOAA that cuts through the noise to make sure you hear the real message. What’s most important is that the retirement system of the future retains top quality, mid-grade NCOs and officers for a career.

**Subject: Vincent House**

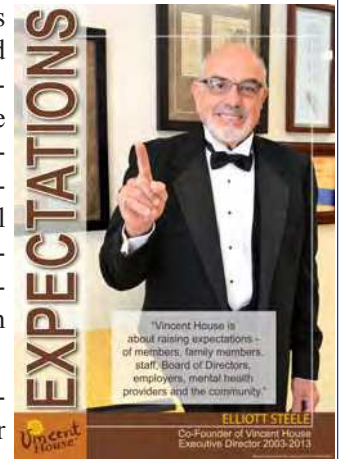
Twenty two years ago Elliott's life was dramatically changed with his younger daughter's diagnosis of schizophrenia. He became acutely aware of the discrimination and the misunderstanding of mental illness as well as the inequities in both the public and private mental health systems. He therefore became an active advocate.

After completing a 16-year career as Administrative Director at University Community Hospital, he made a career change for the sole purpose of working to improve the services for persons living with mental illnesses in Florida. Elliott recognized that one particular aspect of the service delivery system in Florida that was lacking was meaningful daytime activities. He therefore incorporated Van Gogh's Palette, Inc. and trained in the Fountain House Model. He then worked to establish Vincent House, a restorative community for people recovering from mental illnesses.

After several years of advocating, Elliott was able to convince the state of Florida to invest in Vincent House. In January 2003, Vincent House opened its doors. Vincent House participated in an ICCD certification review in December 2004 that resulted in a three-year certification with no recommendations. Vincent House became Florida's first internationally accredited Clubhouse.

Vincent House has been the recipient of the NAMI-Pinellas County Iris Award and the Beverly Chapman Award for Outstanding Employment from the Able Trust. In addition to numerous newspaper articles, Vincent House was featured in Reintegration Today Magazine and a member was featured in the January 2005 edition of Reader's Digest.

Elliott received his bachelor's degree in economics and political science from the University of Wisconsin, Milwaukee and a law degree from Drake University.
