NB: NORMALLY NOTICES OF MOTION WOULD BE RECEIVED BY THE CEO BY THE 29 MAY 2015, AS PER CLAUSE 37 HOWEVER THE CONSTITUTION IS UNDER REVIEW AND WILL BE TABLED FOR VOTING ON AT CONFERENCE
