**REQUIREMENTS**

An applicant for a Journeyman Electrician Examination must have completed 8000 hours as an apprentice and have their hours documented on company letterhead from their employer(s).

An applicant for Journeyman Electrician License who has passed the Prometric Journeyman Examination with a minimum score of 75, must provide documentation of completion of the required 8000 hours as an apprentice prior to their having taken the examination and provide a copy of their examination results.

An applicant for Master Electrician Examination must have completed 4000 hours as a Journeyman Electrician licensed with the City of Jefferson. If the applicant is not licensed with the City of Jefferson they must provide proof that they met the above requirements for a Journeyman Electrician examination prior to having taken the Prometric Journeyman Examination.

An applicant for Master Electrician License who has passed the Prometric Master Electrician Examination with a minimum score of 75 must have documentation that they meet the above requirements for a Master Electrician Examination prior to having taken the Prometric Master Examination. A copy of their examination results must be provided.
