YUP, WE CAN BE ANAL

So I'm talking with a guy the other day, a professional that started his own successful business, has two kids out of college now and works every day to repay his retirement account for eight years worth of the finest weekday

education and weekend partying two Ohio institutions can offer. As we're comparing our lives and similarities, it comes to light that the parallel universes we have traveled together end with his statement that he's "just not a car guy". Even with that, however, he tells me later on after more of my universe is shared with him that "I hear you NCRS guys are anal. You even study bolts." How a non-Corvette guy, a non-CAR guy ever heard of us - much less the degree with which we analyze and compare original parts to reproduction parts - is beyond me. At any rate, I'm not denying it. Evidence is in this small write-up I'll share with you now.

Thousands of parts of the Corvette are scrutinized every time a car sits on the judging field. And with that, information is shared about the differences in a particular, installed reproduction part, and the original part that should be in its place. Some of these lesser-discussed parts are as follows.

Solid axle generator tags aren't talked about much, possibly because there isn't a lot of ink on the subject. When you judge the generator on an early car and see a fresh, newly-minted generator tag and beautiful, clean rivets, you know this isn't the one that was originally installed to this generator 40+ years ago - more like 40 days ago. But you can't deduct from the judging sheet because it's "too nice" or "too new". What, then, is a viable difference between this obvious reproduction and the original? First, it's important to know that there are a couple of styles of original tags that were originally installed.

The photo below shows two original tags followed by a reproduction tag. Note the differences in the two original tags. First, the spread of the "V" in the word "Volts". The top tag has a tighter spread than the 2nd tag. The phrase "Made in the USA" is spread beyond the "12 Volts"

line in the upper tag, and is confined within the spread in the 2nd tag. The "l" in Delco points to the "N" in Anderson in the upper tag, and to the "A" in the 2nd tag. These are both original tags, made by, evidently, two different vendors for Delco-Remy. Top one is dated late '62 and the 2nd is dated late '60.

The 3rd tag, with it's shiny new silver color and pretty new rivets, is a reproduction. The first thing I look at here is the word "model". Note how this word looks in the 3rd tag vs. the top two tags. Original tags used a font that is best described as "bold", in that the letters are thick. The word "model" is easy to read in the reproduction tag, with better clarity and spacing between letters than the originals. This, of course, carries over to the other words on the tag, which you can study and discover the differences. Next I'll look at the actual stampings on the tags. The originals will have crisp, clean and well-defined stampings, as opposed to the reproduction tag that has a heavy. spread stamping. Notice the long top serif of the "1s" in the originals vs. the reproduction tag. It is very difficult to replicate the correct stamping of the original distributor tag.



Now, in honor of the guy who made the statement "you even study bolts", here goes: It's very easy to come up with the WB, the WB1C, the AP and the TR bolts all day long in the restoration of our beloved Corvettes. As you buy these bolts to put into your car, take a minute to compare them to the originals you're replacing. How are the reproduction guys doing?

Well, they're close. The next photo shows two 5/16-24 bolts commonly found in use on early Corvettes. An example would be the nose support rods from the grille opening to the top of the header.

On the left is an original bolt; a reproduction on the right. The difference is obvious with the spacing of the two letters and the built-up pad on the original. When I see an original bolt that is even in fair condition, it will receive full credit - unless it's been painted silver or something. Always give the nod to the original part, even if it's something as anal as a bolt.
