Invest the interim and inactive funds of the District in United States Government obligations and/or Certificates of Deposit of recognized depositories as provided by law, and to sell such investments when such funds are required to meet the operating requirements of the District. This permits the Treasurer to invest at the most productive Rates
- D. Borrow funds within the confines of established accounting practices and statute from internal funds or outside institutions if it is necessary or beneficial to do so
