

The days are getting longer, the sky is getting brighter, and our town is getting busier by the day! A lot is going on this spring, so take a moment to read this newsletter, keep in touch through our facebook page, watch for the weekly events and happenings email, and continue to visit our website. We strive to keep you informed!

On April 9—just a few days from now is the Anacortes Spring Wine Festival. This third annual event is designed to bring visitors to our community to experience wine from throughout the Pacific Northwest. The retail division is encouraging businesses to decorate their storefronts with that theme in mind. Many downtown businesses have agreed to stay open late that evening, as the event ends at 4:30 pm and festival goers will be ready to shop. Featured wines will be available in the evening at local restaurants. To encourage visitors to stay the night, the Majestic has put together a Sunday brunch to extend the festival. As an official event of the Skagit Valley Tulip Festival, we are dovetailing their promotional efforts with our own—Sip-Toe Through The Tulips! Sip on Saturday, sight-see on Sunday, and tell your friends about it on Monday morning.

Another great event of the tulip festival is the Quilt Walk in downtown businesses. This is a treat each year to wander around town and experience the talent of these fabric artists and also take a moment to learn a bit more about the host businesses. The Island Chicks are putting together a wonderful new event directed to antiquers. Chamber members, port and city staff, and community members trekked to Port Townsend last month and toured their Marine Maritime Center and learned about its formation and fundraising efforts. Port Townsend faces many of our same challenges: tourism, downtown businesses, major shopping district in another town, high-end housing costs, ferry dependent, etc. It was great to share ideas with another working waterfront community. We plan to continue to take field trips to other communities to learn "best practices" from them.

Your governmental affairs division has been keeping a keen eye on this legislative session in Olympia, which has been full of issues related to businesses. Once again service for Washington State Ferries is on the chopping block and the Sidney run is taking the brunt of these cuts. A group of Anacortesians travelled to Sidney on March 27 to celebrate the spring opening; our mission is to convince the legislature this run is vital to our economy and continuing to cut it is detrimental to both our businesses, and their tax revenues. I would personally like to welcome three new board members who filled vacancies. **Brian Geer**, executive



director of the American Red Cross-Islands Chapter and city councilman, has been an advocate of the business community and steadfast chamber volunteer. **Chris Terrell** owns How it Works and Sunnyhill Kennels and is very much involved with the new Heart of Anacortes performance venue. Chris and his staff have been instrumental in keeping the chamber near the cutting edge of communication technology. **Matt Miller**, Read Me A Story, is the past XO of NAS Whidbey and brings laser-like strategic and tactical thinking with an easy-going smile.

The new marketing and promotions coordinator, **Leah Hines**, started here last month. Once we get through festival season she will be focusing on cooperative marketing opportunities, building promotions and public relations initiatives. ## **Anacortes Small Boat Center Continues to Move Forward**

For more than a generation, the many residents of Anacortes, Fidalgo and Guemes Islands have worked to gain meaningful public access to the waterways of Fidalgo Island. The Anacortes Small Boat Center (ASBC) was formed with this goal in mind and is focused on the creation of a usable, multipurpose small boat center to enable the on-water launch and use of small boats.

The ASBC's long-term goal is a multipurpose facility on city land adjacent to the Anacortes Yacht Club. The building will have space for equipment storage and small boat repairs, and will host boat-related gatherings and educational events. There will be day parking for trailers and wash-down facilities for small craft. In 2010, the first major step was accomplished with the installation of a small boat hoist in the Cap Sante North Basin at the head of PQ dock.

To help raise money for this facility, ASBC has worked with the Port of Anacortes to create a secure dry storage area for small craft, including mast-up sailboats to 3500 lbs, in the parking lot by PQ dock. There are hand and power mules to get boats to the new small-boat hoist; small boats can be hand launched off the dock. The mast-up storage yard will be ready in April to begin use. Rates will be reasonable.

The ACSB is also working with the Port of Anacortes on small-boat access at the newly designed and renovated Seafarer's Memorial Park south of Cap Sante Marina. The port has worked with ASBC to accommodate the many needs of various small boat users and for that we are honored. This facility will be open to the public late


