Thank you for expressing interest in employment opportunities with the Plain Township Fire and Rescue Department. Enclosed you will find an application packet for the position of Career Firefighter/Paramedic.

An eligibility list for hiring Firefighters/Paramedics shall be established by the chief and deputy chiefs on the final disposition of the evaluation process. The eligibility list shall be submitted to the Plain Township Board of Trustees to be used as informational gathering only, in part of their consideration for the hiring to the Career Firefighter/Paramedic positions. This eligibility list will be used by the Plain Township Board of Trustees to hire Career Firefighter/Paramedics. The Plain Township Board of Trustees do not intend that the establishment of this eligibility list or the procedures, in any manner, used to create the list or the numbers hired shall in any way modify the statutory authority granted to them by O.R.C. 505.38 or other statutory law that delegates any such authority to any person.

Selected candidates will be required to participate in written knowledge tests, physical skills assessments, and practical abilities tests in both fire and EMS skills, as well as an oral evaluation examination. This packet is a part of the examination process. Before completing the application, please read the minimum qualifications. You CANNOT be considered for the positions unless you meet these requirements.

Minimum Qualifications:

In order to have your application considered, YOU MUST:

- 1. Be a U.S. Citizen.
- 2. Be a minimum age of 18.
- 3. Have a minimum one (1) year experience as a Firefighter/Paramedic serving on a volunteer, part-time, or career fire department.
- 4. Have vision in each eye correctable to 20/20 via adjuncts compatible with fire department equipment such as breathing apparatus.
- 5. Have an acceptable driving history, criminal, financial and character background. All driving records are subject to investigation by the Township. The following offenses may disqualify an applicant:
 - A DUI conviction or a revocation or suspension related to DUI.
 - A conviction for a major violation which includes:
 - o Failure to stop/report an accident
 - o Reckless driving/speeding contest
 - o Driving while impaired
 - o Making a false accident report
 - o Homicide, manslaughter or assault arising out of the use of a vehicle
 - o Driving while license is suspended/revoked
 - o Careless driving
 - o Attempting to elude a police officer
 - o Speeding 25-plus miles over posted limit
 - Four or more minor violations or at-fault accidents in any combination, within three years.
 - Three or more at-fault accidents within three years.

This list is not all-inclusive. All other offenses or combination of offenses will be reviewed individually.

 - A. A physical abilities test at Stark State College of Technology or Cuyahoga Community College completed in 4½ minutes or less
 - B. A background and reference check
 - C. The Plain Township Fire Department physical skill assessment
 - D. Written fire & EMS tests
 - E. EMS skills test
 - F. An oral interview

- 3. Provide a photocopy of a current State of Ohio EMT-Paramedic license.

- 5. Provide a photocopy of current CPR certification necessary to comply with Ohio Paramedic Certification.
- 6. Provide a current photocopy of Advanced Cardiac Life Support (ACLS) certification for Paramedics.
- 7. Provide a photocopy of ICS 100 and 200, and IS 700 Certifications from FEMA.

- 8. Provide a notarized copy of the Bureau of Criminal Investigation and Identification (BCI) basic background check with fingerprints.
- 9. Provide a notarized copy of a Stark State College of Technology or Cuyahoga Community College certificate for the firefighter physical ability test completed in 4½ minutes or less.
