# Anthem Expands Product Portfolio; Modifies Existing Products — Effective July 1

Anthem Blue Cross and Blue Shield continues to seek ways to deliver innovative product designs that actively engage members in health care decisions, while at the same time offering affordable health care products to meet members' needs and pocketbook. For more information about new *GROUP* products and changes/enhancements to our existing *group* product portfolio, refer to the sections below.

### **New Group Products**

#### Anthem KeyCare 20 Plus

Highlights: Effective July 1,2004, Anthem introduces the newest addition to our KeyCare Plus product line — Anthem KeyCare 20 Plus. The product requires a \$20 copayment per visit to a general or family practitioner, internist or pediatrician, and \$40 for all specialists. In keeping with our other Plus plans, Anthem KeyCare 20 Plus will also provide diagnostic laboratory services covered with no member copayment.

#### Anthem KeyCare Health Savings Accounts (HSA) Qualified High Deductible Health Plans

Highlights: Targeting fall 2004, Anthem will introduce our KeyCare HSA Qualified High Deductible Health Plans. These plans, in concert with a tax-advantaged health saving account, provide consumers an alternative method to pay for health care expenses and plan for retirement.

Anthem's KeyCare HSA Qualified High Deductible Health Plans offer the options below that include separate deductibles for individuals and families:

A contract-level deductible applies to HSA plans. This means that the entire family must satisfy the deductible before any claims are eligible for reimbursement. An individual deductible does NOT apply for contracts with more than one person enrolled. As part of the HSA plans, prescription drug coverage is available under the medical benefit portion and is subject to the contract deductible.

Routine wellness care and well baby care are included, subject to the contract deductible. A \$2,000 limit applies for physical therapy and occupational therapy. Vision care through Davis Vision requires a \$15 copayment.

#### **Product Changes**

Effective for groups enrolling or renewing on or after July 1, the following product changes apply:

### Tiered Radiology Copayments for Anthem HealthKeepers Products

Higher cost radiology services such as MRIs, MRAs and PET scans will now require a \$100 copayment from the member under most Anthem Health Keepers plans. All other diagnostic radiology services will retain their current primary care physician or specialist office copayment requirements.

#### Coverage for Morbid Obesity

All services related to morbid obesity will become a standard exclusion under Anthem's BlueCare and KeyCare group products, with coverage available through a rider. An optional rider is already available under our standard Health Keepers group products. Services related to obesity are currently excluded under all Anthem *group* products. Excluded services include any service billed with a primary diagnosis of obesity or morbid obesity.

Moving the coverage to an optional rider for our group products is in keeping with requests from the marketplace and is reflective of the industry in that most other health plan carriers already handle coverage for morbid obesity through a rider.

Anthem has developed "transition of care guidelines" for our members currently scheduled to have surgery or other services related to morbid obesity.

Members who have had the procedure pre-authorized prior to their groups' renewal date will have coverage for the surgery (including post-operative visits and complications directly related to the approved surgical procedure). The surgery must be performed within 60 days of the renewal date.

For example, a member's group renews on July 1, and the surgery is pre-authorized on June 17. Surgery must be performed by August 29.

# Coinsurance for Injectable Drugs for Anthem HealthKeepers Products

Anthem will now require members to pay a 20 percent coinsurance for most injectable drugs dispensed in physicians' offices under all Anthem HealthKeepers plans except for our essential and standard plans. Members are responsible for their office visit copayments, as appropriate. Allergy injections/serums and chemotherapy drugs are NOT subject to the coinsurance.

#### **Product Enhancements**

To simplify benefit processes for our members, Anthem will make the following enhancements effective July 1.

### Diabetic Supplies Covered Under Pharmacy Benefit

Anthem will cover diabetic supplies — syringes, lancets, test strips, home glucose blood monitors and needles for the administration of injectable insulin — under the pharmacy benefit of our KeyCare and BlueCare group products since many members purchase these supplies at pharmacies. Anthem will continue to cover insulin pumps as medical equipment since members obtain these items through a medical equipment supplier and not a pharmacy.

#### Copayment Changes for Physical, Occupational and Speech Therapy

The copayment for physical therapy, occupational therapy and speech therapy visits under the Anthem Health Keepers 15 plan will be reduced from \$35 per visit to \$25 to improve this benefit for our members.

# Anthem Removes Deductible from Tier 1 on Prescription Deductible Plans

For members enrolled in drug deductible plans, a deductible will no longer apply to Tier 1 drugs. As before, Anthem will apply a deductible on Tier 2 and 3 drugs. Members are still responsible for their normal drug copayments. Eliminating the deductible component from Tier 1 drugs may increase use of these lower-cost alternatives, as members play an active role in helping contain the costs of their drug coverage.

#### Legislative Changes

While the Virginia General Assembly convened in January 2004, no changes are required as a result of legislative mandates this year.

## Keep Your Provider Information Up-to-Date: Contact Provider Network Administration

Anthem's Provider Network Administration can help you with updating your records with Anthem and participating in our networks. Our provider records contain a number of Post Office Box numbers, Rural Route addresses and inactive addresses. We need your assistance to ensure that there is a CURRENT physical street AND mailing address on file for each provider.

Anthem also wants to ensure that you receive periodic updates about upcoming changes and improvements in a timely manner and our records reflect adequate, accurate information for our provider directories. Our Web-based applications include convenient mapping capabilities for members, and Anthem wants to make it easy for our members to find your office and for you to stay informed of changes.

#### Written Notification Required

Anthem requires WRITTEN notification — either by mail or fax — of any changes to your provider status including the effective date of any changes. Changes to provider status information cannot be taken by telephone. Please send written notification on your office's letterhead stationery to:

We will continue to send your payments to your financial address, as in the past.)
- Change name and address of the practice or facility you are either joining or leaving. (Please include a telephone number with area code.)
- Change legal name and/or new tax identification number.

#### **Updating Records**

To properly update your records on our files, Anthem will need:

- Your tax identification number and current Anthem-assigned, sixdigit provider number.
- A completed W-9 form if you are making changes that require one.
   For example, a W-9 form is required for a change in your legal name and/or a new tax identification number. (Please contact us if you need a W-9 form. We will send you a W-9 packet for you to complete.)

# Anthem Makes Change to PET Coverage Guidelines

Effective with dates of service June 1, 2004, there will be a change in the Positron Emission Tomography (PET) coverage guideline when CPT code 78608 (Brain imaging, PET-metabolic evaluation) and HCPC codes G0214 and G0215 (PET imaging whole body initial staging and restaging for colorectal cancer) will be eligible for coverage.

CPT code 78608 and the following diagnosis codes will be eligible for coverage only when they meet the criteria per the coverage guideline:

<b>1</b> 91.0-192.1	Malignant neoplasm of brain, cranial nerves, cerebral meninges
<b>1</b> 98.3	Secondary malignant neoplasm of brain and spinal cord
237.5	Neoplasm of uncertain behavior of brain and spinal cord

239.6 Neoplasm of unspecified nature, brain

V10.85 Personal history of malignant neoplasm of brain

To differentiate radiation necrosis from recurrent tumor in a patient with an intracranial lesion visible on CT or MRI who has previously been treated for a brain tumor.

**345.00-345.91** Epilepsy

Identification and/or localization of seizure foci in patients who are surgical candidates for intractable epilepsy.

G0214 and G0215 currently pay for the following diagnoses:

<b>1</b> 52.0-154.8	Malignant neoplasm; small intestine, colon, rectum, rectosigmoid junction and anus
<b>1</b> 59.0	Malignant neoplasm, intestinal tract, part unspecified
<b>1</b> 97.5	Secondary malignant neoplasm, large intestine and rectum
<b>1</b> 97.7	Secondary malignant neoplasm, liver, specified as secondary.

The above diagnoses will pend for review to ensure that they meet the following criteria:

- a) To detect and assess resectability of hepatic or extrahepatic metastases of colorectal cancer
- b) To detect recurrence of colorectal cancer in patients with rising CEA levels and/or in patients who present with signs and symptoms of recurrence
- c) To assess scarring vs. local bowel recurrence in patients with previous resected colorectal cancer.

These procedures will be denied as investigational when billed with any other diagnosis codes and/or when fails to meet the criteria.

# Coverage Guideline: Urinary Incontinence Therapy for Adults

Effective for dates of service on or after June 1, 2004, endoscopic injection of implant material to the submucosal tissues of the urethra and/or bladder neck (CPT 51715) must meet the following medical criteria for coverage:

- 1. One of the following indications:
  - A.) Stress urinary incontinence caused by intrinsic sphincter weakness OR
  - B.) Post-traumatic or post-surgical injury **OR**
  - C.) Urethral hypermobility in females with abdominal leak point less than 100 cm H20.

#### **AND**

2. Incontinence has not improved after at least 12 consecutive months of conventional therapy (exercise, medication).

#### Please Note:

When multiple injections are required, up to five (5) injections, a minimum of a week apart are covered. Beyond that is considered a treatment failure, and no further injections will be

Failure to meet the criteria will result in the procedure being denied investigational.

## Anthem Clarifies Billing of Medical Observation Beds

Following a review of claims for medical observation in the outpatient setting, it has come to our attention that there are variations in practices for these services. In order to clarify the correct billing process for observation in the outpatient setting, please ensure that you adhere to the following quidelines:

- Observation is correctly billed up to 23 hours.
- When your patient is treated and released in less than 23 hours, the outpatient place of treatment code (22) and the correct observation CPT code (99234, 99235, 99236) must be used.

If your patients require hospital care beyond the expected 23 hours, we will review the medical necessity of an inpatient stay. To obtain authorization for inpatient care, contact our Medical Management department tollfree at (800) 533-1120.

Effective June 1, 2004, unless medical management has approved your patient for an inpatient stay, the correct observation bed claim must be submitted. This applies to our HMO and PAR/PPO business.

### Correct Billing for Ambulatory Surgical Procedures

In most instances, ambulatory surgery can be safely and adequately managed in the outpatient setting according to Milliman Care Guidelines. Your post-surgical outpatients can remain in the hospital setting for observation for up to 23 hours without authorization. Observation services may take place anywhere in the facility deemed appropriate by the physician.

However, if your patients require hospital care beyond the expected 23 hours, we will review the medical necessity of an inpatient stay. To obtain authorization for inpatient care, contact our Medical Management department at (800) 533-1120.

## State Announces Health Plan Administrators Beginning July 1

Covered services under the Commonwealth of Virginia COVA Care plan and The Local Choice (TLC) Key Advantage, Cost Alliance, KeyShare and Value Alliance plans will remain the same. Deductibles, copayments and coinsurance amounts will be unchanged. However, there will be some important changes in the administration of COVA Care and TLC benefits.

There will be four separate plan administrators for the state's COVA Care plan starting July 1,2004, and for the TLC plans starting July 1 and Oct. 1,2004, depending on the group's renewal date. The four plan administrators presented below were selected by the state through an extensive procurement process. Members will receive four identification (ID) cards in mid-to-late June — one from each plan administrator. Members will be responsible for presenting the appropriate ID card when receiving health care services.

#### Questions About COVA and TLC Claims

Contact Anthem if you have questions about medical, dental, prescription drug, vision or hearing claims with dates of service prior to July 1,2004, and Oct. 1,2004, for some TLC groups. For dates of service on or after July 1, please contact the appropriate plan administrator listed in the table to address claim questions.

#### **Authorizations**

All admission and health services reviews (formerly pre-authorizations) in place from Anthem will continue for medical without change. Prescription drugs for which you have already received approval will continue until they expire. Effective July 1 (or October 1 for some TLC groups), new and renewal prescription drug requests must be sent directly to Medco Health.

# Fiscal Year Change: Deductibles and Out-of-Pocket Amounts

Please note the benefit year (time period when benefits are administered) will change from a calendar to a fiscal year of July 1 through June 30. With the transition to the new fiscal benefit year on July 1, members will NOT need to satisfy again deductibles or out-of-pocket (OOP) amounts met between January 1 and June 30, 2004. New deductibles and out-of-pocket limits will begin July 1, 2005.

#### **TLC Medicare Retirees**

TLC retirees enrolled in the Medicare Complementary and Advantage 65 plans will continue to have their dental benefits through Anthem, rather than Delta Dental. However, they will move to Medco Health for their prescription drug benefits at their group's renewal on July 1 or Oct. 1, 2004. Benefits for the Medicare retirees will continue to be administered on a calendar year, not a plan year.

#### State Medicare Retirees

This group renews Jan. 5, 2005. Until then, there are no changes to their current plan benefits or to the plan administrators.

## Alpha Natural Resources Enrolls With Anthem

The national account will have the alpha prefix "ANR."

# Anthem Makes Minor Changes to ID Cards for Prescription Drugs

Anthem will begin re-issuing ID cards for our members enrolled in PAR and PPO plans as groups renew their coverage. We made minor changes to the prescription drug headers on the ID card — with "Tier 1 Drug" replacing "Generic Drug" and "Tier 2/3 Drug" replacing "Brand Name Drug."

You may notice these minor changes on the ID cards of your patients with Anthem coverage. We also made changes to our HMO cards, making the cards easier to use.

Changes to Anthem ID cards do not reflect any changes in drug benefit coverage. Watch for the June edition of the Anthem Professional Forum for illustrations of the new ID cards.

# Partners in Drug Safety and Utilization: Anthem's Drug Review Forum

Anthem and our affiliated HMOs continue to evaluate drugs for their efficacy and safety advantages along with associated costs, as we work to help keep prescription drugs affordable and safe. To this end, Anthem actively involves community physicians to address drug trends, appropriate drug utilization and ways to improve patient drug safety via our drug review forum — an independent group of

review forum — an independent group of more than 200 physicians who offer feedback and recommendations via e-mail on Anthem's prescription drug guidelines.

To illustrate, Anthem recently requested feedback from forum members regarding the use of proton pump inhibitors or PPIs (Nexium, Prevacid, etc.). Anthem is seeking to improve appropriate utilization of PPIs by encouraging prescribing habits as defined by the U.S. Food and Drug Administration (FDA) and organizations such as the American College of Gastroenterology. The subsequent feedback has led to a program that helps members make more informed health care choices.
