INTERMEDIATE SPANISH: (24 hrs) TCLEOSE 2109 This course is a requirement for Intermediate PEACE OFFICER & JAILER Certification. This course is composed of seven units and is designed build upon the skills acquired during each unit. The jump-start unit is the main focus of this course. Within the jump-start unit are critical words and phrases that the student must completely master during this course. These phrases deal with safety and command and control during responses to a potentially dangerous incident. Employees should be able to detect and take the appropriate action when needed. Employees should be able to effectively communicate and interact with persons with mental disabilities. E-Training CIVILIAN TRAINING COMBATING COMMUNICABLE DISEASES: (8 hrs) TCLEOSE 3800 This course will familiarize civilian personnel with occupational exposure and contagious disease control, which is contained in Policy 4.09 of the Sheriff's Policy Manual. This class explains practices to follow that will protect employees and others against infections caused by contagious diseases. E-Training EFFECTIVE COMMUNICATIONS FOR LAW ENFORCEMENT: (8 hrs) TCLEOSE 3027 for Sergeants and Corporals only. Effective communication is an essential component of a supervisor's success whether it is at the interpersonal, intergroup, or dealing with the public in general. This course will cover the basic process of communication and then explore some of the more difficult communication issues that supervisors face by providing constructive and effective feedback and performance appraisal. Physical Fitness Requirements

** Some courses offered by the El Paso County Sheriff's Office Region VIII Training Academy will require a degree of physical fitness.

- Minimum Level- This level will consist of walking, stepping, and very light cardiovascular exercise.
- **Medium Level** This level will consist of Jogging, minimal levels of calisthenics i.e. push-ups, sit-ups, side straddle hop, beginning levels of hands on classes i.e. PPCT and O.C.
- **Maximum Level** This level will consist of running, sprinting, advanced calisthenics, advanced levels of hands on classes i.e. mobile field force, physical fitness exams.
- **Medium and maximum-** levels will require a blood pressure screening and students who do not pass will not be allowed to participate without a doctor's release on file.
