1. Purpose. To approve renaming of Commander, Carrier Air Wing Reserve (COMCARAIRWINGRES) TWO ZERO under the administrative command of the Chief of Naval Operations.

2. Background. To coordinate efforts of Naval Reserve Tactical Aviation (TACAIR) units supporting Navy mission requirements and as a result of the Active-Reserve Integration (ARI), COMCARAIRWINGRES TWO ZERO will be renamed Commander, Tactical Support Wing (COMTACSUPWING).

3. Organizational Changes. Effective 1 April 2007, rename COMCARAIRWINGRES 20. The following applies:
