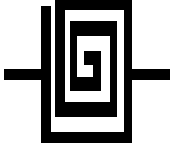
## Manager's Note, Paul S. Cahall, General Manager

### Changes to the Lake Waynoka Entry Gate

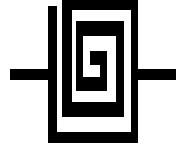
The way we all get in and out of Lake Waynoka will see a big change this year with the utilization of technology. This technology going forward will make it much easier for our members to access the lake, both front and back gate, while increasing access control and making annual renewal a short painless process. This system will reduce delays at the back gate and eliminate 99% of the operational issues we see today back there. This system is scheduled to go live on 1 May 2016, until then, the old style stickers will work as they always have. So here is what you need to know about the new process this year.

1. In order to get in the back gate and to use the right pass lane at the front gate you will to purchase a "Radio Frequency Identification Device" (RFID) sticker for your vehicle. This sticker will provide quick access at both the front and back gates without interaction from the security staff.
  - a. First year cost to purchase a new RFID sticker will be \$15. Next year a new RFID sticker will be \$20.
  - b. As long as you own that vehicle you will not have to purchase a new RFID sticker unless you damage the sticker or the windshield is replaced. If the sticker just stops working it will be replaced at no cost. Any attempt to remove the sticker will cause it to no longer work and you will have to buy a new one.
  - c. Members will be able to get a replacement sticker for a new car for the price of annual renewal as long as we turn off an old one for them.
  - d. You will be able to renew your sticker each year over the phone with admin, in person at the admin office or security by simply paying a \$10 renewal fee. You will no longer have to sit in line at security with your registration to get a new RFID sticker.
  - e. Boats and campers will still need to come in the front gate on the left side but once registered for the year we have a much more streamlined process for access the rest of the year. Boats and campers will be able to leave from the front or back gate without stopping because of the improved camera systems.
2. You can opt out of the RFID system if you like. Members will be issued a dated window sticker just like the past with no changes in fees or process on how you get one.
  - a. The old style sticker will **not** allow you to come in the back gate. The back gate will operate automatically with the RFID but security will no longer be able to let you in that way.
  - b. The old style stickers will be able to go out the back gate without issue.
  - c. When coming in the front gate with the old style sticker you will have to use the left lane so security can see your sticker and open the gate for you. If you go to the right hand lane security cannot open that gate for you because it requires the use of the RFID sticker.

There are bound to be bumps in the road this first year as there is with any new technology but in the long run access to the lake will become a much easier and secure process than it is today.

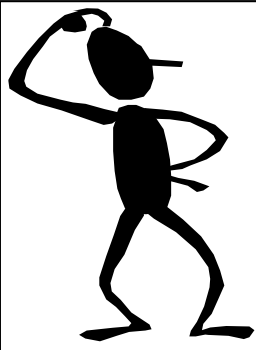

### WRWSD Board of Trustees Meeting – Mon., January 25, 2016

President Jim Bridges called the meeting to order at 7:00 p.m.

**Roll Call:** Present: Beard, Beresford, Bridges, Buskey, LaPlante, Purdin, Redick, Mgr. Cahall and Plant Supt. Culver.  
Absent: none

**Minutes:** A motion was made Purdin and seconded by Redick to approve the minutes of the January 9th Saturday meeting as distributed via email. A yea/nay vote was taken and the motion passed unanimously.

**President's Report** (Jim Bridges): none

**Treasurer's Report** (John Buskey):

- The 2016 calendar of WRWSD meeting dates was presented. After review Buskey moved and Beard seconded a motion to adopt the proposed calendar. (Please note that the dates of three workshop meetings were changed: The May meeting will be on the 23rd rather than the 30th because it is Memorial Day. The September meeting will be on the 19th to avoid conflict with the Brown County Fair Parade on the 26th. The December meeting will be on the 12th rather than the 26th during the Christmas holidays.) A yea/nay voice vote was taken and the motion passed unanimously.
- It was noted that the WPOA will now be paying its water bill monthly based on actual usage. The sewer bill will continue to be paid on an annual basis in April each year.
- Buskey reviewed the WRWSD's 2016 budget and its resources in detail with the Trustees.
- Buskey then requested that Manager Cahall and Plant Supt. Culver work on adding the fifth year to the WRWSD's five year long range capital plan. He also asked that they review the items for 2016 and make any anticipated changes. The plan can then be discussed during the February workshop meeting.

**Report from the Manager** (Paul Cahall) **and Plant Supt.** (George Culver):

- The up-land reservoir is full and the pumping has stopped.
- The staff continues to install water meters. There are less than 200 left to be installed.
- So far this season there have not been any major water leaks. The staff is using its new water leak locator/detector.

At 7:20 pm an Executive Session was called to discuss plant operations and personnel.

**Motions and Resolutions:** none

**Adjournment:** At 7:38 pm the Executive Session ended and a motion to adjourn the meeting was made by Purdin and seconded by Beresford. All were in favor and the meeting was adjourned.

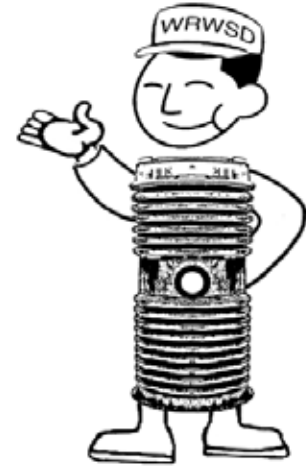

## WRWSD Board of Trustees Meeting – Sat., February 13, 2016

**Minutes:** A motion was made by Purdin and seconded by Redick to approve the minutes of the January 9th workshop meeting as read. A yea/nay vote was taken and the motion passed unanimously.

**President's Report:** none

**Treasurer's Report** (John Buskey):

- Everyone was encouraged to take a look at the WRWSD's January 2016 financial report.
- Buskey requested a motion to approve all of the financial reports from January 31st, 2016 as distributed. The motion was made by LaPlante and seconded by Beresford. A yea/nay voice vote was taken and the motion passed unanimously.
- The 2016 WRWSD calendar is now on the Lake Waynoka website.

**Manager's Report** (Paul Cahall): Cahall noted that the District does not have a lead problem of any kind in the water that it provides to its customers. However, since the concerns in Flint, Michigan have arisen, the EPA is now requiring that testing for lead be done annually rather than every three years as previously required. Cahall also recommended that homeowners, seasonal ones in particular, always 'flush' their water lines if their houses have not been occupied for any length of time. Open all faucets and allow the water to run for a few minutes to remove any 'standing' water in metal pipes.

Tom Sewell (Lot #4015): Sewell inquired as to why his WRWSD bill continues to show zero usage. Cahall explained that once the old meter on his property is replaced, the reading will begin to show usage from the time of the installation of a new meter.

**OHIO BOATERS SAFETY COURSE APRIL 2ND  
LAKE WAYNOKA LODGE**

The Waynoka WaterSports Club will be teaching an Ohio Boating Education Course at 8:00 am on Saturday, April 2nd at the Lake Waynoka Lodge. Cost of this course is \$5 and can be paid at the door. This course will consist of 8 hours of instruction in a certified class followed by an exam. **This year (2016) anybody younger than 34 years of age needs to pass a test certified by the State of Ohio before they can drive any type of boat powered by more than 10hp.**

This class and exam will fulfill the Ohio’s Boater Education requirement that went into effect in January of 2000 and is administered by the ODNR Division of Watercraft. **The law prohibits any person born on or after January 1, 1982, from operating a vessel powered by more than 10HP unless the person has successfully completed either a boating education course approved by the National Association of State Boating Law Administrator (NASBLA) or a proficiency examination approved by ODNR Division of Watercraft.**

You can pre-register for the class by calling ODNR Watercraft at **513-734-2730**. Be sure to reference the date and location for above class. This class is open for any age and not just for Lake Waynoka boaters.

During the month of January no crime patterns were identified. Crime and traffic activity was low across the geographic boundaries of Lake Waynoka.

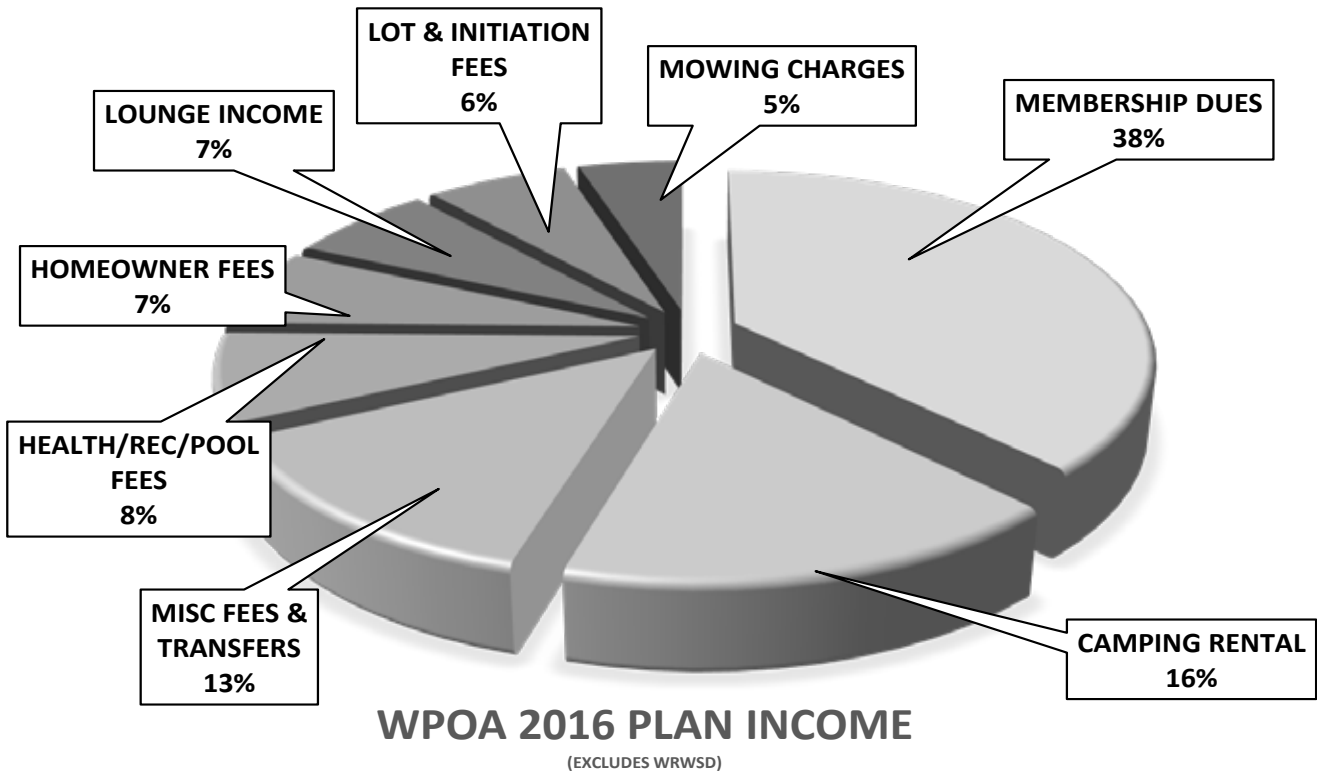

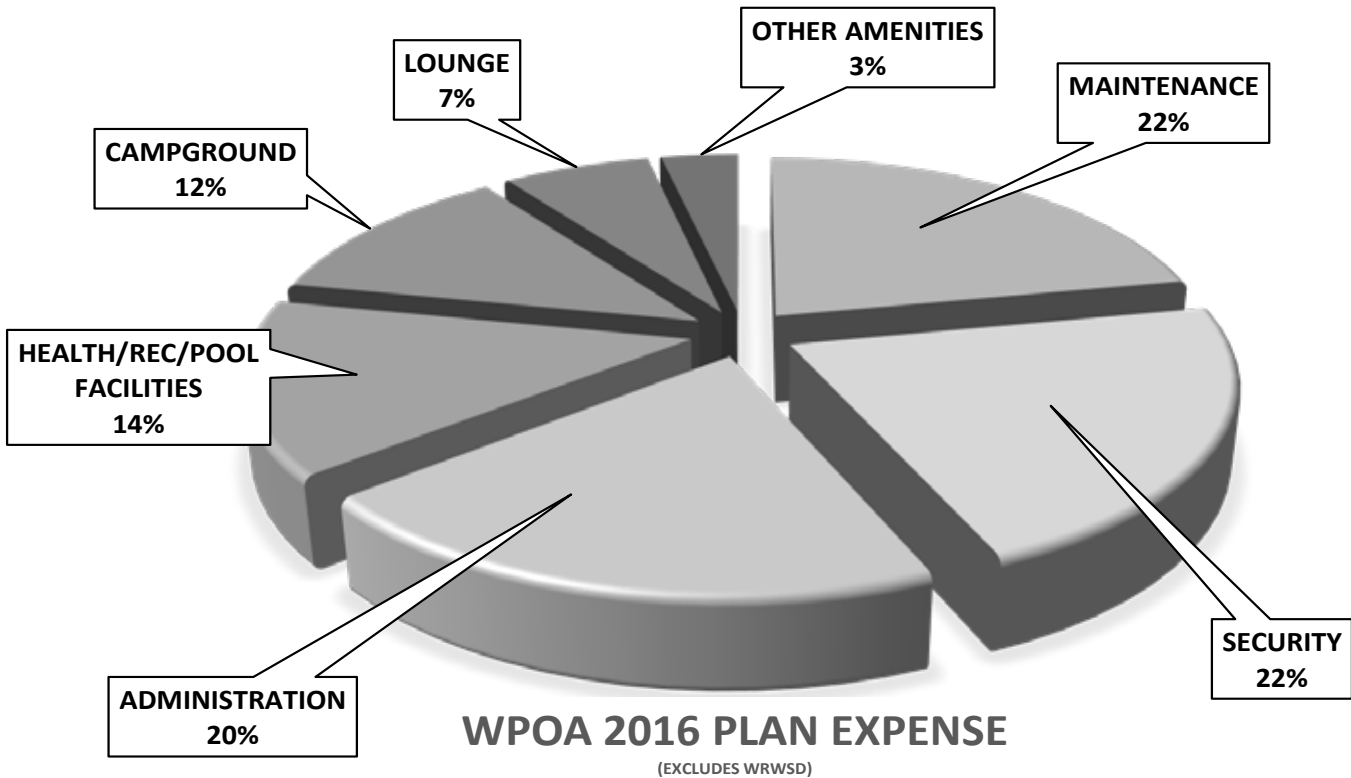

Long Range Plan Objectives are meant to reflect high-level, ongoing activities and strategies necessary to develop and manage our community over time, to achieve the Vision, and to reflect WPOA membership common desires and needs. Specific Board-approved projects derive from these Objectives.

### **Lake Waynoka Community Vision:**

Lake Waynoka Association (WPOA) members envision a gated lake community, with members working together to achieve a highly desirable quality of life and appreciating property values. We envision a neighborhood that is considered by all to be a desirable place in which to live or visit, share our varied recreational amenities, and enjoy the benefits of family and friends in an active member community.

### **LRPC Goals and Objectives:**

#### **Lake Protection and Conservation**

**(protection and conservation of the lake environment, dam, shoreline and public access areas and amenities therein)**

Maintain an effective dredging program to ensure acceptable navigability of the main lake and all coves.

Protect the lake shoreline against erosion by enforcing Rules on the rocking of all lakefront lots, including both private and WPOA-owned.

Properly maintain the condition of the dam, weir area and valve, including recommended regular inspections.

Establish and maintain an acceptable balance of fish population and the lake habitat while recognizing the other recreational needs and uses of the entire membership.

Properly maintain and develop all lake access areas, including amenities included therein.

Support the control of geese, beavers and any other invasive species of animals or plants which might affect the health of the lake and damage to property.

### **Security and Safety for People and Property (security and safety of members, guests, visitors and employees and their property)**

Develop a certified and equipped Lake Waynoka Ranger Department with each ranger providing both law enforcement and emergency medical technician services to enhance the safety and security of all Lake Waynoka residents and guests.

Increase security through the integrated use of gates, cameras, lighting, and other technological tools to limit unauthorized access and elevate identification capability by the security department thereby promoting a safe and secure environment within Lake Waynoka.

Review, modify, publish, and promote WPOA Code of Regulations, WPOA Rules and Regulations to ensure that all WPOA members and guests are aware of these governing documents that reduce conflict and increase enjoyment of facilities and amenities within Lake Waynoka.

Increase safe watercraft operation by enforcement of all State laws and WPOA rules to help avoid watercraft injuries and accidents to members and guests on Lake Waynoka waters.

### **Grounds Maintenance and Beautification (maintenance and improvements to community roads, grounds, signage, etc.)**

Maintain a consistent a “Branding” program, where practical, covering color, fonts and size for community signage. Expand and adopt the program to encompass the color and style for community shelters, toilets, buildings, vehicles, uniforms and etc.

Maintain emphasis on the program for getting rid of the abandoned boats and trailers. Improve enforcement of rules and regulations regarding property restrictions on abandoned boats, cars, unscreened propane tanks and “messy” yards.

Maintain all public area such as shelters, lake access locations and planting beds to minimum acceptable standards of appearance. Proactively support community clubs and organizations who might wish to further improve public area with labor and equipment support if requested.

Maintain all roadways in good condition and keep adjacent trees and bushes pruned and trimmed away from the right-of-way.

## **Administration and Operational Excellence**

**(adherence to best practices, recognition of employee value, member services),**

Identify, research and develop best practices in the areas of fiscal management, public relations, employee relations and other administrative functions using OLCA and other lake community resources.

Continue to identify and maintain an employee recognition and appreciation program.

Identify, develop, and appraise member services through periodic surveys and focus groups.

Continue developing organizational values and a work environment that promotes trust, respect, open communication and teamwork between all levels of staff, The WPOA Board, the association membership and neighboring communities.

Periodically review the community Rules and Regulations for appropriateness and effectiveness.

## **Financial Stability & Protection of Community and Member Assets**

**(conservative financial management, enforcement of community rules and zoning, support of community and member property values)**

Research ways to enhance membership value and implement those that are feasible. (Emphasize the perceived value of Waynoka membership and add value/benefits whenever and wherever possible.

Consistently communicate actions taken by the Board resulting from the Long range plan and membership surveys.

Consistently enforce the adopted Association Rules and communicate Board actions to membership.

Actively communicate financial information to the membership which clearly summarize operating and capital budgets, identifies budgeting for forecasted long-range future projects, and assesses the adequacy of financial surpluses and reserves necessary for the protection of association and member property values.

Monitor progress against long-range membership category growth targets necessary to meet the attained of the vision of Lake Waynoka as a desirable community.

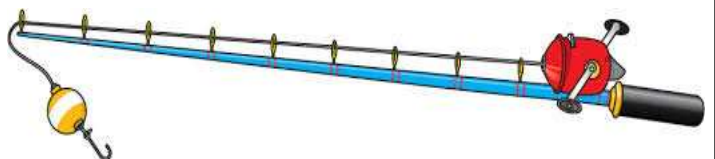

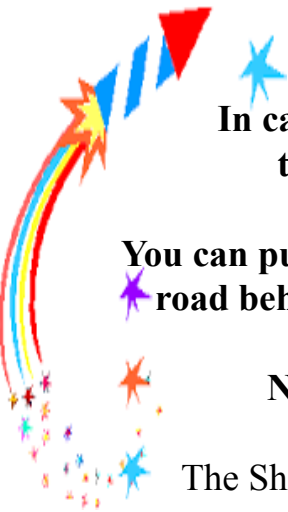

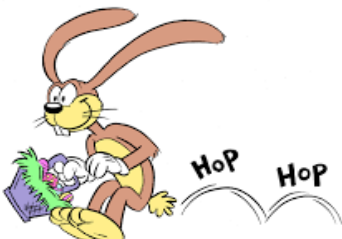
