This instruction implements AFPD 36-30, 2 August 1993, Military Entitlements; Department of Defense Directive 1338.5, Armed Forces Clothing Monetary Allowance Policy, 12 January 2005; Instruction 1338.18, Armed Forces Clothing Monetary Allowance Procedures, 7 January 1998; and Regulation 7000.14-R, Volume 7A, Financial Management Regulation (Department of Defense Military Pay and Allowances Entitlements Manual) February 1999. It provides information and responsibilities for the Air Force clothing programs. It addresses revised civilian clothing, initial issue, and supplemental clothing allowances and adds the Partial Initial Clothing Allowance. It lists the Active Duty, Guard and Reserve allowances and the changes made to the Supplemental Clothing Allowances. It applies to all active duty enlisted personnel and, when indicated to active duty officers and Air National Guard (ANG) and United States Air Force Reserve (AFRES) enlisted personnel (I 1338.18 paragraph B). Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with AFMAN 37-123 (will convert to AFMAN 33-363) Management of Records, and disposed of in accordance with the Air Force Records Distribution Schedule (RDS) located at https://afrims.amc.af.mil/. Refer recommended changes and questions about this publication to HQ AF/A1D using AF Form 847, Recommendation for Change of Publication; route AF Form 847s from the field through the appropriate functional's chain of command. Field activities must route all supplements and implementing guidance through HQ AF/A1D for coordination and approval prior to publishing. Attachment 1 lists abbreviations and acronyms used in this instruction.

This publication requires the collection and or maintenance of information protected by the privacy act (PA) of 1974. The authorities to collect and or maintain the records prescribed in this publication are Title 10 *United States Code*, Section 2107 and Executive Order 9397, *NUMBERING SYSTEM FOR FEDERAL ACCOUNTS RELATING TO INDIVIDUAL PERSONS*, November 22, 1943. System of records notice F023 AF IL C Personal Clothing and Equipment Record (June 11, 1997, 62 FR 31793) applies. Forms affected by the PA have an appropriate PA statement.

(AFISRA) This supplement provides guidance and procedures for issuing civilian clothing allowance (CCA) for Air Force Intelligence, Surveillance and Reconnaissance Agency (AF ISR Agency) personnel. It applies to AF ISR Agency (0U and 2L) coded units worldwide and AF ISR Agency-gained Air Force Reserve units. It does not apply to AF ISR Agency-gained Air National Guard units.

SUMMARY OF CHANGES

This document has been substantially revised and must be completely reviewed. Major changes include clarification of **Table A2.7.** and when Active duty Reserve personnel (serving on a statutory tour) and Air National Guard personnel serving a Title 10 (assigned to HQ ANGRC) statutory tour receive an annual clothing replacement allowance. It includes an increase to the "will not exceed" percentage for supplemental clothing allowance, clarifies officer entitlement to civilian clothing allowance, grants authority for an additional exception, and allows Military Training Leaders to receive supplemental clothing allow-ance. The physical training gear was added and quantity changes were made to various other initial issue items. The revision adds the requirement for records processing IAW AFMAN 37-123; standardizes paragraph numbering; establishes a venue for recommending changes; provides additional clarification of initial, supplemental and annual clothing replacement allowances; updates terminology; and contains other minor changes. We added the Airman Battle Uniform (ABU) in FY08 and noted deletion timeframe for BDU items. We added the cash allowance for purses and running shoes.

(AFISRA) This supplement updates primary office of responsibility, processing procedures and identifies the AF ISR Agency/A1 as the final approval authority for permanent duty Civilian Clothing Allowance (CCA). In addition it designates the Airman Development and Sustainment Division (AF ISR Agency/A1D) as the CCA program administrator.
