#### **SUMMARY**

Junior nominations for the month of June 2014 were received from:

 Cody Phillips (Rugby League) – On three consecutive occasions Cody scored 4 tries first week, 7 the next week and 8 on the third week, a total of 19 tries in three weeks.

Senior nominations for the month of June 2014 were received from:

 Zane Bray (Dragon Boating) – Zane is the first dragon boat paddler to achieve representative status from the Lithgow Flash Dragons Dragon Boat Club. Zane had to undergo a rigorous training and selection program to be awarded a position in the NSW State Regional Team open to all dragon boat paddlers outside the major metropolitan centers and competed for his position in the team against paddlers less than half his age. His selection is a testament to his dedication to the sport, his desire to prefect his paddling technique, his fitness regime and his ability to work in a team environment. As an integral part of the state team Zane achieved great success at the Australian Dragon Boat Titles with the team racing to win a gold, silver and bronze in the final series of 500 meter races and in doing so being awarded the Top Regional Dragon Boat Team in Australia. Not being content with the achievement Zane is presently training for selection in the Australian over 50 Dragon Boat Team.
