Keynote: What We Know about Dyslexia: Let's Stop Monkeying Around

Nancy Mather, Ph.D.

This session will focus on the fundamental facts we know about dyslexia, as well as the current issues that are confronting the field. Discussion will touch upon: the history of the field; the need for comprehensive assessments, including assessment of cognitive and linguistic processes; the importance of identifying strengths and weaknesses for selecting instructional interventions; the role of RTI and ability-achievement discrepancies in the identification process; the importance of using differentiated instructional methodologies; and the need for highly trained, competent reading teachers.

General Session: Raising Children with LD and ADHD: The Good, the Bad, and the Ugly

We are all familiar with the challenges of raising children who struggle in school. Through the use of pictures, work samples, and cartoons, the presenter will describe her particularly challenging journey. As parents we need, teacher support, hope, and a sense of humor.

Dr. Nancy Mather is a professor at the University of Arizona in Tucson in the Department of Special Education, Rehabilitation, and School Psychology. She has presented widely both nationally and internationally on assessment, instruction, and issues that affect service delivery for individuals with learning disabilities. She is co-author of the Woodcock-Johnson® III, as well as co-author of several books, including Learning Disabilities and Challenging Behavior; Woodcock-Johnson III: Reports, Recommendations, and Strategies; and Essentials of Dyslexia Assessment and Intervention.



Common Core Standards and Multi-Tiered Instruction: How Do These Impact Individuals with Dyslexia?

Barbara A. Wilson, M.Ed.

The Common Core State Standards (CCSS) for English Language Arts include foundational skills that assure early instruction in phonemic awareness and the alphabetic principle. The CCSS also states that students eligible under the Individuals with Disabilities Education Act (IDEA) must be challenged to excel within the general curriculum and be prepared for success in college, careers, and other post-school endeavors.

Barbara Wilson will review how the CCSS, combined with multi-tiered implementation models, may impact the successful instruction of individuals with dyslexia and contribute to early intervention for struggling readers. She will present information about key supports and accommodations and will explore proficiency requirements necessary for teachers to facilitate high student success.

Barbara A. Wilson, M.Ed. is director and co-founder of Wilson Language Training which provides teacher support and professional development for school districts and literacy organizations across the country. Barbara has served on the boards of several national educational organizations, consulted on NIH and US Department of Education reading research studies, and is a guest speaker on achieving literacy with struggling students at national and international conferences. Barbara is author of Wilson Reading System®, Wilson Fundations®, Wilson Fluency®, Wilson Just Words®, and several articles on literacy, most recently for *Multisensory Teaching of Basic Language Skills*, *Ed. 3*, Judith Birsch, Editor.
