## III. School Climate

## School Safety Plan (School Year 2011-12)

The school reviewed, revised and submitted to the Board in 11-12 an updated Safety Plan that included: school site safety programs, procedures for complying with school safety laws, and Disaster/Emergency/Crisis Response procedures. Our 2 school security officers and 1 school resource officer (Oakland Police Department) help us address any serious safety problems that arise on campus and ensure that the campus is secure to outsiders. School security officers and teachers provide before and after-school supervision on our campus. During school, the campus is closed. Students are not permitted to leave school, and all visitors are required to register before entering the premises. Administration works with the PTA and directly with community members to build positive relations and support with school neighbors in order to build a zone of safety around the school. Claremont's plan to promote school safety has 2 major strands: 1. Strategies that provide support to students and conflict prevention, and 2. Strategies that provide a progressive response to behaviors that undermine safety.

## IX. Student Performance

## Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

## Academic Performance Index
