Market hours are 5:30 to 8:30 p.m.

FEES:

Single stall fees for Certified Farmers are \$25 per market day or a Summer Seasonal Membership (all 7 weeks) for \$150.00.

Single stall fees for Non-Certified Food and Artisan Vendors are \$30 per market day or a Summer Seasonal Membership (all 7 weeks) for \$175.00.

To be considered for inclusion in the market's family of vendors and to avoid delays in the acceptance process, please review the list of required documentation below, complete the application and submit it to the Chamber office by Friday, May 8, 2015.

Note: Selling at the market is a weekly commitment for the 7-week market year. If accepted as a member, you agree to participate as a seller each week or be subject to actions as defined in the CCCFM rules and regulations.
