

HOMESTEAD REBATE:

It is not necessary for you to reapply for the Homestead rebate every year. The Homestead rebate only applies to the school tax.

PROPERTY TAX/RENT REBATE:

If you are 65 and older, widows or widowers age 50 and older, and people with disabilities age 18 and older, you may be eligible for the Pennsylvania Property Tax or Rent Rebate Program. For more information you can visit their website at <u>www.revenue.state.pa.us</u>,

ESCROW:

It is the homeowner's responsibility to forward the tax bill to their mortgage company for payment if they escrow their taxes. Please make a copy to keep for your records.

TAX PAYMENTS MAY BE PAID:

• When you pay with cash, please bring the entire bill with you in order for you to get a paid receipt. You must pay with exact change.

SMOKING SAFETY

If you smoke, use only fire-safe cigarettes.

If you smoke, smoke outside. Most deaths result from fires that started in living rooms, family rooms and dens or in bedrooms.

Keep cigarettes, lighters, matches, and other smoking materials up high out of the reach of children, in a locked cabinet.

<u>PUT IT OUT!</u>

Use a deep, sturdy ashtray.

Do not discard cigarettes in vegetation such as mulch, potted plants or landscaping, peat moss, dried grasses, leaves or other things that could ignite easily.

FIRE CHIEF ROBERT McCOY OFFERSTHE FOLLOWING "CHILDREN AND FIRE SAFETY TIPS":

Children playing with fire cause hundreds of deaths and injuries each year. Preschoolers and kindergartners are most likely to start these fires, typically by playing with matches and lighters, and are most likely to die in them.

- Store matches and lighters out of children's reach and sight, up high, preferably in a locked cabinet.
- Never use lighters or matches as a source of amusement for children; they may imitate you.
- If your child expresses curiosity about fire or has been playing with fire, calmly but firmly explain that matches and lighters are tools for adults only.
- Use only lighters designed with child-resistant features. Remember child-resistant does not mean child proof.
- Teach young children and school-age children to tell an adult if they see matches or lighters.
- Never leave matches or lighters in a bedroom or any place where children may go without supervision.
- If you suspect your child is intentionally setting fires or unduly fascinated with fire, get help. Your local fire department, school, or community counseling agency can put you in touch with trained experts.

FOURTH OF JULY



York Area United Fire and Rescue reminds our residents that fireworks during the Fourth of July are as American as apple-pie, but did you know that more fires are reported on that day than on any other day of the year in the United States? Nearly half of these fires are caused by fireworks. The good news is you can enjoy your holiday and the fireworks, with just a few simple safety tips:

- FACT: Each July Fourth, thousands of people, most often children and teens, are injured while using consumer fireworks.
- **FACT:** The risk of fireworks injury is more than twice as high for children ages 10–14 as for the general population.

PROCEED WITH CAUTION!

- Leave fireworks to the professionals. Do not use consumer fireworks.
- The safest way to enjoy fireworks is to attend a public display conducted by trained professionals.
- After the firework display, children should never pick up fireworks that may be left over, they may still be active.

How HOT does a sparkler burn?

Consumer fireworks include sparklers and firecrackers. The tip of a sparkler burns at a temperature of more than **1,200 degrees Fahrenheit,** which is hot enough to cause third-degree burns.

CAR FIRE SAFETY



Cars can catch fire for many reasons. Mechanical or electrical issues are the most common cause. A car can also catch fire as the result of a bad crash. If you see smoke or flames or smell burning rubber or plastic, respond immediately. www.nfpa.org/education

What to do if your car is on fire

- Pull over as quickly as it is safe to do so, be sure to use your signal as you make your way to a safe location off the road such as the breakdown lane or rest stop.
- Once you have stopped, TURN OFF the engine.
- GET everyone out of the car. Never return to a burning car for anything.
- MOVE at least 100 feet from the burning car and well away from traffic.
- CALL 9-1-1.

How to prevent a car fire

- Have your car serviced regularly by a professionally trained mechanic. If you spot leaks, your car is not running properly, get it checked. A well-maintained car is less likely to have a fire.
- If you must transport gasoline, transport only a small amount in a certified gas can that is sealed. Keep a window open for ventilation.
- Gas cans and propane cylinders should never be transported in the passenger compartment.
- Never park a car where flammables, such as grass, are touching the catalytic converter.
- Drive safely to avoid an accident.

Know the danger signs

- Cracked or loose wiring or electrical problems, including a fuse that blows more than once
- Oil or fluid leaks
- Oil cap not on securely
- Rapid changes in fuel or fluid level, or engine temperature

ZONING/PERMIT DEPT.

RAIN BARRELS

Spring Garden Township administers and implements the MS4 (Municipal Separate Storm Sewer System) program and best management practices in accord with the EPA (Environmental Protection Agency) and DEP (Pennsylvania Department of Environmental Protection) requirements. If you have any questions or concerns about storm water activity, do not hesitate to contact the Township Administration Office.

You can help reduce storm water pollution - consider installing a rain barrel ...



Rain by nature is important for replenishing drinking water supplies, recreation, and healthy wildlife habitats. It only becomes a problem when pollutants from our activities like car maintenance, lawn care and dog walking are left on the ground for rain to wash away. Here are some of the most important ways to prevent storm water pollution:

- Properly dispose of hazardous substances such as used oil, cleaning supplies and paint – never pour them down any part of the storm sewer system and report anyone who does.
- Use pesticides, fertilizers, and herbicides properly and efficiently to prevent excess runoff.
- Look for signs of soil and other pollutants, such as debris and chemicals, leaving construction sites in storm water runoff or tracked into roads by construction vehicles. Report poorly managed construction sites that could impact storm water runoff to Spring Garden Township.
- Install innovative storm water practices on residential property, such as rain barrels or rain gardens, that capture storm water and keep it on site instead of letting it drain away into the storm sewer system.

- Report any discharges from storm water outfalls during times of dry weather a sign that there could be a problem with the storm sewer system.
- Pick up after pets and dispose of their waste properly. No matter where pets make a mess – in a back yard or at the park – storm water runoff can carry pet waste from the land to the storm sewer system to a stream.
- Store materials that could pollute storm water indoors and use containers for outdoor storage that do not ruse or lease to eliminate exposure of materials to storm water.

POOLS

All Pools, Permanent or Temporary require a permit in Spring Garden Township as required by the 2009 International Residential Building Code (2009 I.R.C.) <u>These regulations also apply</u> to inflatable pools.

Any pool that can hold 24 inches of water or more requires a building permit. Temporary pools (as shown in the picture), tend to be collapsed and put away every year at the end of summer. These pools will require an **additional permit every year** when the pool is set up again.

ZONING/PERMIT DEPT.

PLEASE REMEMBER DUMPSTER PERMITS ARE REQUIRED

In an effort to regulate the placement of dumpsters and other roll off units, Spring Garden Township has enacted an ordinance that regulates dumpsters and temporary portable storage units (PODS).

Permit Process: No person shall place upon a street or property located in the Township, a temporary portable storage unit or dumpster without first obtaining a permit from the Zoning Officer. A permit application must be accompanied by a nonrefundable fee of \$100. Permit applications are available at the Township Administration Office, 558 South Ogontz Street.

Permit Issuance: The Zoning Officer shall only issue a permit if the application and proposed temporary portable storage unit or dumpster satisfies the requirements. The effective date of the permit shall be the date it is issued by the Zoning Officer. No property located in the Township shall be subject to more than three dumpster and temporary portable storage unit permits per year. Unless an extension is granted, at least 30 days shall elapse between the grant of a subsequent permit. A permit shall be placed in plain view on the property containing the temporary portable storage unit or dumpster.

Duration: A temporary portable storage unit permit shall be valid for 21 days. A dumpster permit shall be valid for 30 days.

Number: No more than one temporary portable storage unit shall be located on a property at a time. No more than two dumpsters shall be located on a property at a time.





BUILDING PERMITS REQUIRED:

The Township appreciates any and all efforts to make improvements to your property; however, always call the Administration Office before starting a project to check if a building permit is required. Painting, flooring, siding, and landscaping are exempt from building permits.

The path your permit application takes depends on the project involved. Certain home improvements require submission of plans to be approved by Commonwealth Code Inspection Service, Inc. and will require inspections during phases of the project, as well as a final inspection. UCC information can be found at

www.codeservices.net.

Permits needing review from Commonwealth Code Inspection Service, Inc. (CCIS) still need to be submitted to the Township to be forwarded on for approval. When the plans are approved, they will be returned to the Township for a Building Permit to be issued. You will be notified when the permit is ready to be picked up and the fees that need to be paid.

All commercial/industrial plans will be submitted to CCIS for approval and inspections.

A permit that needs CCIS review and approval may take several weeks to complete the process. Permits being approved at the Township Office will be prepared in a few days. Please allow sufficient time for permit approval before scheduling your contractor to start the project.

Per Pennsylvania law, contractors are required to provide a proof of workers compensation insurance certificate, or sign a waiver.

Administrative Code Clerk RENTAL PROPERTIES MAINTENANCE AND HOUSING

The applications for the Spring Garden Township residential rental units were mailed to property owners on December 7, 2015. The license fee for each residential rental unit it \$145.00 payable to Spring Garden Township by January 31, 2016. An application and license fee is required for each residential rental unit. The Township accepts payment of cash, check, money order and Master Card, Visa and Discover credit cards. There is a 2.45% convenient fee paid by the property owner if any credit card is used. Payment by credit card must be done at the Township Office. The license certificate is valid from January I to December 31, 2016.

OCCUPANCY ORDINANCE

If the Township Code Enforcement Officer / Inspector did not inspect the rental unit during the calendar year 2015, please contact the Township office to schedule a date and time for your bi-annual inspection once the application and license fee have been submitted to the township office.

As a reminder, if the tenant changes, a Tenant Change Application needs to be completed and provided to the Township Office along with a fee of \$80.00 for a new tenant inspection.

DOGS

No dog owner shall be permitted to create a condition involving a dog or dogs that shall be offensive, bothersome or annoying to the public, nor shall any persons create a condition that is



unhealthy or dangerous to any member of the public. It is unlawful for a dog owner to permit the accumulation of animal excretion in a pen, enclosed area or at any place in the township where accumulation creates a threat to the health of any



member of the township or the odor therefrom pollutes the air inhaled by any neighbor or resident of the township.


GRASS AND WEEDS

The Township receives numerous complaints each year about properties where the grass and weeds are long. To ensure the beauty of your neighborhood, please cut the grass and remove the trimmings. This will keep all properties looking nice and reduce the number of complaints. The ordinance states, all premises and exterior property shall be maintained free from weeds or plant growth in excess of six (6) inches. This includes any flowerbeds.

MOSQUITOES WEST NILE VIRUS

All residents, businesses, developers, farmers and municipalities need to be responsible and clean up to help eliminate mosquitoes. Please inspect your property for sources of stagnant water that can collect in tarps, tires, buckets, construction debris, trash, pools, plastic toys, gutters, watering troughs and birdbaths. Eliminating these sources of stagnant water is the best method to reduce mosquito populations that can transmit West Nile virus. Additional sources for breeding mosquitoes can be rain barrels and ornamental ponds. Rain barrels need to be completely screened. Ornamental ponds and fountains need to be stocked with fish or treated with a bacterial larvicide available at most hardware stores.

- Sump pumps are not to be pumped into the sewer system. We pay by the gallon to York City and Springettsbury Township.
- 4. Also, keep your fresh air vent opened for your sewer to breathe.

Reminder for property owners that received notice in regards to their curb and sidewalks, all work must be completed by July 1, 2016 if your street is listed to be paved in 2016. Highway Crew will do base repairs to roadways and crack sealing throughout the Township.

All projects consist of milling streets before actual paving can begin. All residents on these particular streets will receive a door knocker letting them know when work will begin. When paving starts, we will also put another door knocker on the door of all residents. These door knockers are placed one day before the actual paving will start. They will list time of day streets will closed and a rain-date. Once blacktop is complete and barricades are removed, the street will be open for use. Streets will normally be closed for five hours. 

SNOW SHOVELING TIPS


After a snowstorm, how many times have you shoveled your driveway only to have it plowed in?

Spring Garden Township offers some tips on shoveling your driveway to avoid being plowed in.

Clear an area to the right of your driveway (as seen in the diagram below) to give the snow on the blade of the plow a place to empty before it gets to your driveway. This way you will not have to do the same job twice.

Eliminate snow piles at the end of the driveway. High accumulations of snow can obstruct the vision of motorists, posing a safety hazard.

Spring Garden Township also reminds you that it is illegal to push snow from a parking lot or driveway onto a state highway.



THINK BEFORE YOU WASH

Preservation of the environment is a major topic in the world today, especially as it relates to automobiles. Have you considered that these topics can also be applied to the seemingly simple task of washing your vehicle? Spring Garden Township, as a MS-4 (Municipal Separate Storm Sewer System) municipality, would like to help outline the best and most eco-friendly way to keep your vehicle shining like new.

Today, the "greenest" way to wash your car is to take it to an automatic car wash. Studies show that an automatic car wash uses roughly half the water the average person would use while washing with a traditional bucket and hose. Regulations are also in place that require commercial carwash systems to contain and collect the dirty water used during a wash cycle. This waste water is then cleaned and, in many cases, reused.



It can be argued that the most effective way to shine up your vehicle remains to be hand washing but it can be far from environmentally friendly. The main reasons for this are the excessive use of water and the release of harmful substances such as soap residue, oil, acid and metal particles into the storm sewer system while washing and rinsing. If you do plan to wash at home, your first step is to get automotive soap and cleaners that are biodegradable and nontoxic. Secondly, avoid washing on the pavement, which will let the wash water directly into a storm sewer. Storm sewers drain directly to streams or lakes and carry pollutants with them to these waters. Washing over grass or gravel that will absorb the water into the ground to reduce or eliminate the environmental impact is best.

TOWNSHIP COMPLIANCE WITH MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT (PAG-13) FOR DISCHARGES FROM SMALL MUNICIPAL SEPARATE STORM SEWER SYSTEMS (MS4S)

Spring Garden Township is the owner of a municipal separate storm sewer system (MS4) that discharges to surface waters of the Commonwealth of Pennsylvania. Therefore, the Pennsylvania Department of Environmental Protection (PA-DEP) requires that the Township obtain and comply with the requirements of a NPDES General Permit (PAP-13).

In June, Spring Garden Township submitted a MS4 Annual Report Form which outlined the Township's efforts to comply with the NPDES GP-13 requirements from April 1, 2014 through March 31, 2015. The Township follows the PA-DEP's 6 Minimum Control Measure (MCMs) protocols which include:

- Public Education and Outreach of Storm Water Impacts
- Public Involvement/Participation
- Illicit Discharge Detection and Elimination
- Construction Site Storm Water Runoff Control
- Post-Construction Storm Water Management in New Development and Redevelopment
- Pollution Prevention/ Good Housekeeping for Municipal Operations

The Township has adopted and enforces a Stormwater Management Ordinance. All stormwater management plans are required to have engineering review and approval before approval of all new developments.

Spring Garden Township and the York County Conservation District have a Memorandum of Understanding (MOU) for review and enforcement of erosions and sediment control measures. **If you think you have observed an erosion or sediment problem from any construction site, please call 717-841-7430, the York County Conservation District.** The District will investigate these issues for the Township and enforce the regulations as applicable.

If you have any other type of stormwater problem or concern, please call the Township Office at

717-848-2858 to have it investigated. You will be required to provide your name, address, telephone number where you can be contacted, along with the specific location and description of the problem.

FACTS

Some people assume baby wipes, sanitary napkins and other household items are gone forever, once they have been flushed. The truth is they're not. Items such as these, after time, turn into a grayish pulp that can wrap around a pump. Each occurrence requires a two-person crew two hours to accomplish. Often crews are called out after hours to clear the pipes. These are additional costs that impact all customers.

DISPOSAL TIPS

A lot of products have a recommended method of disposal listed right on the package. If you are ever unsure if an item is safe to dispose of in the drain or toilet call us (717) 848-2858 or just throw it in the garbage can.

Many car centers or garages in the area will take your used motor oil. Contact your local garage or car center and ask them if they recycle the used motor oil and any instructions on how to prepare it and when to bring it to them.

Repair leaky plumbing fixtures. A leaky toilet can waste up to 2,000 gallons of water in a single day.

OUTSIDE THE HOME

DON'T dig without knowing the location of your sewer system.

DON'T connect rain gutters, storm drains, or sump pumps to the sewer system.

DON'T dump RV waste into your sewer collection system. Take it to an authorized RV dump site.

NEW YARD WASTE DROP OFF SERVICE

Spring Garden Township will open the property at 1799 Mt. Rose Avenue, former site of the United Dye Works, on the first Saturday of each month to accept tree limbs and other yard waste materials. Public Works staff will be on-site to assist with unloading of materials.

- Follow signs to the drop off area when entering the site.
- Tree limbs must be limited to eight inches in diameter or less and cannot exceed eight feet in length.
- Residents are asked to limit the number of drop offs to two truck or trailer loads.

DATES AND TIMES

The property will be open starting on the first Saturday in March 2016, weather permitting. The hours of operation are from 8 a. m. to 12 p. m.

OTHER OPTIONS FOR YARD WASTE

Curbside collections for recycling of yard waste for Spring Garden Township residents are held on the **fourth (4th) Saturday** of each month from **April through October** for the 2016 calendar year. Yard waste is material such as tree trimmings, shrubbery, and other organic landscape vegetation. **Exceptions** would include grass clippings, fruits and vegetables, leaf waste, dirt and stones. (Do not place any of these items out for yard waste collection.)

Please prepare your yard waste properly.

Yard waste in plastic bags **will not** be collected.

- Place yard in biodegradable brown paper bags or bundle it with biodegradable twine in easy to handle bundles. (Bags can be purchased at most home centers. i.e. Lowes, Ace, Home Depot, and Walmart.)
- Bundles may be no longer than for feet (4') in length.
- Bundles may not weigh more than 30 lbs. each.
- Branches may not exceed six inches (6") in diameter.
- Once prepared, yard waste must be placed at the curb on the scheduled pickup date before 7:00 a.m.
- An unlimited number of bags or bundles may be placed at the curb for these special collection days.

MIDDLE CREEK BUS TRIP:

Middle Creek in late February and early March harbors snow geese in numbers that rival the continent's population only 30 years ago. With a force only nature could provide, tens of thousands of snow geese rise



from the waters off Willow Point at the Pennsylvania Game Commission's Middle Creek Wildlife Management Area in follow-the-leader formations that make more sense to watchers the further the geese get from the water. Amid the chaotic liftoff, though, there is calmness among the participants, almost to a bird. This is casual for them. Life as they know it, sort of like heading to work in Manhattan every morning.

Coming to Middle Creek when large numbers of snow geese and tundra swans are staging there to push further north in spring migration is an adventure you won't forget. You'll see nature unbound, in your face and percolating with spontaneity.

Please bring appropriate clothes for walking and being outside. If you want, bring binoculars and a bird guide. Observed holidays are noted in RED. Collection days that fall on or after the holiday will be delayed one day. EXCEPTION: If holiday falls on a Saturday or Sunday, there is no change in service prior to or after the holiday.

BASIC RESIDENTIAL GUIDELINES

- Trash, Recycling, one bulk item and yard waste (see calendar above for scheduled dates) must be curb side by 7:00 AM on your scheduled collection day.
 No more than four (4) trash cans/bags will be collected each week unless using an Extra Service Bag.
 - Extra Service Bags are available at the Township Office for \$5.00 each.
 - Bags or containers must not exceed 32 gallons or 50 pounds.
 - Bulk items that are too heavy to be lifted into a truck by two people will not be accepted.
 - Call Penn Waste to schedule collection of appliances containing freon (air conditioners, refrigerators, freezers, etc.)
 - No construction debris will be collected curb side.

2016 RESIDENTIAL TRASH AND COLLECTIONS

The regular trash collection schedules remain the same with the exception of holiday pickups and additional Yard Waste pickups. Please read below for the 2016 information.

WARD 2, WARD 4 AND WARD 3 (WEST OF S. QUEEN ST.)

TRASH: Up to four (4) 32 gallon size bags/cans, picked up on Monday and Thursday.

RECYCLING: Picked up on Monday.

One (I) Large item is picked up on Thursday.

WARD I, WARD 5 AND WARD 3 (EAST OF S. QUEEN ST.)

TRASH: Up to four (4) 32 gallon size bags/cans, picked up on Tuesday and Friday.

RECYCLING: Picked up on Tuesday.

One (I) Large item is picked up on Friday.

You may place your items out for pick up after 8 p.m. on the evening prior to pick up day. Please remember to take your empty cans and recycling bins back in as soon as possible after each pick up. No full or empty containers can remain at the curb between your pickup schedules.

There is a 50lb. weight limit for regular trash. Dirt, stones, bricks, cement or construction debris of any kind will not be picked up by our contract hauler.



RECYCLING BINS

Thirty two gallon recycling bins are available at the Township Administration Office, 558 S Ogontz Street, for any residents who have not received one. As in the past the bins are Township property and must remain at the address they are assigned. The staff recommends that you put your address on the bins with a permanent ink marker.



WHERE RECYCLED ITEMS END UP

Here are eight things to know:

- Magazines are recycled into newspapers, telephone directories and paperboard.
- Paperboard, mixed paper and junk mail are paper towel rolls, new paperboard and the paper backing on roof shingles.
- Cardboard is recycled into paper bags, new paperboard and new cardboard.
- Notebook and computer paper are recycled into toilet paper, facial tissue and new notebook paper.
- Steel and tin cans are recycled into bicycle parts, rebar and appliances.
- Glass is recycled into new bottles and jars and sand used in road construction.
- Plastics are recycled into outdoor play equipment, backpacks and insulation for jackets.
- Orange juice and milk cartons are recycled into tissues, paper towels and computer paper.

RECYCLE USED MOTOR OIL

Pour all collected used motor oil into a clean, empty sealable container such as plastic milk jugs. Specialized used oil containers can be purchased at local auto parts stores. Do not mix used motor oil with any other substances, such as antifreeze, paint or other chemicals. It is a good idea to call ahead to confirm the hours of operation and to be sure that the site still accepts used oil. At the collection site, ask an attendant where to deposit used oil. Don't leave your container of used oil at the site if unattended. Take your empty container home with you to use again. The following retail establishments will accept used motor oil for recycling:

HELP ELIMINATE LITTER AND ILLEGAL DUMPSITES

Spring Garden Township residents can help our community celebrate Earth Day every day of the year. Residents, organizations, civic groups, schools and neighborhoods that want to clean up litter or eliminate illegal dumpsites, can dispose of waste from a clean-up effort free of charge at the York County Resource Recovery Center. The Authority is working with Keep York County Beautiful to stop illegal dumping in our community and

clean up existing dumpsites. If you are looking for a site to help clean up call Tom Smith at Keep York County Beautiful at 717-840-2375, or email him at tls35@psu.edu. Keep York County Beautiful will assist with providing free gloves, bags and safety vests. WHAT TO DO WITH MEDICAL NEEDLES

If you take shots at home for a medical condition and must dispose of needles, we recommend that they be placed in a glass or very heavy plastic bottle with a secure cap and put in the trash. If you are a small medical office or dental office that uses a residential trash pick-up service **you are required** to dispose of needles and other medical waste through a medical and infectious waste removal company.



DISPOSAL OF PAINT AND PAINT CANS



You may dispose of oil/latex liquid paint in the regular trash. If there is wet paint in the cans, pour it out on old newspaper and let it dry. Dispose of the newspaper in the regular trash. Another way to dry up paint in old cans is to add either oil dry or cat litter to the container. This must then be placed in the regular trash. Empty paint cans may be recycled. Empty spray paint cans are recyclable also. Full paint cans cannot be recycled. If you must place a can with wet paint in the trash, please make sure the lid is on tight and secured and in a heavy plastic bag so that it does not break open and splatter paint on the trash hauler, the street, a car or property nearby.

DISPOSAL OF COOKING OILS

Cooking oils, shortenings and cooking grease should not be washed down the drain! These materials can clog and block sewer lines. The correct way to dispose of cooking oils, etc. is to place them in a secure can or suitable container with a lid. It's okay to place recycling cans or bottles in the trash if they are being used to dispose oils or grease.

DISPOSAL OF COMPACT FLUORESCENT LIGHT BULBS

Although Spring Garden Township has no outlet for recycling these bulbs, we would like to inform our residents that you may take these bulbs to the York Home Depot or Lowes for recycling. Also, Sylvania provides consumers with pre-labeled recycling kits to recycle small and large quantities of CFL's and other light bulbs. You may find further information on their web site at www.sylvania.com/ recycle.



RECYCLING ENFORCEMENT FOR LARGE COMMERCIAL ESTABLISHMENTS, **INSTITUTIONS & GOVERNMENT BUILDINGS**

All establishments are required by State and Local laws to be in compliance with recycling requirements (this applies to all offices, restaurants, grocery stores, retail shops, service shops, schools, hospitals, churches, civic groups, banks and any other establishment that does not fit into the residential category.) Due to the larger volume of waste, more than four (4) 32 gallon size containers, you must privately contract for disposal of your waste and recycling, You are required to separate your recycling from your waste!

Items required to be recycled are:

- Corrugated cardboard
- High-grade office paper (including white computer paper, copier paper, letterhead, manila file folders and similar white office paper. Please note that shredded paper must still be recycled.
- Aluminum, steel and bimetallic cans
- Glass (clear and colored)

Note: Incineration of materials is not recycling! The mandated items listed above must be "recycled" in a manner so the material can be used again for making new products. If you are not already recycling, you must make arrangements with a recycling hauler! No business or residence is too small. Items cannot be taken out of the township for recycling. Most times, the company you're paying to collect your trash can provide a way to collect your recycles.

All Establishments Must Report Each Year! In the last quarter of every year, Spring Garden Township will mail each business/establishment or institution a report that MUST BE COMPLETED and returned to the Township. The report asks you to fill out your information, identify the types of materials recycled at your location and the name(s) of your private contractor(s). We will then contact these haulers and ask them to supply us with amount of materials you recycled. If they are unwilling to provide this data directly to us, we will contact you, and it will become your responsibility to obtain the data and report it to us.

Fines and penalties for violations of our recycling ordinance is established for those who do not recycle or fail to report to the Township from \$25 or more up to \$600 plus costs and, in default of payment of said fine and costs, to a term of imprisonment not to exceed 30 days per violation may be assessed for non-compliance. Each day that a violation continues or each violation constitutes a separate offense.

DISPOSAL OF AUTOMOBILE TIRES

Automobile tires can be placed out with the regular trash, but must be off the rims. Each tire is considered as one bag of trash. You may place the rims out for large item pickup.





DISPOSAL OF LAWNMOWERS, LEAF BLOWERS, GAS TRIMMERS & OLD PORTABLE GRILLS

These items can be placed out for pickup as a large item. They must be empty of all oil, grease and gas.
