

# GREENWOOD VILLAGE MUNICIPAL ELECTION NOMINATION PETITION

### INFORMATION

This petition is for the purpose nominating candidates for the position of Mayor or Councilmember. City of Greenwood Village elections are non-partisan. Eight Councilmembers (two from each district) will be elected and will hold office for a term of two years. One Mayor will be elected and will hold officer for a term of four years. Their terms of office shall begin at 7:00 p.m. of the first Monday after his or her election and shall continue until the first Monday after his or her successor has been elected.

Nomination Petition forms will be made available to all Candidates on (Insert Date).

### REQUIREMENTS FOR OFFICE

A Candidate for City Council must:

- Be a registered elector
- Have resided in his/her District for one year immediately preceding the election
- Have submitted a nomination petition for Councilmember of his/her district signed by at least 20 registered electors from such district
- File a completed Candidate Affidavit

A Candidate for Mayor must:

- Be a registered elector
- Have resided in his/her District for one year immediately preceding the election
- Have submitted a nomination petition for Mayor signed by at least 50 registered electors
- File a completed Candidate Affidavit

Nomination Petitions may be circulated beginning (Insert Date) and **must be submitted to the City Clerk no later than 5:00 p.m. on (Insert Date)**. If a petition is found to be insufficient or incomplete, the filer will be notified and it may be corrected or cured until 5:00 p.m. on (Insert Date).

The petition will not be considered complete unless all of the following components are submitted and completed:

- Petition for Nomination
- Affidavit of Circulator
- Acceptance of Nomination

## INSTRUCTIONS FOR CIRCULATOR

- 1. There may be only ONE CIRCULATOR FOR EACH PETITION PACKET.
- 2. Do not take apart this packet. If the original staples are removed, the petition may not count.
- 3. READ THE WARNING on the top of each signature page
- 4. TO SIGN A PETITION, a person must be an eligible elector as shown by the records of the Arapahoe County Clerk, must be 18 years of age, a citizen of the United States, and have resided in the Village for 30 days prior to the election.
- 5. THE CIRCULATOR MUST PERSONALLY OBSERVE every eligible voter who signs his/her petition.
- 6. Make certain that all required information is complete. A signer must use the ADDRESS WHERE HE/SHE IS REGISTERED TO VOTE.
- 7. SIGNERS MAY SIGN THREE PETITIONS: One for the office of Mayor, and two for the office of Councilmember within their district.
- 8. A POST OFFICE BOX IS NOT A PLACE OF RESIDENCE. Street number and name must be provided.
- 9. If a small correction must be made, the signer should INITIAL THE CHANGE. If a large correction must be made, the signer should cross out the incorrect information and proceed to the next available signature space.
- 10. If a signer is disabled and needs assistance, a THIRD PARTY should provide the assistance. THE CIRCULATOR CANNOT ASSIST THE SIGNER. The person providing assistance should SIGN and STATE THAT ASSISTANCE WAS GIVEN.
- 11. NO PERSON MAY SIGN FOR ANOTHER including spouses and children.
- 12. When the circulator has finished collecting signatures, he/she should take the completed petition packet to a Notary Public. The Affidavit of Circulator must be signed and dated IN THE PRESENCE OF A NOTARY, who will then notarize the affidavit.
