Explain: The five wetlands consist of four small herbaceous wetlands that also have open water and one forested wetland (Wetland 5). The 1984 Sour Lake, Tex. Quadrangle Map shows a tributary crossing the southwest corner of the tract, however, the quadrangle map shows it does not flow into a traditional navigable water and the tributary is not visible in the aerial photos and it appears it does not exist. Therefore, an unnamed tributary to Little Pine Island Bayou, a non-relatively

permanent water, is the closest potential water of the United States to Wetlands 1, 2, 3, 4, and 5. Wetland 1 is located approximately 3,210 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 2 is located approximately 3,095 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 3 is located approximately 3,025 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 4 is located approximately 3,000 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 5 is located approximately 2,485 feet northeast of the unnamed tributary to Little Pine Island Bayou. There are no known hydrological connections between Wetlands 1, 2, 3, 4, or 5 and the unnamed tributary to Little Pine Island Bayou. There are no confined hydrologic connections between Wetlands 1, 2, 3, 4, or 5 and any water of the United States. Wetlands 1, 2, 3, 4, and 5 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Wetlands 1, 2, 3, 4, and 5 are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. Wetlands 1, 2, 3, 4, and 5 are not subject to the ebb and flow of the daily tide. Wetlands 1, 2, 3, 4, and 5 do not cross interstate or tribal boundaries. The destruction of Wetlands 1, 2, 3, 4, and 5 (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands 1, 2, 3, 4, and 5 are not an impoundment of a water of the United States. Wetlands 1, 2, 3, 4, and 5 are not part of a surface tributary system of any of the above. Wetlands 1, 2, 3, 4, and 5 are not part of the territorial seas. Wetlands 1, 2, 3, 4, and 5 are not adjacent to waters identified in any of the above. Wetlands 1, 2, 3, 4, and 5 have been determined by the Galveston District to NOT be adjacent, (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c). Wetlands 1, 2, 3, 4, and 5 are located out of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Wetlands 1, 2, 3, 4, and 5 are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands 1, 2, 3, 4, and 5 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators and hydric soils.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The five wetlands consist of four small herbaceous wetlands that also have open water and one forested wetland (Wetland 5). The 1984 Sour Lake, Tex. Quadrangle Map shows a tributary crossing the southwest corner of the tract, however, the quadrangle map shows it does not flow into a traditional navigable water and the tributary is not visible in the aerial photos and it appears it does not exist. Therefore, an unnamed tributary to Little Pine Island Bayou, a non-relatively permanent water, is the closest potential water of the United States to Wetlands 1, 2, 3, 4, and 5. Wetland 1 is located approximately 3,210 feet northeast of the

unnamed tributary to Little Pine Island Bayou. Wetland 2 is located approximately 3,095 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 3 is located approximately 3,025 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 4 is located approximately 3,000 feet northeast of the unnamed tributary to Little Pine Island Bayou. Wetland 5 is located approximately 2,485 feet northeast of the unnamed tributary to Little Pine Island Bayou. There are no known hydrological connections between Wetlands 1, 2, 3, 4, or 5 and the unnamed tributary to Little Pine Island Bayou. There are no confined hydrologic connections between Wetlands 1, 2, 3, 4, or 5 and any water of the United States. Wetlands 1, 2, 3, 4, and 5 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Wetlands 1, 2, 3, 4, and 5 are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. Wetlands 1, 2, 3, 4, and 5 are not subject to the ebb and flow of the daily tide. Wetlands 1, 2, 3, 4, and 5 do not cross interstate or tribal boundaries. The destruction of Wetlands 1, 2, 3, 4, and 5 (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands 1, 2, 3, 4, and 5 are not an impoundment of a water of the United States. Wetlands 1, 2, 3, 4, and 5 are not part of a surface tributary system of any of the above. Wetlands 1, 2, 3, 4, and 5 are not part of the territorial seas. Wetlands 1, 2, 3, 4, and 5 are not adjacent to waters identified in any of the above. Wetlands 1, 2, 3, 4, and 5 have been determined by the Galveston District to NOT be adjacent, (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c). Wetlands 1, 2, 3, 4, and 5 are located out of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Wetlands 1, 2, 3, 4, and 5 are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands 1, 2, 3, 4, and 5 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial.
