**11:35 A.M.–12:15 P.M.** Playground time

**12:15 A.M.–1 P.M.** Lunch then change for pool –

**1:15 P.M.–3 P.M.** Swim time at the Fuqua Pool

**3:15 P.M.–4 P.M.** Change clothes, snack time, and quiet time

### **HOURS OF OPERATION**

7:15 A.M. – 5:30 P.M. daily\*

(with the exception of July 4, which is a Federal holiday)

\*No drop-off on Traveling Tuesdays between 9:30 A.M. -12:30 P.M. due to scheduled field trips.

### **ARRIVAL/DEPARTURE**

Parents or guardians must accompany children to and from the Extended Daycare complex each day and sign their child in and out daily. Should children be participating in any of the Beyond the Bell camps offered at Fuqua School, staff will accompany children to and from the facilities.

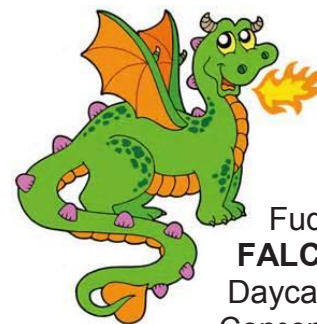
### **FEES**

- Application fee - due with application: \$75 which includes fees for local field trips and snacks
- Hourly fee – first child: \$4.00
- Hourly fee – additional child: \$3.50
- Late charge (each 15 minute interval after 5:30 P.M.): \$15.00

**Billing is weekly with payment due upon receipt.**

### **LUNCH/SNACKS**

Children must bring their lunch from home. Snacks are included with the hourly fee.
