### Letter from your President

Fall 2009 Greetings:

At the August Annual Dinner, our membership said good bye and thank you to Carter Diers, Kevin Kolstad, and Colleen O'Keefe, 3 outgoing Board members who had served the Cedar Lake Conservation Club for 4 years. In addition to being Board members, Carter served as President and Secretary, Kevin served as the Water Quality Committee Chairman and Colleen served as Secretary and was on the Social Committee. Their service is greatly appreciated. We elected and welcomed 3 new Board members at the same time, Leslie Kruetter, Kathy Jonsrud and Cheryl Wold.

Right after the meeting, the Board met to elect officers for 2009-2010. I was elected President, Kathy Jonsrud was elected Vice President, Bill Arendt was elected Treasurer and Carter Diers was elected Secretary.

Speaking of the Annual Dinner, I want to apologize to those members who were disappointed that we did not have more of a business meeting at the dinner. We had received feedback that the 2008 Annual Dinner was too long so we were trying to shorten this year's

dinner by limiting the business aspect. We received some feedback that the awarding of prizes was still too long this year so the Board discussed the issue and we are going to try some different things next year. You can read the details in another part of this newsletter.

### **Prevention of swine flu**

Recommendation by Dr. Vinay Goyal, MBBS, MD, DM

The only portals of entry are the nostrils and mouth/ throat. In a global epidemic of this nature, it's almost impossible to not come into contact with H1N1 in spite of all precautions. Contact with H1N1 is not so much of a problem as proliferation is.

While you are still healthy and not showing any symptoms of H1N1 infection, in order to prevent proliferation, aggravation of symptoms and development of secondary infections, some very simple steps, not fully highlighted in most official communications, can be practiced.

1. Frequent hand-washing (well highlighted in all official communications).

2. "Hands -off-the-face" approach. Resist all temptations to touch any part of face (unless you want to eat, bathe or slap).

3. Gargle twice a day with warm salt water (use Listerine if you don't trust salt). H1N1 takes 2-3 days after initial infection in the throat/nasal cavity to proliferate and show characteristic symptoms. Simple gargling prevents proliferation. In a way, gargling with salt water has the same effect on a healthy individual that Tamiflu has on an infected one. Don't underestimate this simple, inexpensive and powerful preventative method.

4. Similar to 3 above, clean your nostrils at least once every day with warm salt water. Blowing the nose hard once a day and swabbing both nostrils with cotton buds dipped in warm salt water is very effective in bringing down viral population.

5. Boost your natural immunity with foods that are rich in Vitamin C (various citrus fruits). If you have to supplement with Vitamin C tablets, make sure that it also has Zinc to boost absorption.

6. Drink as much of warm liquids as you can. Drinking warm liquids has the same effect as gargling, but in the reverse direction. They wash off proliferating viruses from the throat into the stomach where they cannot survive, proliferate or do any harm.

# Cedar Lake Water Quality Update

As fall reminds us that the pending long winter months that will soon be upon us, and the last few docks and boats get removed and stored on Cedar Lake, it's easy to also store away our thoughts on Cedar Lake's water quality. We spend less time down by the lakeshore. The water clarity has returned again. Gone are the weeds around your docks. Gone are the algae blooms you may have seen floating on the surface. But like the docks and boat, they too will be back for another season.

I think as an Association, we have made some good progress in 2009. As noted in a previous newsletter article, Cedar Lake has survived another year without detection of eurasian milfoil. And we have initiated a formal project to address the Curly-leaf pondweed issue in Cedar Lake. This great project team, lead by Orv Jonsrud, completed the first ever treatment of Curly-leaf pondweed this spring. We also observed a record breaking secci dish first reading for 2009. And there are other measures of success that were shared in previous newsletters as well.

But our focus and drive doesn't get to take a winter vacation, like some of you snowbirds who head south for the winter months. We already have a lot of work to do to prepare for next year.

I had an opportunity to spend some time talking to the people at the DNR a couple of weeks ago. I told them that we had some concerns, as do other lakes in our area, on the DNR's permitting process to allow us to treat our Curly-leaf presence. As you may remember, we were only permitted to treat about half of the area we had applied for this last spring. We had a really good conversation and together we created a to-do list for each of us to help us prepare for 2010 and the future.

The DNR will only permit treatment in areas of the lake where Curly-leaf is present, and properly identified. The DNR leverages two key documents to make this decision. The first is the Vegetation Lake Map. The last updated Lake Map for Cedar Lake was completed in 2006. We are in the process of updating this map starting next spring. If successful, the DNR should permit a larger treatment area. If not, we'll be restricted to areas identified in the 2006 map. The Board authorized spending \$3000 to complete the map update. The funds came from a grant provided to us by the Initiative Foundation for the Curly-leaf pondweed project we presented to them. We will press forward with updating our Lake Map shortly after the ice goes out in the spring. They suggested two or three inspections should be performed in early spring.

The second key document is called a Lake Vegetation Management Plan. The CLCC Board has already begun creating this document. Our thanks to Dave Wagner and others for all the work he has done initially with this document. Further document updates, and ongoing management of this plan, will be performed by the Water Quality Committee.

In order to apply the necessary herbicides in the water to kill off Curly-leaf, the DNR requires lakeshore property owner's signatures on approval forms. The project team gathered the necessary signatures for the treatment area this spring, and those approvals will be valid for 3 years. However signatures will need to be obtained for additional areas on the lake outside of our treatment area this spring. This is where we can really use your help! The Water Quality committee will be sending out approval forms to property owners for you to sign and return to us. We would greatly appreciate it if you could do so right away when you receive them. We will try to collect all the necessary signatures over the winter months and present them to the DNR when we request our spring 2010 permit. This step is the most time consuming in the permitting process.

The DNR conducted a pilot project back in the early 1990's with the Army Corp of Engineers to determine the best methods to manage and eliminate Curly-leaf pondweed. Their study determined the most effective time to kill the plant was when the lake water was between 50 - 60 degrees. Thus the DNR will issue permits as long as the water temperature remains within this range. This is a very narrow window in the spring, so everything must be in order to be successful.

The DNR indicated that they are in the process of hiring a full time lake weed Invasive Species Specialist for our area of the state. In the meantime, we will continue to work with the folks with the DNR. They will be available for any questions we have on obtaining our 2010 treatment permit. I am excited that I have been able to get these folks engaged in our efforts and have started to develop a good game plan.

In our newsletter publications, a significant amount of attention to water quality over the last 3 years is been mostly dedicated to phosphorous intake reduction, rough fish removal, and recently Curly-Leaf pondweed removal. There are many other concerns such as zebra mussels, purple loosestrife, and gypsy moth to name a few. I'll try to address some of these in future newsletters. I've also been informed that Swartout Lake property owners are reconsidering their earlier position on cleaning up their lake. This Clearwater River Watershed District (CRWD) will work with them and other lakes in the district that are now on the MN Pollution Control Agency's (PCA) Impaired Waters list. # Fish and Wildlife Conservation

## Winter Bird Feeding

Do you want to shorten up the winter season and help make it easier on our feathered friends. Why not put some favorite food out for them.

If you are at the cabin or at your home here are a few tips on enjoying birds and other wildlife around us.

There are all kinds of bird food mixes available out there, but some can get to be very expensive. So if you want to stay within a budget and attract the most number of species without going all out, go with black sunflower seed and a suet cake. Most bird species that winter here enjoy these foods. You can save money by buying 50 lbs of black sunflower seed at a time, but make sure you store that extra seed in a mouse proof container so the mice don't invade your garage.

All woodpeckers and other birds enjoy suet placed out for them. You can go to a local butcher and buy it there or pick it up at any store selling bird seed. I would like to note that feeding a cheap seed mix, containing allot of millet, has a tendency to attract more non native species such as the English Sparrow to your feeder.

A heated bird bath is also enjoyed by the birds in the winter. One of my favorite birds at the heated bird bath is the Eastern Bluebird. Although most of them do migrate, some will stay in the area if they have food and water. They will not come to your seed feeder. They feed mainly on berries in the winter. The area around Cedar Lake contains hackberry trees that hold their berries through the winter. I have observed this to be a great food source for them. There is not anything prettier than a flock of Bluebirds, sitting on the heated bird bath, against a snow background. Looking out your window on those cold blustery days with a busy bird feeder may help bring spring around the corner quicker than you think. There also might be some surprises of wild turkeys or whitetail deer coming to your buffet.

Enjoy nature at its best.

### **Wood Ducks**

Spring is a few months out but it is never too early to think about building yourself a wood duck house this winter and have it in place by April 1<sup>st</sup>. The last few years I have noticed a lot of Wood Ducks searching for nesting sites around Cedar Lake. We can help them out by building, properly placing and maintaining a house for them. They will nest anywhere on the lake but once the ducklings hatch they quickly take them to a more secure area such as the bay of Camp Courage and the south end of the lake, where more vegetation grows.

Two things are very important to keep in mind when building these houses. The entry hole size should be oval,

3 inch's high by 4 inch's wide, and you should place four inches of cedar shavings in the house. Listed below are two websites with building plans of wood duck houses. www.woodducksociety.com/duckhouse.htm

## Walleye Stocking

Cedar Lake receives a stocking of walleyes every other year from the DNR. This fall we received a stocking of walleye fingerlings. According to Paul Diedrich of the DNR, the fingerlings ran a little smaller in size this year, so we would be getting more fish per pound. The quota for Cedar Lake is 315 pounds.

When they had finished stocking our lake 322 lbs were stocked, which consisted of 10,865 Walleye.

At the Spring Fling Walleye raffle we received \$306, and at the Annual Dinner \$625. To date we have received \$931 from your generous donations. Our Fish and Wildlife Committee is considering stocking in the off year of the DNR. With continued donations we could be stocking from our Walleye Stocking Fund in 2010!!

# **Quality Lake Life in our Community**

#### Being at "the lake" is not just a place...it is a life style.

A committee has been established to improve the quality of our lake life community through outreach and education. The incredible gifts of lake life come with important responsibilities to improve and preserve quality, not only on Cedar Lake, but in our lake community. This committee, through close work with the Clearwater River Watershed District (CRWD), will identify and execute opportunities to support quality lake life in surrounding areas. We believe that educational, social and shared learning activities, at the community level, will improve lake life for all. Our lake neighbors on Albion, Henshaw, and Swartout had a meeting with CRWD in August, 2009 to discuss their desires to improve the quality of their lakes.

The following information addresses comments/ questions those residents This is information was provided by Norma Wenck, District Engineer, to the Clearwater River Watershed district.

Residents noted that pelicans are nesting on the island on Swartout and complained of odor. Some residents also feel that the water quality is worse than normal in the lake as a result of the pelicans. Residents wondered the effectiveness and cost of frightening the birds away from the island and the possibility of using a chemical to neutralize the effects of the bird's waste on the lake.

The island on Swartout has been identified by the MN DNR as a rookery (nesting area) for several species of birds including white pelicans, double crested cormorants, egrets, black crowned night herons, and other shorebirds. The presence of the nesting colony of pelicans is a natural occurrence on a shallow lake, as the treeless island provides ideal habitat for the ground nesting bird. Populations of the birds using the island likely fluctuate with climactic conditions or as the birds are displaced from other nesting areas.

The white pelican is a protected species in Minnesota and under the Migratory Bird Treaty Act. As a result hazing activities would not be permitted. While the pelicans may cause a nuisance odor, they also provide a benefit to the lake, as studies have shown that the bulk of their diets consist of abundant rough fish such as carp and bullheads.

While the waste from the nesting colony of pelicans may be causing a nuisance odor, it is unlikely that the waste is contributing a significant amount of nutrients to the lake. Lake monitoring results indicate that water quality in Swartout in 2009 is similar to that of previous years, as total phosphorus and chlorophyll-a concentrations are within the established ranges observed during previous years. Furthermore, large colonies of pelicans exist on lakes throughout the state without any known connections to decreased water quality.

Residents also asked about the effectiveness of carp removal and the budget remaining for rough fish removal.

The carp harvesting efforts removed approximately 62,000 lbs of carp from Swartout Lake in 2009. While the netting can not completely eliminate carp in the lake, combined with the rough fish barriers that restrict the adult carp from reaching their spawning habitat in adjacent wetlands, the rough fish control efforts will result in a reduction of the carp population.

The budget remaining for fish removal in 2010 is \$10,000.

A resident on Lake Albion commented on the abundance of aquatic vegetation, including lily pads, this year.

Climate conditions can influence vegetation growth patterns. Floating leaf vegetation (such as lily pads) or emergent vegetation require shallow water to germinate. During years with below average precipitation (dry conditions) lake levels often decrease. In shallow lakes the decreased water levels can create new shallow areas allowing germination of floating leaf or emergent vegetation species. This could lead to floating leaf or emergent vegetation covering a larger portion of the lake basin as compared to normal or high water years.

Aquatic vegetation comprises an important ecological component at several levels in shallow lakes. For shallow lakes such Albion Lakes that are experiencing eutrophic conditions that have resulted from elevated phosphorus loads, aquatic vegetation is an important component of maintaining water clarity. Aquatic vegetation filters phosphorus from the water column and traps the phosphorus as plant biomass. This process decreases the amount of phosphorus available from the water column for algae. Aquatic vegetation also can help to stabilized mucky, organic sediments that can become stirred up through wind and wave action in shallow lakes. Finally, aquatic vegetation provides important food and habitat for fish and wildlife utilizing a lake. *Kathy J.*


