In September 1984, the Chester County Solid Waste Authority (CCSWA) became owner and operator of the Lanchester Landfill, a 600-acre property located in Honey Brook, Salisbury, and Caernarvon townships that includes 160 acres of landfills and nature trails.

Known for waste recycling and disposal the landfill is also home to a 360-degree panoramic view rising 80 feet above the highest point of the Welsh Mountains, the overlook provides a 360-degree panoramic view of the Conestoga and Brandywine valleys. A scenic overlook was opened in July 2001 to be used by the public as a recreational area. Join us as we learn more about the Chester County Solid Waste Authority and its contribution to Chester County.
