The Massachusetts Town Clerks' Association (MTCA) and the Massachusetts City Clerks' Association (MCCA) held a joint conference February 3rd through February 5th. The conference was held at the Devens Common Center in Devens, Massachusetts. The conference drew 265 attendees along with approximately 25 vendors. It was one of the most well attended winter conferences in recent memory. The conference was started with a session on Safety in the Municipal workplace which was presented by Jeremy Gillis, CMMC/MMC, Easton Town Clerk and First Vice President of the MTCA. Thursday's session included presentations on the By-law Submissions with the AG's Office, Presidential Primary Elections, Vital Records and an Athenian Dialogue.

The highlight of the conference was the appearance of Lt. Governor, Karyn Polito, who spoke at the business luncheon. Lt. Governor Polito spoke to the attendees about the work the Governor's office is doing to partner with municipalities, including Community Compacts. The Governor is hoping that Community Compacts will help to nurture working relationships between the Commonwealth and communities that will promote standards and accountability for the state and municipal government and will provide better government for the citizens of the Commonwealth. Andrew Dowd (Northborough), president of the MTCA and Lisa Thomas (Marlborough), president of the MCCA (pictured below with Lt. Governor Polito) had previously met with the Lt. Governor to discuss a variety of issues that were important to municipalities in general and clerks' offices more particularly.



Lt. Governor Polito indicated that a lot of the issues being addressed by the Commonwealth resulted from her conversation with the two presidents. The speech was well received by

the attendees and her attendance at the conference was important to highlight the efforts by the Governor's office to work closely with municipalities.

CROCUSES AND ICICLES

What an odd sight, to see such a thing! Is it the middle of winter or the beginning of spring? Little green stalks have popped through the ground; shadowed by icicles three inches around! The lore of the groundhog remains steadfast; an early spring the forecast as no shadow was cast.

The Rhode Island Town and City Clerk's Association (RITCCA) held their quarterly meeting on January 22nd at Newport Vineyards – Brix Restaurant in Middletown. We were welcomed by Town Clerk Wendy Marshall and Robert "Rocky" Kempenaar, II, Town Council Vice President. The educational session was a presentation by Dr. Arlene Nicholas, Associate Professor at Salve Regina University, on Job Evaluations. The session focused on understanding the benefits of a job review so managers can better prepare for and execute employee evaluations. Do's and don'ts were discussed as well as how to motivate employees and how to correct any inadequacies for their own benefit and that of the organization. Of particular interest was the "Cheeseburger Approach to Deliver Bad News". Picture a delicious cheeseburger (mmm!) – starting with the top bun you would give the employee some background information, not an excuse, keeping it positive and neutral; the cheese is next and this where you would give reasons to help the employee see the situation from your point of view; next is the meat or the bad news which should be delivered clear and firm keeping it brief and low-key; and the bottom bun represents a goodwill gesture and perhaps a potential solution to the problem.

During our business meeting, we discussed some new legislation that was introduced at the General Assembly. The Association was opposed to three bills in particular which were Audio and Video Recordings of municipal meetings (H7238), Conduct of Elections (H7249) and In-person Early Voting (H₇₂₄₈). An affirmative vote was taken and Secretary Nelson drafted and sent letters of opposition to the Committee Chairs on behalf of the Association. Rob Rock, Director of the Board of Elections, gave an update on the in-person early voting bill, new voting equipment and e-poll books. He also introduced a new texting tool to help registered voters find their polling place by texting "VOTE" to 468683. The reply is the address to your polling location. Probate Judge Cristine McBurney provided an update on the revision of probate forms at the State level. The Association was presented with a list of suggested amendments to their by-laws which included but was not limited to the addition of the names and charges of Special Committees. These will be reviewed again in April and voted on in June at the annual meeting. At the close of the meeting, Kimball Brace, President of Election Data Services, advised that he will be meeting with all cities and towns to review new developments as it relates to geographic boundaries in preparation for the 2020 census. The Conference Committee met briefly to discuss the next fundraiser, a theme and entertainment! Our next quarterly meeting in April brings us back to Newport where the 2018 NEACTC Annual Conference will be held!!!

Hats off to Lisa Goodwin, City Clerk in Bangor and Elizabeth Bullen, Deputy Clerk in Gray for volunteering to help. A lot of us are finding it hard to find the space needed to retain the ever increasing boxes of local government records so better definitions will allow us to better define which records must be retained permanently or disposed of. Some towns in Maine are, also, looking at digitizing records for better access.

We all enjoyed November's annual NEACTC Conference last fall at Woodstock! Thanks again for the superhero effort put into that event and wonderful educational opportunities!

We have had a mild winter in Maine this year. Here's to effortless Caucuses and Primary Elections!

What a strange winter this is! Mother Nature cannot seem to make up her mind. Those that love the warmer temps are certainly not minding the lack of cold and snow. But the swaying back and forth between record warm and record cold I find is harder to adjust to. Hopefully winter will not decide to come in March and stay until June!

2016 is shaping up to be a very busy and active election year for Vermont, starting with Town Meeting and the Presidential Primary on March 1st also known as Super Tuesday. With both parties looking to nominate a Presidential candidate for the November election, voters are focused on the Primaries and Caucuses around the country and voter participation is expect to reach record numbers. The Vermont Secretary of State's Office rolled out a new Elections Management System in October, 2015. The new system allows Clerks to register and maintain voter data, maintain polling location information, issue and track absentee ballots, submit election night results to the Secretary of State, as well as electronically submit our Official Return of Votes the next day. In the past, Clerks have had to use 3 different systems to accomplish these tasks and the Official Return of Votes had to be express mailed the next day by noon. The new system also allows voters to set up a My Voter Page making it easier to update personal information and request and track Absentee Ballots. The Secretary of State provided several extensive user trainings around the State last summer and fall and has accommodated requests for smaller refresher trainings in these weeks leading up to the March 1st election. As hectic as this election will be, the new system should help ease some of the stress.

The 2016 Legislative Session is also shaping up to be an active one and the VMCTA Legislative Committee is working hard tracking and testifying on several new bills affecting Clerks and Treasurers.

The Education & Certification Committee is hard at work putting together Spring Trainings for new (and not so new) Clerks and Treasurers. These trainings will be again be held in Hartland (April 21st) and Barre City (May 4th) more information can be found at www.vmcta.org.

Congratulations to Kimberly Moulton, Clerk/Treasurer of Hyde Park on earning the prestigious Certified Municipal Clerk (CMC) designation from IIMC. We are so proud of Kim's accomplishment.

MEMBERSHIP DEFINITIONS

BD15-16

FULL MEMBER

State/Province

Full members are Municipal Clerks, City Secretaries, Recorders, Legislative Administrators and Directors of Corporate Services and/or an individual who serves a Legislative Government Body (LGB) in an administrative capacity with management responsibilities and whose duties include four of the following: • General Management • Records Management • Elections • Meeting Administration • Management of by-laws, Articles of Incorporation, ordinances or other legal instruments • Human Resources Management • Financial Management • Custody of the official seal and execution of official documents.

ADDITIONAL FULL MEMBER

Connecticut

Additional Full Members are fully qualified members from the same organization. This would essentially be Deputy Clerks within the same City, but could be other individuals provided they would qualify under the definition of Full Member. A city must have one Full Member before they would be eligible to have Additional Full Members.

ASSOCIATE MEMBER

Associate Members are individuals serving a legislative body in a capacity not previously defined. In other words if someone serving a legislative body does not qualify for Full Membership they would be able to join as an Associate Member. Associate members have the right to vote BUT CANNOT hold office or obtain certification, but they can take advantage of education programs and should they eventually assume the job of Clerk or Deputy, they could then apply for certification. A Full Member who is in transition (between jobs) would automatically become an Associate Member until they reassume the position of Clerk. Associate members would also pay a lower fee.




