**THE FIRST AMENDMENT TODAY**  
**Tuesday November 25, 2014**

The various clauses of the First Amendment - concerning free exercise, establishment of religion, the freedom of speech and the press, and the right of assembly - have spawned an evolving jurisprudence that covers diverse areas. This seminar will summarize current law governing free exercise, Establishment Clause and free speech. There will be a discussion on the specific free speech concerns governing students and teachers as well as the internet. There will also be a one hour discussion of the intersection of the First Amendment and the free speech rights of lawyers and judges. Six CLE credits will be awarded and one hour of Ethics credit.
