QUEN SHARES HER TALENTS

Quendred Carpenter began sketching at art fairs in 1967 and still continues today. Most recently, Quen has been sketching veterans at the Fox Valley Veterans' Breakfast Club. In lieu of payment, Quen has kindly offered them the opportunity to give donations to Open Door, which is very much appreciated. Quen has long been a supporter of Open Door and has served on the Board of Directors for over 43 years!

One need only visit the conference room at Open Door to view Quen's sketches and oil paintings of the founders and their children, Dr. Robert Coleman, President Emeritis, and his wife, Edie. Of course, one of the most treasured sketches is that of the consumers. Quen also used her artistic talents in designing Open Door's logo, timeline, and numerous other creations.

Quen was fortunate to be an art student of Open Door Co-founder Dave Graf at the D.O. (Diversified Occupations)

program in the Sandwich School District. Graf recommended her for a draftsman's position at the James Knights Company where Open Door's other co-founder, Bill Squier, was her supervisor.

In the early years, Quen was named "Outstanding Designer" at a statewide art camp. The Ford Foundation awarded her for an original furniture design. After winning her county's scholastic scholarship for tuition to the University of Illinois, she entered the School of Art.

In 1980, Quen sketched the entire fifty- nine member Illinois Senate. Four years later, she was commissioned by McDonalds Corporation to develop instructional material to aid the Ronald McDonalds when visiting children in hospitals, and presented this at McDonalds Hamburger University. Quen as co-author of the published "A Moderately Amusing Book" also illustrated 165 pages. As

an acrylic painter, Quen has created many murals: Community Bank of Plano, Somonauk Baptist Church, Old Barn Museum, and, most recently, Timber Creek Inn & Suites.

job?

This was actually an extension of the original SLIP program. These kids liked it so much they wanted another year! SLIP

stands for Student Leadership Initiative Program and is directed and supervised through Kendall County Outdoor **Education Center** (KCOEC). The SLIP program is an experiential and multicultural leadership training program. It is for high school students in the

DeKalb and Kendall County areas with four public high schools in Oswego, Plano and Sandwich. The program's main focus and purpose is to teach our leaders of tomorrow how to get along and work effectively with each other regardless of race, gender, religion, ethnic or socio-economic backgrounds. Using experiential and

adventure education techniques, the students learn leadership, creative problem solving, and effective interpersonal skills. This would involve small group outdoor challenge experiences such as: low challenge courses, urban exploration, wilderness challenges, and community service days. Through all of these experiences, the students are placed in real life situations that require leadership, trust, responsibility, communication, cooperation, planning, and problem solving.

It is important to note, and not forget, that the educators involved

with this program deserve a big high five! The KCOEC staff instructors that supervise and work with the students in the SLIP program have made experiential and adventure education their profession. Understanding that this group of students was on their second year of SLIP, the supervisors really were able to hang out and enjoy themselves as well. There was a unique feeling of respect and honor amongst all participants and the supervisors as well. In the second year, the students actually choose their community

service project, make the contacts, set everything up, and then follow up afterwards.

When the group came that morning,

KCOEC staff supervisor Mark works on a craft with Tim H.

I divided them up with our different class leaders at East and the MAT (Material Assembly Training) supervisor at West so they could work one- on- one with staff and learn what we do every day. Then in the afternoon, they flip-flopped buildings and helped with lunchtime and MAT work at East, then classes and programming at West. They were well received at both buildings and did an outstanding job! I was very happy to have this group come to help us at the workshops. The happy smiles on the faces of our consumers (who LOVE company!!) and

then again the smiles on the students' faces showed me that they really like what they do. It makes such a huge difference...even just ONE day... can mean the world here at Open Door. I am still being asked when the group will return. All I can say for now is "not soon enough!"

First Aid/Safety Education

What should you do for cold or heat related illnesses? What are the symptoms of a heart attack? How can I be better prepared for emergency situations? These are just some of the questions asked and answered in the Open Door "First Aid & Safety Education" course.

A group of individuals, the majority of them living independently in the community, gathered to learn what they can do to help in a variety of emergency situations, how to be better prepared, and how to avoid these situations in the first place. With the help of Gene Stephens, Residential Coordinator and certified Safety Instructor, the group learned about cardiac emergencies, sudden illnesses such

as stroke, and environmental emergencies such as heat stroke and hypothermia.

Individuals got the opportunity to ask questions, discuss the answers, and share stories and personal experiences. The course was a huge success. In fact, the group has decided to make the course into a series of classes to be offered throughout the year so that they can continue to

Program Coordinator Laurie W. summed the area up nicely when she stated that "the whole room has a nice feel."
