Canadian Food Safety and Quality Program: On-Farm Implementation Component Producer Declaration Information

The On-Farm Implementation program is designed to assist you, as a Canadian producer, to implement food safety systems on your farm. Food safety systems are based on the Hazard Analysis Critical Control Point (HACCP) principles and definitions.

How the Program Works

Each participating national commodity organization will apply for funding on behalf of all producers of that commodity. These national commodity organizations, working with their provincial affiliates, will then be able to help producers implement food safety systems on their farms. AAFC will provide funding to national commodity organizations so that they may provide some or all of the following:

- Workshops worth up to \$100/producer
- On-farm support worth up to \$750/producer to:
 - ✓ Provide you with technical support to adapt and implement a food safety system on your farm; and/or
 - ✓ Purchase specialized equipment needed to implement a food safety system on your farm.

Who May Participate

You may be entitled to participate in this program if you: Earned at least \$2,500 in farm cash receipts during the last taxation year; and Filed form T2042, Statement of Farm Activities, for that taxation year.

Available Benefits

Each national commodity organization has determined which of the above benefits it will offer to producers, however, you have the option of choosing which organization's benefits you would like to receive. The commodity organization will inform you of the costs associated with each benefit they are offering.

Money that is available to you for equipment is a taxable benefit and you will be issued a tax information slip for those funds.

In order to be eligible to receive these goods and/or services, you must complete the attached declaration.

By submitting this form for benefits under the Canadian Food Safety and Quality Program – On-Farm Implementation component (the Program), I:

- 1) certify that the information provided is complete and correct;
- 2) certify that I am actively engaged in farming and that I have earned at least \$2,500 in net farm cash receipts during the last taxation year;
- 3) agree to notify the Program in writing of any changes to the income tax information provided to the Canada Revenue Agency (CRA) for the taxation year;
- 4) understand that the equipment benefit received under the Program is a taxable benefit and that I will be issued a tax information slip from the producer organization for such benefits. I understand that I may be required to provide my social insurance number to enable the producer organization to issue a tax information slip as required by the Canada Revenue Agency;
- understand that I am not eligible for benefits exceeding \$100 for a workshop or \$750 for on-farm support, which is comprised of technical assistance service and/or equipment, and that I cannot request benefits in excess of these amounts;
- 6) agree that if it is determined that I have received any benefit under the Program that exceeds the maximum amount to which I am eligible under the Program, that I will promptly repay such amount, failing which AAFC may proceed with legal action to recover the amount of the benefit that exceeds the maximum amount for which I am eligible;
- 7) consent to the use of the information contained on this form by officials from Agriculture and Agri-Food Canada and by the Dairy Farmers of Canada for the purposes of administering my participation in the Program, for determining my eligibility for benefits under the Program, for verifying the information submitted, including the information on the T2042 from for the taxation year under which these funds are made available, as well as for the purposes of analysis, evaluation, program development of this or related programs;
- agree that I may be required to provide receipts verifying the purchaser of services or equipment under the Program;
- 9) consent to the disclosure by third parties, CRA and other government programs, upon request, to the Program any information pertaining to me or my financial affairs which the Program Administration considers necessary for the purpose of verifying the benefit under the Program;
- 10) consent to the retention of this declaration by the Dairy Farmers of Canada; and
- 11) consent to the disclosure of this declaration by the Dairy Farmers of Ontario to the Dairy Farmers of Canada for the purpose of the Dairy Farmers of Canada requesting funding from AAFC under this Program and for the purpose of assisting AAFC to ensure that producers, on an aggregate basis, receive no more than the maximum amount of funding to which they are entitled under the Program and to evaluation the performance of the Program; and
- 12) The federal Privacy Act protects information given on this form which may be kept in a Personal Information Bank by AAFC. The information collected or received by the Dairy Farmers of Ontario or by the Dairy Farmers of Canada may be protected by applicable the PIPEDA or provincial privacy legislation.
